CONCURRENT RESOLUTION

Authorizing the use of the Capitol Grounds for the Greater
Washington Soap Box Derby.

1 *Resolved by the House of Representatives (the Senate*
2 *concurring),*

1 **SECTION 1. AUTHORIZATION OF SOAP BOX DERBY RACES**
2 **ON CAPITOL GROUNDS.**

3 *The Greater Washington Soap Box Derby Association*
4 *(hereinafter in this resolution referred to as the “Associa-*
5 *tion”)* shall be permitted to sponsor a public event, soap
6 box derby races, on the Capitol Grounds on July 10, 1999,
7 or on such other date as the Speaker of the House of Rep-
8 resentatives and the Committee on Rules and Administra-
9 tion of the Senate may jointly designate.

10 **SEC. 2. CONDITIONS.**

11 *The event to be carried out under this resolution shall*
12 *be free of admission charge to the public and arranged not*
13 *to interfere with the needs of Congress, under conditions to*
14 *be prescribed by the Architect of the Capitol and the Capitol*
15 *Police Board; except that the Association shall assume full*
16 *responsibility for all expenses and liabilities incident to all*
17 *activities associated with the event.*

18 **SEC. 3. STRUCTURES AND EQUIPMENT.**

19 *For the purposes of this resolution, the Association is*
20 *authorized to erect upon the Capitol Grounds, subject to the*
21 *approval of the Architect of the Capitol, such stage, sound*
22 *amplification devices, and other related structures and*
23 *equipment as may be required for the event to be carried*
24 *out under this resolution.*

1 **SEC. 4. ADDITIONAL ARRANGEMENTS.**

2 *The Architect of the Capitol and the Capitol Police*
3 *Board are authorized to make any such additional arrange-*
4 *ments that may be required to carry out the event under*
5 *this resolution.*

6 **SEC. 5. ENFORCEMENT OF RESTRICTIONS.**

7 *The Capitol Police Board shall provide for enforcement*
8 *of the restrictions contained in section 4 of the Act of July*
9 *31, 1946 (40 U.S.C. 193d; 60 Stat. 718), concerning sales,*
10 *displays, and solicitations on the Capitol Grounds, as well*
11 *as other restrictions applicable to the Capitol Grounds, with*
12 *respect to the event to be carried out under this resolution.*
