## A BILL

To prohibit the imposition of access charges on Internet service providers, and for other purposes.

1        *Be it enacted by the Senate and House of Representa-*  
 2        *tives of the United States of America in Congress assembled,*

3        **SECTION 1. SHORT TITLE.**

4            This Act may be cited as the “~~Internet Access Charge~~  
 5        ~~Prohibition Act of 1999~~”.

6        **SEC. 2. PURPOSE.**

7            It is the purpose of this Act to ensure that Internet  
 8        ~~information services will continue to be deployed as rapidly~~  
 9        ~~and efficiently to as many Americans as possible by pre-~~  
 10       ~~venting the Federal Communications Commission from~~  
 11       ~~applying interstate access charges to providers of Internet~~  
 12       ~~services.~~

1 **SEC. 3. PROHIBITION OF ACCESS CHARGES ON INTERNET**  
 2 **SERVICE PROVIDERS.**

3 Section 254 of the Communications Act of 1934 (47  
 4 U.S.C. 254) is amended by adding at the end the following  
 5 new subsection:

6 “(1) PROHIBITION OF ACCESS CHARGES ON INTER-  
 7 NET SERVICE PROVIDERS.—Notwithstanding subsection  
 8 (b)(4) or (d) or any other provision of this section, the  
 9 Commission shall not impose on any interactive computer  
 10 service (as such term is defined in section 230(e)) or other  
 11 information service provider any access charge for the sup-  
 12 port of universal service that is based on a measure of  
 13 the time that telecommunications services are used in the  
 14 provision of such interactive computer service or informa-  
 15 tion service.”.

16 **SECTION 1. SHORT TITLE.**

17 *This Act may be cited as the “Internet Access Charge*  
 18 *Prohibition Act of 2000”.*

19 **SEC. 2. PROHIBITION OF CHARGES ON PROVIDERS OF**  
 20 **INTERNET ACCESS SERVICE.**

21 *Section 254 of the Communications Act of 1934 (47*  
 22 *U.S.C. 254) is amended by adding at the end the following*  
 23 *new subsection:*

24 “(1) PROHIBITION OF CHARGES ON INTERNET SERV-  
 25 ICE PROVIDERS.—

1           “(1) *IN GENERAL.*—Notwithstanding subsection  
2           **(b)(4)** or **(d)** or any other provision of this title, the  
3           Commission shall not impose on any provider of  
4           Internet access service (as such term is defined in sec-  
5           tion 231(e)) any contribution for the support of uni-  
6           versal service that is based on a measure of the time  
7           that telecommunications services are used in the pro-  
8           vision of such Internet access service.

9           “(2) *RULE OF CONSTRUCTION.*—Nothing in this  
10          subsection shall preclude the Commission from impos-  
11          ing access charges on the providers of Internet tele-  
12          phone services, irrespective of the type of customer  
13          premises equipment used in connection with such  
14          services.”.
