A BILL

To reduce corporate welfare and promote corporate responsibility.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

2 **OTHER PROVISIONS**
3 **Subtitle A—Tax Provisions**

4 **SEC. 101. ELIMINATION OF EXCLUSION OF CERTAIN IN-**
5 **COME OF FOREIGN SALES CORPORATIONS.**

6 (a) IN GENERAL.—Section 921 of the Internal Rev-
7 enue Code of 1986 (relating to exempt foreign trade in-
8 come excluded from gross income) is amended by adding
9 at the end the following new subsection:

10 “(e) TERMINATION.—This section shall not apply to
11 any taxable year beginning after December 31, 1999.”

12 (b) EFFECTIVE DATE.—The amendment made by
13 this section shall apply to taxable years beginning after
14 December 31, 1999.

15 **SEC. 102. REPEAL OF INCENTIVES FOR ALCOHOL FUELS.**

16 (a) REPEAL.—Section 40 of the Internal Revenue
17 Code of 1986 is repealed.

18 (b) CONFORMING REDUCTIONS OF OTHER INCEN-
19 TIVES FOR ETHANOL FUEL.—

20 (1) REPEAL OF REDUCED RATE ON ETHANOL
21 FUEL PRODUCED OTHER THAN FROM PETROLEUM
22 OR NATURAL GAS.—Subsection (b) of section 4041
23 of such Code is amended to read as follows:

24 “(b) EXEMPTION FOR OFF-HIGHWAY BUSINESS
25 USE.—

1 “(1) IN GENERAL.—No tax shall be imposed by
2 subsection (a) or (d)(1) on liquids sold for use or
3 used in an off-highway business use.

4 “(2) TAX WHERE OTHER USE.—If a liquid on
5 which no tax was imposed by reason of paragraph
6 (1) is used otherwise than in an off-highway busi-
7 ness use, a tax shall be imposed by paragraph
8 (1)(B), (2)(B), or (3)(A)(ii) of subsection (a)
9 (whichever is appropriate) and by the corresponding
10 provision of subsection (d)(1) (if any).

11 “(3) OFF-HIGHWAY BUSINESS USE DEFINED.—
12 For purposes of this subsection, the term ‘off-high-
13 way business use’ has the meaning given to such
14 term by section 6421(e)(2); except that such term
15 shall not, for purposes of subsection (a)(1), include
16 use in a diesel-powered train.”

17 (2) REPEAL OF REDUCED RATE ON ETHANOL
18 FUEL PRODUCED FROM NATURAL GAS.—Subsection
19 (m) of section 4041 of such Code is amended—

20 (A) by striking “or ethanol” each place it
21 appears (including the heading of paragraph
22 (2)), and

23 (B) by striking “, ethanol, or other alco-
24 hol” in paragraph (2) and inserting “or other
25 alcohol (other than ethanol)”.

1 (c) CONFORMING AMENDMENTS TO EXCISE TAXES;
2 FUEL ALCOHOL TAXED IN SAME MANNER AS OTHER
3 MOTOR FUELS.—

4 (1) IN GENERAL.—Paragraph (1) of section
5 4083(a) of such Code (defining taxable fuel) is
6 amended by striking “and” at the end of subpara-
7 graph (B), by striking the period at the end of sub-
8 paragraph (C) and inserting “, and”, and by adding
9 at the end the following:

10 “(D) fuel alcohol.”

11 (2) FUEL ALCOHOL.—Subsection (a) of section
12 4083 of such Code is amended by adding at the end
13 the following new paragraph:

14 “(4) FUEL ALCOHOL.—The term ‘fuel alcohol’
15 means any alcohol (including ethanol and meth-
16 anol)—

17 “(A) which is produced other than from
18 petroleum, natural gas, or coal (including peat),
19 and

20 “(B) which is withdrawn from the distillery
21 where produced free of tax under chapter 51 by
22 reason of section 5181 or so much of section
23 5214(a)(1) as relates to fuel use.”

24 (3) RATE OF TAX.—Clause (i) of section
25 4081(a)(2)(A) of such Code is amended by striking

1 “other than aviation gasoline” and inserting “(other
2 than aviation gasoline) and fuel alcohol”.

3 (4) SPECIAL RULES FOR IMPOSITION OF TAX.—
4 Paragraph (1) of section 4081(a) of such Code is
5 amended by adding at the end the following new
6 subparagraph:

7 “(C) SPECIAL RULES FOR FUEL ALCO-
8 HOL.—In the case of fuel alcohol—

9 “(i) the distillery where produced shall
10 be treated as a refinery, and

11 “(ii) subparagraph (B) shall be ap-
12 plied by including transfers by truck or rail
13 in excess of such minimum quantities as
14 the Secretary shall prescribe.”

15 (5) REPEAL OF REDUCED RATES ON ALCOHOL
16 FUELS.—

17 (A) Section 4041 of such Code is amended
18 by striking subsection (k).

19 (B) Section 4081 of such Code is amended
20 by striking subsection (c).

21 (C) Section 4091 of such Code is amended
22 by striking subsection (c).

23 (6) CONFORMING AMENDMENTS.—

24 (A) Subparagraph (A) of section
25 4041(a)(2) of such Code is amended by adding

1 at the end the following: “No tax shall be im-
2 posed by this paragraph on the sale or use of
3 any liquid if tax was imposed on such liquid
4 under section 4081 and the tax thereon was not
5 credited or refunded.”

6 (B) Section 6427 of such Code is amended
7 by striking subsection (f).

8 (C)(i) Subsection (i) of section 6427 of
9 such Code is amended by striking paragraph
10 (3) and by redesignating paragraph (4) as
11 paragraph (3).

12 (ii) Paragraph (3) of section 6427(i) of
13 such Code (as redesignated by clause (i)) is
14 amended by striking the last sentence of sub-
15 paragraph (A) and by adding at the end of such
16 paragraph the following new subparagraph:

17 “(C) PAYMENT OF CLAIM.—Notwith-
18 standing subsection (f)(1), if the Secretary has
19 not paid pursuant to a claim filed under this
20 paragraph within 20 days of the date of the fil-
21 ing of such claim, the claim shall be paid with
22 interest from such date determined by using the
23 overpayment rate and method under section
24 6621.”

1 (D) Paragraph (2) of section 6427(k) of
2 such Code is amended by striking “(3)”.

3 (E)(i) Paragraph (1) of section 6427(l) of
4 such Code is amended by striking “or” at the
5 end of subparagraph (A), by redesignating sub-
6 paragraph (B) as subparagraph (C), and by in-
7 serting after subparagraph (A) the following
8 new subparagraph:

9 “(B) any fuel alcohol (as defined in section
10 4083) on which tax has been imposed by sec-
11 tion 4081, or”.

12 (ii) Paragraph (2) of section 6427(l) of
13 such Code is amended by striking “and” at the
14 end of subparagraph (A), by redesignating sub-
15 paragraph (B) as subparagraph (C), and by in-
16 serting after subparagraph (A) the following
17 new subparagraph:

18 “(B) in the case of fuel alcohol (as so de-
19 fined), any use which is exempt from the tax
20 imposed by section 4041(a)(2) other than by
21 reason of a prior imposition of tax, and”.

22 (iii) The heading of subsection (l) of sec-
23 tion 6427 of such Code is amended by inserting
24 “, FUEL ALCOHOL,” after “DIESEL FUEL”.

1 (F) Sections 9503(b)(1)(D) and
2 9508(b)(2) of such Code are each amended by
3 striking “and kerosene” and inserting “ker-
4 osene, and fuel alcohol”.

5 (G) Section 9502 of such Code is amended
6 by striking subsection (e).

7 (H) Subsection (b) of section 9503 of such
8 Code is amended by striking paragraph (5) and
9 by redesignating paragraph (6) as paragraph
10 (5).

11 (d) EFFECTIVE DATE.—

12 (1) REPEAL OF THE CREDIT.—The repeal made
13 by subsection (a) shall apply to taxable years begin-
14 ning after December 31, 1999.

15 (2) AMENDMENTS RELATING TO EXCISE
16 TAXES.—The amendments made by subsections (b)
17 and (c) shall take effect on January 1, 2000.

18 (e) FLOOR STOCK TAXES.—

19 (1) IMPOSITION OF TAX.—In the case of fuel al-
20 cohol which is held on January 1, 2000, by any per-
21 son, there is hereby imposed a floor stocks tax of
22 18.4 cents per gallon.

23 (2) LIABILITY FOR TAX AND METHOD OF PAY-
24 MENT.—

1 (A) LIABILITY FOR TAX.—A person hold-
2 ing fuel alcohol on January 1, 2000, to which
3 the tax imposed by paragraph (1) applies shall
4 be liable for such tax.

5 (B) METHOD OF PAYMENT.—The tax im-
6 posed by paragraph (1) shall be paid in such
7 manner as the Secretary shall prescribe.

8 (C) TIME FOR PAYMENT.—The tax im-
9 posed by paragraph (1) shall be paid on or be-
10 fore June 30, 2000.

11 (3) DEFINITIONS.—For purposes of this
12 subsection—

13 (A) FUEL ALCOHOL.—The term “fuel alco-
14 hol” has the meaning given such term by sec-
15 tion 4083 of the Internal Revenue Code of
16 1986, as amended by this section.

17 (B) HELD BY A PERSON.—Fuel alcohol
18 shall be considered as “held by a person” if
19 title thereto has passed to such person (whether
20 or not delivery to the person has been made).

21 (C) SECRETARY.—The term “Secretary”
22 means the Secretary of the Treasury or his del-
23 egate.

24 (4) EXCEPTION FOR EXEMPT USES.—The tax
25 imposed by paragraph (1) shall not apply to fuel al-

1 cohol held by any person exclusively for any use to
2 the extent a credit or refund of the tax imposed by
3 section 4081 of the Internal Revenue Code of 1986
4 is allowable for such use.

5 (5) EXCEPTION FOR FUEL HELD IN VEHICLE
6 TANK.—No tax shall be imposed by paragraph (1)
7 on fuel alcohol held in the tank of a motor vehicle
8 or motorboat.

9 (6) EXCEPTION FOR CERTAIN AMOUNTS OF
10 FUEL.—

11 (A) IN GENERAL.—No tax shall be im-
12 posed by paragraph (1) on fuel alcohol held on
13 January 1, 2000, by any person if the aggre-
14 gate amount of fuel alcohol held by such person
15 on such date does not exceed 2,000 gallons.
16 The preceding sentence shall apply only if such
17 person submits to the Secretary (at the time
18 and in the manner required by the Secretary)
19 such information as the Secretary shall require
20 for purposes of this paragraph.

21 (B) EXEMPT FUEL.—For purposes of sub-
22 paragraph (A), there shall not be taken into ac-
23 count fuel held by any person which is exempt
24 from the tax imposed by paragraph (1) by rea-
25 son of paragraph (4) or (5).

1 (C) CONTROLLED GROUPS.—For purposes
2 of this paragraph—

3 (i) CORPORATIONS.—

4 (I) IN GENERAL.—All persons
5 treated as a controlled group shall be
6 treated as 1 person.

7 (II) CONTROLLED GROUP.—The
8 term “controlled group” has the
9 meaning given to such term by sub-
10 section (a) of section 1563 of such
11 Code; except that for such purposes
12 the phrase “more than 50 percent”
13 shall be substituted for the phrase “at
14 least 80 percent” each place it ap-
15 pears in such subsection.

16 (ii) NONINCORPORATED PERSONS
17 UNDER COMMON CONTROL.—Under regula-
18 tions prescribed by the Secretary, prin-
19 ciples similar to the principles of clause (i)
20 shall apply to a group of persons under
21 common control where 1 or more of such
22 persons is not a corporation.

23 (7) OTHER LAWS APPLICABLE.—All provisions
24 of law, including penalties, applicable with respect to
25 the taxes imposed by section 4081 of such Code

1 shall, insofar as applicable and not inconsistent with
2 the provisions of this subsection, apply with respect
3 to the floor stock taxes imposed by paragraph (1) to
4 the same extent as if such taxes were imposed by
5 such section 4081.

6 **SEC. 103. SOURCE OF INCOME FROM CERTAIN SALES OF IN-**
7 **VENTORY PROPERTY.**

8 (a) GENERAL RULE.—Subsection (b) of section 865
9 of the Internal Revenue Code of 1986 (relating to excep-
10 tion for inventory property) is amended to read as follows:

11 “(b) INVENTORY PROPERTY.—

12 “(1) INCOME ATTRIBUTABLE TO PRODUCTION
13 ACTIVITY.—In the case of income from the sale of
14 inventory property produced (in whole or in part) by
15 the taxpayer—

16 “(A) a portion (determined under regula-
17 tions) of such income shall be allocated to pro-
18 duction activity (and sourced in the United
19 States or outside the United States depending
20 on where such activity occurs), and

21 “(B) the remaining portion of such income
22 shall be sourced under the other provisions of
23 this section.

1 The regulations prescribed under subparagraph (A)
2 shall provide that at least 50 percent of such income
3 shall be allocated to production activities.

4 “(2) SALES INCOME.—

5 “(A) UNITED STATES RESIDENTS.—In-
6 come from the sale of inventory property by a
7 United States resident shall be sourced outside
8 the United States if—

9 “(i) the property is sold for use, con-
10 sumption, or disposition outside the United
11 States and an office or another fixed place
12 of business of the taxpayer outside the
13 United States participated materially in
14 the sale, and

15 “(ii) such sale is not (directly or indi-
16 rectly) to an affiliate of the taxpayer.

17 “(B) NONRESIDENT.—Income from the
18 sale of inventory property by a nonresident
19 shall be sourced in the United States if—

20 “(i) the taxpayer has an office or
21 other fixed place of business in the United
22 States, and

23 “(ii) such sale is through such office
24 or other fixed place of business.

1 This subparagraph shall not apply if the require-
2 ments of clauses (i) and (ii) of subparagraph (A) are
3 met with respect to such sale.

4 “(3) COORDINATION WITH TREATIES.—For
5 purposes of paragraph (2)(A)(i), a United States
6 resident shall not be treated as having an office or
7 fixed place of business in a foreign country if a trea-
8 ty prevents such country from imposing an income
9 tax on the income.”

10 (b) EFFECTIVE DATE.—The amendments made by
11 this section shall apply to income from sales occurring
12 after December 31, 1999.

13 **Subtitle B—Agricultural-Related** 14 **Provisions**

15 **SEC. 111. COST OF WATER USED TO PRODUCE CROPS ON** 16 **PRODUCTION FLEXIBILITY CONTRACT ACRE-** 17 **AGE.**

18 Section 9 of the Act of August 4, 1939 (commonly
19 known as the Reclamation Project Act of 1939; 43 U.S.C.
20 485h) is amended by inserting at the end the following
21 new subsection:

22 “(g)(1) Any contract entered into under authority of
23 this section or any other provision of Federal reclamation
24 law shall require that the organization agree by contract
25 with the Secretary to pay full cost for the delivery of water

1 used in the production of any contract commodity on acre-
2 age subject to a production flexibility contract entered into
3 under section 111 of the Agricultural Market Transition
4 Act (7 U.S.C. 7211).

5 “(2) The Secretary shall announce the amount of the
6 full cost payment for the succeeding year on or before July
7 1 of each year.

8 “(3) As used in this subsection:

9 “(A) The term ‘full cost’ has the meaning given
10 such term in section 202(3) of the Reclamation Re-
11 form Act of 1982 (43 U.S.C. 390bb(3)).

12 “(B) The term ‘contract commodity’ has the
13 meaning given such term in section 102(5) of the
14 Agricultural Market Transition Act (7 U.S.C.
15 7202(5)).

16 “(4) Paragraph (1) shall apply to any contract en-
17 tered into or amended after the date of the enactment of
18 this subsection.”

19 **SEC. 112. REPEAL OF EXPORT ENHANCEMENT PROGRAM.**

20 Title III of the Agricultural Trade Act of 1978 (7
21 U.S.C. 5651 et seq.) is repealed.

22 **SEC. 113. REPEAL OF MARKET ACCESS PROGRAM.**

23 Section 203 of the Agricultural Trade Act of 1978
24 (7 U.S.C. 5623) is repealed.

1 **SEC. 114. ELIMINATION OF FEDERAL SUBSIDIES FOR**
2 **TOBACCO.**

3 (a) **ELIMINATION OF TOBACCO PRICE SUPPORT.—**

4 (1) **ELIMINATION.**—The Agricultural Act of
5 1949 is amended by striking sections 106, 106A,
6 and 106B (7 U.S.C. 1445, 1445–1, 1445–2).

7 (2) **CONFORMING AMENDMENTS.**—The Agricultural
8 Act of 1949 is further amended—

9 (A) in section 101 (7 U.S.C. 1441)—

10 (i) in subsection (a), by striking “to-
11 bacco (except as otherwise provided here-
12 in), corn,” and inserting “corn”;

13 (ii) by striking subsection (c); and

14 (iii) in subsection (d)(3), by striking
15 “, except tobacco,”; and

16 (B) in section 408 (7 U.S.C. 1428)—

17 (i) in subsection (c), by striking “to-
18 bacco,”; and

19 (ii) in subsection (d), by adding before
20 the period at the end the following: “or to-
21 bacco”.

22 (b) **ELIMINATION OF TOBACCO MARKETING**
23 **QUOTAS.—**

24 (1) **ELIMINATION.**—Part I (sections 311
25 through 320C) of subtitle B of title III of the Agri-

1 cultural Adjustment Act of 1938 (7 U.S.C. 1311–
2 1314i) is repealed.

3 (2) CONFORMING AMENDMENTS.—The Agricul-
4 tural Adjustment Act of 1938 is further amended—

5 (A) in section 301(b) (7 U.S.C. 1301(b))—

6 (i) by striking paragraphs (3)(C),
7 (10)(B), (14)(B), (14)(C), (14)(D), (15),
8 (16)(B), and (17);

9 (ii) in paragraph (6)(A), by striking
10 “tobacco,”;

11 (iii) in the undesignated subpara-
12 graphs in paragraph (7), by striking
13 “Tobacco (flue-cured), July 1–June 30;

14 “Tobacco (other than flue-cured), October
15 1–September 30;”;

16 (iv) in paragraph (11)(B), by striking
17 “and tobacco”; and

18 (v) in paragraph (12), by striking “to-
19 bacco,”;

20 (B) in section 303 (7 U.S.C. 1303), by
21 striking “rice, or tobacco” and inserting “or
22 rice”; and

23 (C) in section 372(b) (7 U.S.C. 1372(b)),
24 by striking “Except as provided in section

1 320B, the amount” in the third sentence and
2 inserting “The amount”.

3 (c) CONFORMING AMENDMENTS.—

4 (1) BURLEY TOBACCO IMPORTS.—Section 3 of
5 Public Law 98–59 (7 U.S.C. 625) is repealed.

6 (2) TRANSFER OF TOBACCO ALLOTMENTS.—
7 Section 703 of Public Law 89–321 (7 U.S.C. 1316;
8 79 Stat. 1210) is amended by striking the second
9 sentence.

10 (3) BURLEY TOBACCO ACREAGE ALLOT-
11 MENTS.—The Act of July 12, 1952 (7 U.S.C. 1315),
12 is repealed.

13 (d) APPLICATION OF AMENDMENTS.—The amend-
14 ments made by this section shall apply with respect to the
15 2000 and subsequent crops of tobacco. As soon as possible
16 after operations are completed with regard to the 1999
17 crop of tobacco, the Secretary of Agriculture shall termi-
18 nate all loan agreements entered into with tobacco pro-
19 ducer associations under section 106A of the Agricultural
20 Adjustment Act of 1938 (7 U.S.C. 1445–1) and provide
21 for the disposal of all funds in the No Net Cost Tobacco
22 Fund of those associations and in the No Net Cost To-
23 bacco Account of the Commodity Credit Corporation.

24 (e) CONTINUED LIABILITY OF PRODUCERS.—An
25 amendment made by this section shall not affect the liabil-

1 ity of any person under any provision of law as in effect
2 before the date of the enactment of this Act.

3 (f) PROHIBITION ON SUBSEQUENT PROVISION OF
4 PRICE SUPPORT.—With respect to the 2000 and subse-
5 quent crops of tobacco, the Secretary of Agriculture may
6 not make price support available, whether in the form of
7 loans, payments, purchases, or other operations, by using
8 the funds of the Commodity Credit Corporation or under
9 the authority of any law.

10 **Subtitle C—Other Subsidies**

11 **SEC. 121. ABOLITION OF ADVANCED TECHNOLOGY PRO-** 12 **GRAM.**

13 (a) ABOLISHMENT.—

14 (1) REPEAL OF SECTION 28 OF THE NATIONAL
15 INSTITUTE OF STANDARDS AND TECHNOLOGY
16 ACT.—Section 28 of the National Institute of Stand-
17 ards and Technology Act (15 U.S.C. 278n) is re-
18 pealed.

19 (2) CLERICAL AMENDMENTS.—The National
20 Institute of Standards and Technology Act (15
21 U.S.C. 271 et seq.) is amended—

22 (A) in section 2(d), by striking “, 26, and
23 28” and inserting “and 26”; and

1 (B) in section 10(h)(1), by striking “, in-
2 cluding the Program established under section
3 28,”.

4 (b) RESCISSION OF UNOBLIGATED FUNDS APPRO-
5 PRIATED.—Any funds appropriated for the Advanced
6 Technology Program established under section 28 of the
7 National Institute of Standards and Technology Act (15
8 U.S.C. 278n) that are unobligated on the date of the en-
9 actment of this Act are hereby rescinded.

10 **SEC. 122. TENNESSEE VALLEY AUTHORITY FUNDING**
11 **ELIMINATION.**

12 Section 27 of the Tennessee Valley Authority Act of
13 1933 (16 U.S.C. 831z) is amended to read as follows:

14 “SEC. 27. No appropriations are authorized to carry
15 out the provisions of this Act after September 30, 1999.”.

16 **SEC. 123. CODIFICATION OF ELIMINATION OF PURCHASER**
17 **ROAD CREDITS AND ELIMINATION OF OTHER**
18 **FEDERAL FUNDING OF FOREST ROADS FOR**
19 **LOGGING.**

20 (a) CODIFICATION OF PURCHASER ROAD CREDITS
21 ELIMINATION.—Consistent with section 329 of the De-
22 partment of the Interior and Related Agencies Appropria-
23 tions Act, 1999 (as contained in section 101(e) of division
24 A of Public Law 105–277; 112 Stat. 2681–292; 16 U.S.C.
25 535a), section 4 of Public Law 88–657 (16 U.S.C. 535;

1 commonly known as the National Forest Roads and Trails
2 Act) is amended—

3 (1) by striking “including provisions for amorti-
4 zation of road costs in contracts” and inserting “ex-
5 cept that the Secretary may not provide effective
6 purchaser credit for road construction”; and

7 (2) by striking the last sentence.

8 (b) CONFORMING AMENDMENTS REGARDING PUR-
9 CHASER ROAD CREDITS.—

10 (1) TRANSPORTATION SYSTEM.—Section 10(a)
11 of the Forest and Rangeland Renewable Resources
12 Planning Act of 1974 (16 U.S.C. 1608(a)) is
13 amended by striking “benefits” and all that follows
14 through the period at the end of the subsection and
15 inserting “benefits.”.

16 (2) TIMBER SALES WITH PURCHASER CREDIT
17 PROVISIONS.—Section 14 of the National Forest
18 Management Act of 1976 (16 U.S.C. 472a) is
19 amended by striking subsection (i).

20 (c) USE OF FEDERAL FUNDS FOR CONSTRUCTION
21 OR RECONSTRUCTION OF LOGGING ROADS.—

22 (1) RESTRICTION.—Except as provided in para-
23 graph (2), Federal funds shall not be obligated after
24 the date of the enactment of this Act for the con-
25 struction or reconstruction of any forest road that

1 will be used principally for logging, including under
2 section 205 of title 23, United States Code (relating
3 to forest development roads and trails).

4 (2) USE OF FUNDS FOR SPECIFICATIONS AND
5 REQUIREMENTS.—Paragraph (1) does not prohibit
6 the obligation of Federal funds for the establishment
7 of specifications and requirements for the construc-
8 tion or reconstruction of roads under timber con-
9 tracts and the oversight and enforcement of compli-
10 ance with those specifications and requirements.

11 (3) RECOVERY OF ROAD COSTS.—The Secretary
12 of Agriculture shall seek to recover from persons
13 who use forest roads for logging that portion of the
14 cost to the Federal Government of construction or
15 reconstruction of forest roads that is attributable to
16 that use.

17 **SEC. 124. PROHIBITION AGAINST PROVISION OF FEDERAL**
18 **FUNDS PURSUANT TO THE NEW ARRANGE-**
19 **MENTS TO BORROW OF THE INTERNATIONAL**
20 **MONETARY FUND.**

21 No officer, employee, or agent of the United States
22 may, directly or indirectly, provide Federal funds to, or
23 for the benefit of, the International Monetary Fund or any
24 instrumentality thereof, pursuant to the New Arrange-
25 ments to Borrow of the International Monetary Fund.

1 **TITLE II—MINERAL EXPLO-**
2 **RATION AND DEVELOPMENT**
3 **Subtitle A—Mineral Exploration**
4 **and Development**

5 **SEC. 201. SHORT TITLE, FINDINGS AND PURPOSES.**

6 (a) **SHORT TITLE.**—This title may be cited as the
7 “Mineral Exploration and Development Act of 1999”.

8 (b) **FINDINGS.**—Congress finds and declares the fol-
9 lowing:

10 (1) The general mining laws, commonly re-
11 ferred to as the Mining Law of 1872, at one time
12 promoted the development of the West and provided
13 a framework for the exploitation of Federal mineral
14 resources.

15 (2) Congress recognized that the public interest
16 was no longer being advanced under the Mining Law
17 of 1872 when, in 1920, it removed energy minerals
18 and minerals chiefly valuable for agricultural use,
19 and in 1955, removed common varieties of mineral
20 materials, from the scope of the general mining laws
21 and made such minerals available under regimes
22 which provide for a financial return to the public for
23 the disposition of such minerals and which better
24 safeguard the environment.

1 (3) The Mining Law of 1872 no longer fosters
2 the efficient and diligent development of those min-
3 eral resources still under its scope, giving rise to
4 speculation and nonmining uses of lands chiefly val-
5 uable for minerals.

6 (4) The Mining Law of 1872 does not provide
7 for a financial return to the American people for use
8 by claim holders of public domain lands or for the
9 disposition of valuable mineral resources from such
10 lands.

11 (5) The Mining Law of 1872 continues to
12 transfer lands valuable for mineral resources from
13 the public domain to private ownership for less than
14 the fair market value of such lands and mineral re-
15 sources.

16 (6) There are a substantial number of acres of
17 land throughout the Nation disturbed by mining ac-
18 tivities conducted under the Mining Law of 1872 on
19 which little or no reclamation was conducted, and
20 the impacts from these unreclaimed lands pose a
21 threat to the public health, safety, and general wel-
22 fare and to environmental quality.

23 (7) Activities under the Mining Law of 1872
24 continue to result in disturbances of surface areas
25 and water resources which burden and adversely af-

1 fect the public welfare by destroying or diminishing
2 the utility of public domain lands for other appro-
3 priate uses and by creating hazards dangerous to
4 the public health and safety and to the environment.

5 (8) Existing Federal law and regulations, as
6 well as applicable State laws, have proven to be in-
7 adequate to ensure that active mining operations
8 under the Mining Law of 1872 will not leave to fu-
9 ture generations a new legacy of hazards associated
10 with unreclaimed mined lands.

11 (9) The public interest is no longer being served
12 by archaic features of the Mining Law of 1872 that
13 thwart the efficient exploration and development of
14 those minerals which remain under its scope and
15 which conflict with modern public land use manage-
16 ment philosophies.

17 (10) The public is justified in expecting the dili-
18 gent development of its mineral resources, a finan-
19 cial return for the use of public domain lands for
20 mineral activities as well as for the disposition of
21 valuable mineral resources from such lands.

22 (11) It is not in the public interest for public
23 domain lands to be sold far below fair market value
24 nor does this aspect of the Mining Law of 1872
25 comport with modern Federal land policy which is

1 grounded on the retention of public domain lands
2 under the principles of multiple use.

3 (12) Mining and reclamation technology is now
4 developed so that effective and reasonable regulation
5 of operations by the Federal Government in accord-
6 ance with this title is an appropriate and necessary
7 means to minimize so far as practicable the adverse
8 social, economic and environmental effects of such
9 mining operations.

10 (13) Mining activities on public domain lands
11 affect interstate commerce, contribute to the eco-
12 nomic well-being, security and general welfare of the
13 Nation and should be conducted in an environ-
14 mentally sound manner.

15 (14) It is necessary that any revision of the
16 general mining laws insure that a domestic supply of
17 hardrock minerals be made available to the domestic
18 economy of the United States.

19 (15) America's economy still depends heavily on
20 hardrock minerals and a strong environmentally
21 sound mining industry is critical to the domestic
22 minerals supply.

23 (16) Many of the deposits of hardrock minerals
24 remain to be discovered on the Federal public do-
25 main.

1 (17) Private enterprise must be given adequate
2 incentive to engage in a capital-intensive industry
3 such as hardrock mining.

4 (18) The United States, as owner of the public
5 domain, has a dual interest in insuring a fair return
6 for mining on the public domain and insuring that
7 any royalty and fees charged do not discourage es-
8 sential mining activity on the public domain.

9 (19) The domestic mining industry provides
10 thousands of jobs directly and indirectly to the do-
11 mestic economy and those jobs must be preserved
12 and encouraged by a sound Federal policy regarding
13 mining on Federal lands.

14 (c) PURPOSE.—It is the purpose of this title—

15 (1) to devise a more socially, fiscally and envi-
16 ronmentally responsible regime to govern the use of
17 public domain lands for the exploration and develop-
18 ment of those minerals not subject to mineral leas-
19 ing acts or mineral materials statutes;

20 (2) to provide for a fair return to the public for
21 the use of public domain lands for mineral activities
22 and for the disposition of minerals from such lands;

23 (3) to foster the diligent development of mineral
24 resources on public domain lands in a manner that

1 is compatible with other resource values and envi-
2 ronmental quality;

3 (4) to promote the restoration of mined areas
4 left without adequate reclamation prior to the enact-
5 ment of this Act and which continue, in their
6 unreclaimed condition, to substantially degrade the
7 quality of the environment, prevent the beneficial
8 use of land or water resources, and endanger the
9 health and safety of the public;

10 (5) to assure that appropriate procedures are
11 provided for public participation in the development,
12 revision and enforcement of regulations, standards
13 and programs established under this title; and

14 (6) to, whenever necessary, exercise the full
15 reach of Federal constitutional powers to ensure the
16 protection of the public interest through the effective
17 control of mineral exploration and development ac-
18 tivities.

19 **SEC. 202. DEFINITIONS AND REFERENCES.**

20 (a) DEFINITIONS.—As used in this title:

21 (1) The term “affiliate” means with respect to
22 any person, any of the following:

23 (A) Any person who controls, is controlled
24 by, or is under common control with such per-
25 son.

1 (B) Any partner of such person.

2 (C) Any person owning at least 10 percent
3 of the voting shares of such person.

4 (2) The term “applicant” means any person ap-
5 plying for a permit under this title or a modification
6 to or a renewal of a permit under this title.

7 (3) The term “beneficiation” means the crush-
8 ing and grinding of locatable mineral ore and such
9 processes as are employed to free the mineral from
10 other constituents, including but not necessarily lim-
11 ited to, physical and chemical separation techniques.

12 (4) The term “claim holder” means a person
13 holding a mining claim located or converted under
14 this title. Such term may include an agent of a claim
15 holder.

16 (5) The term “control” means having the abil-
17 ity, directly or indirectly, to determine (without re-
18 gard to whether exercised through one or more cor-
19 porate structures) the manner in which an entity
20 conducts mineral activities, through any means, in-
21 cluding without limitation, ownership interest, au-
22 thority to commit the entity’s real or financial as-
23 sets, position as a director, officer, or partner of the
24 entity, or contractual arrangement. The Secretary
25 and the Secretary of Agriculture shall jointly pro-

1 mulgate such rules as may be necessary under this
2 paragraph.

3 (6) The term “exploration” means those tech-
4 niques employed to locate the presence of a locatable
5 mineral deposit and to establish its nature, position,
6 size, shape, grade and value not associated with min-
7 ing, beneficiation, processing or marketing of min-
8 erals.

9 (7) The term “Indian lands” means lands held
10 in trust for the benefit of an Indian tribe or indi-
11 vidual or held by an Indian tribe or individual sub-
12 ject to a restriction by the United States against
13 alienation.

14 (8) The term “Indian tribe” means any Indian
15 tribe, band, nation, pueblo, or other organized group
16 or community, including any Alaska Native village
17 or regional corporation as defined in or established
18 pursuant to the Alaska Native Claims Settlement
19 Act (43 U.S.C. 1601 et seq.), which is recognized as
20 eligible for the special programs and services pro-
21 vided by the United States to Indians because of
22 their status as Indians.

23 (9) The term “land use plans” means those
24 plans required under section 202 of the Federal
25 Land Policy and Management Act of 1976 (43

1 U.S.C. 1712) or the land management plans for Na-
2 tional Forest System units required under section 6
3 of the Forest and Rangeland Renewable Resources
4 Planning Act of 1974 (16 U.S.C. 1604), whichever
5 is applicable.

6 (10) The term “legal subdivisions” means an
7 aliquot quarter quarter section of land as established
8 by the official records of the public land survey sys-
9 tem, or a single lot as established by the official
10 records of the public land survey system if the perti-
11 nent section is irregular and contains fractional lots,
12 as the case may be.

13 (11)(A) The term “locatable mineral” means
14 any mineral, the legal and beneficial title to which
15 remains in the United States and which is not sub-
16 ject to disposition under any of the following:

17 (i) The Mineral Leasing Act (30 U.S.C.
18 181 and following).

19 (ii) The Geothermal Steam Act of 1970
20 (30 U.S.C. 1001 and following).

21 (iii) The Act of July 31, 1947, commonly
22 known as the Materials Act of 1947 (30 U.S.C.
23 601 and following).

24 (iv) The Mineral Leasing for Acquired
25 Lands Act (30 U.S.C. 351 and following).

1 (B) The term “locatable mineral” does not in-
2 clude any mineral held in trust by the United States
3 for any Indian or Indian tribe, as defined in section
4 2 of the Indian Mineral Development Act of 1982
5 (25 U.S.C. 2101), or any mineral owned by any In-
6 dian or Indian tribe, as defined in that section, that
7 is subject to a restriction against alienation imposed
8 by the United States.

9 (12) The term “mineral activities” means any
10 activity on Federal lands for, related to, or inci-
11 dental to, mineral exploration, mining, beneficiation,
12 processing, or reclamation activities for any locatable
13 mineral.

14 (13) The term “mining” means the processes
15 employed for the extraction of a locatable mineral
16 from the earth.

17 (14) The term “mining claim” means a claim
18 for the purposes of mineral activities.

19 (15) The term “National Conservation System
20 unit” means any unit of the National Park System,
21 National Wildlife Refuge System, National Wild and
22 Scenic Rivers System, National Trails System, or a
23 National Conservation Area, National Recreation
24 Area, a National Forest Monument or any unit of
25 the National Wilderness Preservation System.

1 (16) The term “operator” means any person,
2 conducting mineral activities subject to this title or
3 any agent of such a person.

4 (17) The term “person” means an individual,
5 Indian tribe, partnership, association, society, joint
6 venture, joint stock company, firm, company, cor-
7 poration, cooperative or other organization and any
8 instrumentality of State or local government includ-
9 ing any publicly owned utility or publicly owned cor-
10 poration of State or local government.

11 (18) The term “processing” means processes
12 downstream of beneficiation employed to prepare
13 locatable mineral ore into the final marketable prod-
14 uct, including but not limited to, smelting and elec-
15 trolytic refining.

16 (19) The term “Secretary” means the Secretary
17 of the Interior, unless otherwise specified.

18 (20) The term “surface management require-
19 ments” means the requirements and standards of
20 subtitle B, and such other standards as are estab-
21 lished by the Secretary governing mineral activities
22 pursuant to this title.

23 (b) REFERENCES.—(1) Any reference in this title to
24 the term “general mining laws” is a reference to those
25 Acts which generally comprise chapters 2, 12A, and 16,

1 and sections 161 and 162 of title 30 of the United States
2 Code.

3 (2) Any reference in this title to the “Act of July
4 23, 1955”, is a reference to the Act of July 23, 1955,
5 entitled “An Act to amend the Act of July 31, 1947 (61
6 Stat. 681) and the mining laws to provide for multiple
7 use of the surface of the same tracts of the public lands,
8 and for other purposes” (30 U.S.C. 601 and following).

9 **SEC. 203. LANDS OPEN TO LOCATION.**

10 (a) LANDS OPEN TO LOCATION.—Except as provided
11 in subsection (b), mining claims may be located under this
12 title on lands and interests in lands owned by the United
13 States if—

14 (1) such lands and interests were open to the
15 location of mining claims under the general mining
16 laws on the date of enactment of this Act; or

17 (2) such lands and interests are opened to the
18 location of mining claims after the date of enact-
19 ment of this Act by reason of any administrative ac-
20 tion or statute.

21 (b) LANDS NOT OPEN TO LOCATION.—

22 (1) IN GENERAL.—Notwithstanding any other
23 provision of law and subject to valid existing rights,
24 each of the following shall not be open to the loca-

1 tion of mining claims under this title on or after the
2 date of enactment of this Act:

3 (A) Lands recommended for wilderness
4 designation by the agency managing the sur-
5 face, pending a final determination by the Con-
6 gress of the status of such recommended lands.

7 (B) Lands being managed by the Sec-
8 retary, acting through Bureau of Land Manage-
9 ment, as wilderness study areas on the date of
10 enactment of this Act except where the location
11 of mining claims is specifically allowed to con-
12 tinue by the statute designating the study area,
13 pending a final determination by the Congress
14 of the status of such lands.

15 (C)(i) Lands under study for inclusion in
16 the National Wild and Scenic River System
17 pursuant to section 5(a) of the Wild and Scenic
18 Rivers Act (16 U.S.C. 1276(a)), pending a final
19 determination by the Congress of the status of
20 such lands, and (ii) lands determined by a Fed-
21 eral agency under section 5(d) of such Act to
22 be eligible for inclusion in such system, pending
23 a final determination by the Congress of the
24 status of such lands.

1 (D) Lands withdrawn from mineral activi-
2 ties under authority of other law.

3 (2) DEFINITION.—(A) As used in this sub-
4 section, the term “valid existing rights” refers to a
5 mining claim located on lands described in para-
6 graph (1) of subsection (a) that—

7 (i) was properly located and maintained
8 under this title prior to and on the applicable
9 date, or

10 (ii) was properly located and maintained
11 under the general mining laws prior to the ap-
12 plicable date, and

13 (I) was supported by a discovery of a
14 valuable mineral deposit within the mean-
15 ing of the general mining laws on the ap-
16 plicable date, and

17 (II) continues to be valid under this
18 title.

19 (B) As used in this paragraph, the term “appli-
20 cable date” means one of the following:

21 (i) In the case of lands described in para-
22 graph (1)(A), such term means the date of the
23 recommendation referred to in paragraph
24 (1)(A) if such recommendation is made on or
25 after the enactment of this Act.

1 (ii) In the case of lands described in para-
2 graph (1)(A), if the recommendation referred to
3 in paragraph (1)(A) was made before the enact-
4 ment of this Act, such term means the earlier
5 of (I) the date of enactment of this Act or (II)
6 the date of any withdrawal of such lands from
7 mineral activities.

8 (iii) For lands described in paragraph
9 (1)(B), such term means the date of the enact-
10 ment of this Act.

11 (iv) For lands referred to in paragraph
12 (1)(C)(i), such term means the date of the en-
13 actment of the amendment to the Wild and Sce-
14 nic Rivers Act listing the river segment for
15 study and for lands referred to in paragraph
16 (1)(C)(ii), such term means the date of the eli-
17 gibility determination.

18 (v) For lands referred to in paragraph
19 (1)(D), such term means the date of the with-
20 drawal.

21 **SEC. 204. RIGHTS UNDER THIS TITLE.**

22 The holder of a mining claim located or converted
23 under this title and maintained in compliance with this
24 title shall have the exclusive right of possession and use
25 of the claimed land for mineral activities, including the

1 right of ingress and egress to such claimed lands for such
2 activities, subject to the rights of the United States under
3 this title and other applicable Federal law. Such rights of
4 the claim holder shall terminate upon completion of min-
5 eral activities of lands to the satisfaction of the Secretary.
6 In cases where an area is determined unsuitable under
7 section 219, holders of claims converted or located under
8 this title shall be entitled to receive a refund of claim
9 maintenance fees.

10 **SEC. 205. LOCATION OF MINING CLAIMS.**

11 (a) GENERAL RULE.—A person may locate a mining
12 claim covering lands open to the location of mining claims
13 by posting a notice of location, containing the person's
14 name and address, the time of location (which shall be
15 the date and hour of location and posting), and a legal
16 description of the claim. The notice of location shall be
17 posted on a suitable, durable monument erected as near
18 as practicable to the northeast corner of the mining claim.
19 No person who is not a citizen of the United States, or
20 a corporation organized under the laws of the United
21 States or of any State or the District of Columbia may
22 locate or hold a claim under this title. On or after the
23 enactment of this Act, a mining claim for a locatable min-
24 eral on lands open to location—

1 (1) may be located only in accordance with this
2 title,

3 (2) may be maintained only as provided in this
4 title, and

5 (3) shall be subject to the requirements of this
6 title.

7 (b) USE OF PUBLIC LAND SURVEY.—Except as pro-
8 vided in subsection (c), each mining claim located under
9 this title shall (1) be located in accordance with the public
10 land survey system, and (2) conform to the legal subdivi-
11 sions thereof. Except as provided in subsection (c)(1), the
12 legal description of the mining claim shall be based on the
13 public land survey system and its legal subdivisions.

14 (c) EXCEPTIONS.—(1) If only a protracted survey ex-
15 ists for the public lands concerned, each of the following
16 shall apply in lieu of subsection (b):

17 (A) The legal description of the mining claim
18 shall be based on the protracted survey and the min-
19 ing claim shall be located as near as practicable in
20 conformance with a protracted legal subdivision.

21 (B) The mining claim shall be monumented on
22 the ground by the erection of a suitable, durable
23 monument at each corner of the claim.

24 (C) The legal description of the mining claim
25 shall include a reference to any existing survey

1 monument, or where no such monument can be
2 found within a reasonable distance, to a permanent
3 and conspicuous natural object.

4 (2) If no survey exists for the public lands concerned,
5 each of the following shall apply in lieu of subsection (b):

6 (A) The mining claim shall be a regular square,
7 with each side laid out in cardinal directions, 40
8 acres in size.

9 (B) The claim shall be monumented on the
10 ground by the erection of a suitable durable monu-
11 ment at each corner of the claim.

12 (C) The legal description of the mining claim
13 shall be expressed in metes and bounds and shall be
14 defined by and referenced to the closest existing sur-
15 vey monument, or where no such monument can be
16 found within a reasonable distance, to a permanent
17 and conspicuous natural object. Such description
18 shall be of sufficient accuracy and completeness to
19 permit recording of the claim upon the public land
20 records and to permit the claim to be readily found
21 upon the ground.

22 (3) In the case of a conflict between the boundaries
23 of a mining claim as monumented on the ground and the
24 description of such claim in the notice of location referred
25 to in subsection (a), the notice of location shall be deter-

1 minative, except where determined otherwise by the Sec-
2 retary.

3 (d) FILING WITH SECRETARY.—(1) Within 30 days
4 after the location of a mining claim pursuant to this sec-
5 tion, a copy of the notice of location referred to in sub-
6 section (a) shall be filed with the Secretary in an office
7 designated by the Secretary.

8 (2)(A) Whenever the Secretary receives a copy of a
9 notice of location of a mining claim under this title, the
10 Secretary shall assign a serial number to the mining claim,
11 and immediately return a copy of the notice of location
12 to the locator of the claim, together with a certificate set-
13 ting forth the serial number, a description of the claim,
14 and the claim maintenance requirements of section 207.
15 The Secretary shall enter the claim on the public land
16 records.

17 (B) Return of the copy of the notice of location and
18 provision of the certificate under subparagraph (A) shall
19 not constitute a determination by the Secretary that a
20 claim is valid. Failure by the Secretary to provide such
21 copy and certificate shall not constitute a defense against
22 cancellation of a claim for failure to follow applicable re-
23 quirements of this title.

24 (3) Notwithstanding any other provision of law, for
25 every unpatented mining claim located after the date of

1 enactment of this Act, the locator shall, at the time the
2 location notice is recorded with the Bureau of Land Man-
3 agement, pay a location fee of \$25.00 per claim. The loca-
4 tion fee shall be in addition to the claim maintenance fee
5 payable under section 207.

6 (4) Subsections (b) and (c) of section 314 of the Fed-
7 eral Land Policy and Management Act of 1976 (43 U.S.C.
8 1744(b)) are repealed.

9 (e) CONVERTED CLAIMS.—For mining claims and
10 mill sites deemed converted under this title, for the pur-
11 poses of complying with the requirements of subsection
12 (d), upon receipt of the initial claim maintenance fee re-
13 quired under section 207, the Secretary shall issue a cer-
14 tificate referenced in subsection (d)(2) to the holder of the
15 mining claim or mill site.

16 (f) DATE OF LOCATION.—A mining claim located
17 under this title shall be effective based upon the time of
18 location.

19 (g) LANDS COVERED BY CLAIM.—A mining claim lo-
20 cated or converted under this title shall include all lands
21 and interests in lands open to location within the bound-
22 aries of the claim, subject to any prior mining claim lo-
23 cated or converted under this title.

24 (h) CONFLICTING LOCATIONS.—Any conflicts be-
25 tween the holders of mining claims located or converted

1 under this title relating to relative superiority under the
2 provisions of this title may be resolved in adjudication pro-
3 ceedings in a court with proper jurisdiction, including, as
4 appropriate, State courts. It shall be incumbent upon the
5 holder of a mining claim asserting superior rights in such
6 proceedings to demonstrate that such person was the sen-
7 ior locator, or if such person is the junior locator, that
8 prior to the location of the claim by such locator—

9 (1) the senior locator failed to file a copy of the
10 notice of location within the time provided under
11 subsection (d); or

12 (2) the amount of claim maintenance fee paid
13 by the senior locator at the time of filing the loca-
14 tion notice referred to in subsection (d) was less
15 than the amount required to be paid by such locator.

16 (i) **EXTENT OF MINERAL DEPOSIT.**—The boundaries
17 of a mining claim located under this title shall extend
18 vertically downward.

19 **SEC. 206. CONVERSION OF EXISTING CLAIMS.**

20 (a) **EXISTING CLAIMS.**—Notwithstanding any other
21 provision of law, on the effective date of this title any
22 unpatented mining claim for a locatable mineral located
23 under the general mining laws prior to the date of enact-
24 ment of this Act shall become subject to this title's provi-
25 sions and shall be deemed a converted mining claim under

1 this title. Nothing in this title shall be construed to affect
2 extralateral rights in any valid lode mining claim existing
3 on the date of enactment of this Act. After the effective
4 date of this title, there shall be no distinction made as
5 to whether such claim was originally located as a lode or
6 placer claim.

7 (b) MILL AND TUNNEL SITES.—On the effective date
8 of this title, any unpatented mill or tunnel site located
9 under the general mining laws before the date of enact-
10 ment of this Act shall become subject to this title's provi-
11 sions and shall be deemed a converted mining claim under
12 this title.

13 (c) POSTCONVERSION.—Any unpatented mining
14 claim or mill site located under the general mining laws
15 shall be deemed to be a prior claim for the purposes of
16 section 205(g) when converted pursuant to subsection (a)
17 or (b).

18 (d) DISPOSITION OF LAND.—In the event a mining
19 claim is located under this title for lands encumbered by
20 a prior mining claim or mill site located under the general
21 mining laws, such lands shall become part of the claim
22 located under this title if the claim or mill site located
23 under the general mining laws is declared null and void
24 under this section or is otherwise declared null and void
25 thereafter.

1 (e) CONFLICTS.—(1) Any conflicts in existence before
2 the effective date of this title between holders of mining
3 claims, mill sites and tunnel sites located under the gen-
4 eral mining laws shall be subject to, and shall be resolved
5 in accordance with, applicable laws governing such con-
6 flicts in effect before the effective date of enactment of
7 this Act in a court of proper jurisdiction.

8 (2) Any conflicts not relating to matters provided for
9 under section 205(h) between the holders of a mining
10 claim located under this title and a mining claim, mill,
11 or tunnel site located under the general mining laws aris-
12 ing either before or after the conversion of any such claim
13 or site under this section shall be resolved in a court with
14 proper jurisdiction.

15 **SEC. 207. CLAIM MAINTENANCE REQUIREMENTS.**

16 (a) IN GENERAL.—(1) The holder of each mining
17 claim converted pursuant to this title shall pay to the Sec-
18 retary an annual claim maintenance fee of \$100 per claim.

19 (2) The holder of each mining claim located pursuant
20 to this title shall pay to the Secretary an annual claim
21 maintenance fee of \$200 per claim.

22 (b) TIME OF PAYMENT.—The claim maintenance fee
23 payable pursuant to subsection (a) for any year shall be
24 paid on or before August 31 of each year, except that in
25 the case of claims referred to in subsection (a)(2), for the

1 initial calendar year in which the location is made, the
2 locator shall pay the initial claim maintenance fee at the
3 time the location notice is recorded with the Bureau of
4 Land Management.

5 (c) OIL SHALE CLAIMS SUBJECT TO CLAIM MAINTENANCE FEES UNDER ENERGY POLICY ACT OF 1992.—
6 This section shall not apply to any oil shale claims for
7 which a fee is required to be paid under section 2511(e)(2)
8 of the Energy Policy Act of 1992 (Public Law 102–486;
9 106 Stat. 3111; 30 U.S.C. 242).

11 (d) CLAIM MAINTENANCE FEES PAYABLE UNDER 1993 ACT.—The claim maintenance fees payable under
12 this section for any period with respect to any claim shall
13 be reduced by the amount of the claim maintenance fees
14 paid under section 10101 of the Omnibus Budget Rec-
15 onciliation Act of 1993 with respect to that claim and with
16 respect to the same period.

18 (e) WAIVER.—(1) The claim maintenance fee re-
19 quired under this section may be waived for a claim holder
20 who certifies in writing to the Secretary that on the date
21 the payment was due, the claim holder and all related par-
22 ties held not more than 10 mining claims on lands open
23 to location. Such certification shall be made on or before
24 the date on which payment is due.

1 (2) For purposes of paragraph (1), with respect to
2 any claim holder, the term “related party” means each
3 of the following:

4 (A) The spouse and dependent children (as de-
5 fined in section 152 of the Internal Revenue Code of
6 1986), of the claim holder.

7 (B) Any affiliate of the claim holder.

8 (f) CO-OWNERSHIP.—Upon the failure of any one or
9 more of several co-owners to contribute such co-owner or
10 owners’ portion of the fee under this section, any co-owner
11 who has paid such fee may, after the payment due date,
12 give the delinquent co-owner or owners notice of such fail-
13 ure in writing (or by publication in the newspaper nearest
14 the claim for at least once a week for at least 90 days).
15 If at the expiration of 90 days after such notice in writing
16 or by publication, any delinquent co-owner fails or refuses
17 to contribute his portion, his interest in the claim shall
18 become the property of the co-owners who have paid the
19 required fee.

20 (g) FUND.—All monies received under this section
21 shall be deposited in the Abandoned Locatable Minerals
22 Mine Reclamation Fund established under subtitle C of
23 this title.

24 (h) CREDIT AGAINST ROYALTY.—The amount of the
25 annual claim maintenance fee required to be paid under

1 this section for any claim for any period shall be credited
2 against the amount of royalty required to be paid under
3 section 236 for the same period with respect to that claim.

4 **SEC. 208. FAILURE TO COMPLY.**

5 (a) **FORFEITURE.**—The failure of the claim holder to
6 file the notice of location, to pay the location fee, or to
7 pay the claim maintenance fee for a mining claim as re-
8 quired by this subtitle shall be deemed conclusively to con-
9 stitute forfeiture of the mining claim by operation of law.
10 Forfeiture shall not relieve any person of any obligation
11 created under this title, including reclamation.

12 (b) **PROHIBITION.**—No claim holder may locate a new
13 claim on the lands such claim holder included in a for-
14 feited claim for 1 year from the date such claim is deemed
15 forfeited.

16 (c) **RELINQUISHMENT.**—A claim holder deciding not
17 to pursue mineral activities on a claim may relinquish such
18 claim by notifying the Secretary. A claim holder relin-
19 quishing a claim is responsible for reclamation as required
20 by section 217 of this title and all other applicable require-
21 ments. A claim holder who relinquishes a claim shall not
22 be subject to the prohibition of subsection (b) of this sec-
23 tion unless the Secretary determines that the claim is
24 being relinquished and relocated for the purpose of avoid-

1 ing compliance with any provision of this title, including
2 payment of the claim maintenance fee.

3 **SEC. 209. BASIS FOR CONTEST.**

4 (a) DISCOVERY.—(1) After the effective date of this
5 title, a mining claim may not be contested or challenged
6 on the basis of discovery under the general mining laws,
7 except as follows:

8 (A) Any claim located before the effective date
9 of this title may be contested by the United States
10 on the basis of discovery under the general mining
11 laws as in effect prior to the effective date of this
12 title if such claim is located within any National
13 Conservation System unit, or within any area re-
14 ferred to in section 203(b).

15 (B) Any mining claim located before the effec-
16 tive date of this title may be contested by the United
17 States on the basis of discovery under the general
18 mining laws as in effect prior to the effective date
19 of this title if such claim was located for a mineral
20 material that purportedly has a property giving it
21 distinct and special value within the meaning of sec-
22 tion 3(a) of the Act of July 23, 1955 (as in effect
23 prior to the date of enactment of this Act), or if
24 such claim was located for a mineral that was not

1 locatable under the general mining laws before the
2 effective date of this title.

3 (2) The Secretary may initiate contest proceedings
4 against those mining claims referred to in paragraph (1)
5 at any time, except that nothing in this subsection may
6 be construed as requiring the Secretary to inquire into,
7 or contest, the validity of a mining claim for the purpose
8 of the conversion referred to in section 206, except as pro-
9 vided in section 252.

10 (3) Nothing in this subsection may be construed as
11 limiting any contest proceedings initiated by the United
12 States on issues other than discovery, or any contest pro-
13 ceedings filed before the effective date of this title.

14 (4) Any contest proceeding initiated pursuant to
15 paragraph (1) shall determine whether the mining claim
16 or claims subject to such proceeding supported a discovery
17 of a valuable mineral deposit within the meaning of the
18 general mining laws on the effective date of this title.

19 (b) CONTINUED SUFFICIENCY OF MINING CLAIM.—

20 (1) At any time, upon request of the Secretary, the claim
21 holder shall demonstrate that the continued retention of
22 a mining claim located or converted under this title is ex-
23 clusively related to mineral activities at the site.

24 (2) Where the Secretary requests demonstration of
25 the continuing sufficiency of any mining claim under this

1 section, the claim holder shall have the burden of showing
2 each of the following:

3 (A) The lands or interests in lands included in
4 the mining claim are not used predominantly for rec-
5 reational, residential or other purposes rather than
6 for mineral activities and are being held in good
7 faith for the ultimate exploration for, development
8 of, or production of locatable minerals, as dem-
9 onstrated by the claim holder or his or her assigns
10 through showings satisfactory to the Secretary.

11 (B) The claim holder or operator does not re-
12 strict access to the lands or interests in lands in-
13 cluded in the mining claim in a manner that is not
14 required for mineral activities.

15 (C) The mineral being or to be mined on the
16 mining claim is a locatable mineral (unless such
17 lands are used for beneficiation or processing).

18 (D) The claim holder or operator has not con-
19 structed, improved, maintained or used a structure
20 located on a mining claim in a manner not specifi-
21 cally authorized by the Secretary in accordance with
22 this title.

23 (3) Any mining claim for which the claim holder fails
24 to demonstrate continued sufficiency, in the determination
25 of the Secretary, pursuant to subsection (b) of this section,

1 shall thereupon be deemed forfeited and be declared null
2 and void.

3 (c) REMEDIES.—(1) The Secretary may assess a civil
4 penalty of not more than \$5,000 per claim against the
5 claim holder upon declaring a mining claim null and void
6 pursuant to subsection (b) of this section.

7 (2) Upon declaring a mining claim null and void pur-
8 suant to subsection (b), the Secretary shall provide a rea-
9 sonable opportunity for the mining claim holder or oper-
10 ator to remove any real or personal property which such
11 person had previously placed upon the claim. If the prop-
12 erty is not removed within the time provided, the Sec-
13 retary may retain the property or provide for its disposi-
14 tion or destruction.

15 (d) OTHER LAW.—The Secretary shall take such ac-
16 tions as may be necessary to ensure the compliance by
17 claim holders with section 4 of the Act of July 23, 1955
18 (30 U.S.C. 612), consistent with this section.

19 **Subtitle B—Environmental Consid-**
20 **erations of Mineral Exploration**
21 **and Development**

22 **SEC. 211. SURFACE MANAGEMENT STANDARD.**

23 Notwithstanding the last sentence of section 302(b)
24 of the Federal Land Policy and Management Act of 1976,
25 and in accordance with this subtitle and other applicable

1 law, the Secretary, and for National Forest System lands
2 the Secretary of Agriculture, shall require that mineral ac-
3 tivities on Federal lands conducted by any person mini-
4 mize adverse impacts to the environment.

5 **SEC. 212. PERMITS.**

6 (a) PERMITS REQUIRED.—No person may engage in
7 mineral activities on Federal lands that may cause a dis-
8 turbance of surface resources, including but not limited
9 to, land, air, ground water and surface water, fish, wild-
10 life, and biota unless—

11 (1) the claim was properly located or converted
12 under this title and properly maintained; and

13 (2) a permit was issued to such person under
14 this subtitle authorizing such activities.

15 (b) NEGLIGIBLE DISTURBANCE.—Notwithstanding
16 subsection (a)(2), a permit under this subtitle shall not
17 be required for mineral activities related to exploration,
18 or gathering of data, required to comply with section 213
19 or 214 that cause a negligible disturbance of surface re-
20 sources and do not involve any of the following:

21 (1) The use of mechanized earth moving equip-
22 ment, suction dredging, explosives.

23 (2) The use of motor vehicles in areas closed to
24 off-road vehicles.

1 (3) The construction of roads, drill pads, or the
2 use of toxic or hazardous materials.

3 Persons engaging in such activities shall provide prior
4 written notice. The Secretary and the Secretary of Agri-
5 culture may provide, by joint regulations the manner in
6 which such notice shall be provided.

7 (c) WAIVER OF THE SOVEREIGN IMMUNITY OF IN-
8 DIAN TRIBES.—The Secretary is authorized to require In-
9 dian tribes to waive sovereign immunity as a condition of
10 obtaining a permit under this title.

11 **SEC. 213. EXPLORATION PERMITS.**

12 (a) AUTHORIZED EXPLORATION ACTIVITY.—Any
13 claim holder may apply for an exploration permit for any
14 mining claim authorizing the claim holder to remove a rea-
15 sonable amount of the locatable minerals from the claim
16 for analysis, study and testing. Such permit shall not au-
17 thorize the claim holder to remove any mineral for sale
18 nor to conduct any activities other than those required for
19 exploration for locatable minerals and reclamation.

20 (b) PERMIT APPLICATION REQUIREMENTS.—An ap-
21 plication for an exploration permit under this section shall
22 be submitted in a manner satisfactory to the Secretary
23 or, for National Forest System lands, the Secretary of Ag-
24 riculture, and shall contain an exploration plan, a reclama-
25 tion plan for the proposed exploration, such documenta-

1 tion as necessary to ensure compliance with applicable
2 Federal and State environmental laws and regulations,
3 and each of the following:

4 (1) The name, mailing address, and social secu-
5 rity number or tax identification number, as applica-
6 ble, of each of the following:

7 (A) The applicant for the permit and any
8 agent of the applicant.

9 (B) The operator (if different than the ap-
10 plicant) of the claim concerned.

11 (C) Each claim holder (if different than
12 the applicant) of the claim concerned.

13 (2) A statement of whether any person referred
14 to in subparagraphs (A) through (C) of paragraph
15 (1) is currently in violation of, or was, during the 3-
16 year period preceding the date of the application,
17 found to be in violation of, any of the following and,
18 if so, a brief explanation of the facts involved, in-
19 cluding identification of the site and nature of the
20 violation:

21 (A) Any provision of this title or any regu-
22 lation under this title.

23 (B) Any applicable toxic substance, solid
24 waste, air, water quality, or fish and wildlife
25 conservation law or regulation at any site where

1 mining, beneficiation, or processing activities
2 are occurring or have occurred.

3 (C) The Surface Mining Control and Rec-
4 lamation Act of 1977 (30 U.S.C. 1201 and fol-
5 lowing) or any regulation under that Act at any
6 site where surface coal mining operations have
7 occurred or are occurring.

8 (3) A description of the type and method of ex-
9 ploration activities proposed, the engineering tech-
10 niques proposed to be used and the equipment pro-
11 posed to be used.

12 (4) The anticipated starting and termination
13 dates of each phase of the exploration activities pro-
14 posed, including any planned temporary cessation of
15 exploration.

16 (5) A map, to an appropriate scale, clearly
17 showing the land to be affected by the proposed ex-
18 ploration.

19 (6) Information determined necessary by the
20 Secretary concerned to assess the cumulative im-
21 pacts, as required to comply with the National Envi-
22 ronmental Policy Act of 1969.

23 (7) Evidence of appropriate financial assurance
24 as specified in section 216.

1 (c) RECLAMATION PLAN REQUIREMENTS.—The rec-
2 lamation plan required to be included in a permit applica-
3 tion under subsection (b) shall include such provisions as
4 may be jointly prescribed by the Secretary and the Sec-
5 retary of Agriculture and each of the following:

6 (1) A description of the condition of the land,
7 including the fish and wildlife resources and habitat
8 contained thereon, subject to the permit prior to the
9 commencement of any exploration activities.

10 (2) A description of reclamation measures pro-
11 posed pursuant to the requirements of section 217.

12 (3) The engineering techniques to be used in
13 reclamation and the equipment proposed to be used.

14 (4) The anticipated starting and termination
15 dates of each phase of the reclamation proposed.

16 (5) A description of the proposed condition of
17 the land, including the fish and wildlife resources
18 and habitat contained thereon, following the comple-
19 tion of reclamation.

20 (d) PERMIT ISSUANCE OR DENIAL.—The Secretary,
21 or for National Forest System lands, the Secretary of Ag-
22 riculture, shall issue an exploration permit pursuant to an
23 application under this section if such Secretary makes
24 each of the following determinations, and such Secretary

1 shall deny a permit which he or she finds does not fully
2 meet the requirements of this subsection:

3 (1) The permit application, the exploration plan
4 and reclamation plan are complete and accurate.

5 (2) The applicant has demonstrated that pro-
6 posed reclamation can be accomplished.

7 (3) The proposed exploration activities and con-
8 dition of the land after the completion of exploration
9 activities and final reclamation would conform with
10 the land use plan applicable to the area subject to
11 mineral activities.

12 (4) The area subject to the proposed permit is
13 not included within an area designated unsuitable
14 under section 219 or not open to location under sec-
15 tion 203(b) for the types of exploration activities
16 proposed.

17 (5) The applicant has demonstrated that the
18 exploration plan and reclamation plan will be in
19 compliance with the requirements of this title and all
20 other applicable Federal requirements, and any
21 State requirements agreed to by the Secretary of the
22 Interior (or Secretary of Agriculture, as appropriate)
23 pursuant to a cooperative agreement under section
24 218.

1 (6) The applicant has fully complied with the
2 requirements of section 216 (relating to financial as-
3 surance).

4 (e) TERM OF PERMIT.—An exploration permit shall
5 be for a stated term. The term shall be no greater than
6 that necessary to accomplish the proposed exploration,
7 and in no case for more than 5 years.

8 (f) PERMIT MODIFICATION.—During the term of an
9 exploration permit the permit holder may submit an appli-
10 cation to modify the permit. To approve a proposed modi-
11 fication to the permit, the Secretary concerned shall make
12 the same determinations as are required in the case of
13 an original permit, except that the Secretary and the Sec-
14 retary of Agriculture may specify by joint rule the extent
15 to which requirements for initial exploration permits under
16 this section shall apply to applications to modify an explo-
17 ration permit based on whether such modifications are
18 deemed significant or minor.

19 (g) FEES.—Each application for a permit pursuant
20 to this section shall be accompanied by a fee payable to
21 the Secretary of the Interior in such amount as may be
22 established by the Secretary of the Interior. Such amount
23 shall be equal to the actual or anticipated cost to the Sec-
24 retary or the Secretary of Agriculture, as the case may
25 be, of reviewing, administering, and enforcing such permit,

1 as determined by such Secretary. All moneys received
2 under this subsection shall be deposited in the Abandoned
3 Locatable Minerals Mine Reclamation Fund established
4 under subtitle C of this title.

5 (h) TRANSFER, ASSIGNMENT, OR SALE OF
6 RIGHTS.—(1) No transfer, assignment, or sale of rights
7 granted by a permit issued under this section shall be
8 made without the prior written approval of the Secretary
9 or for National Forest System lands, the Secretary of Ag-
10 riculture.

11 (2) Such Secretary may allow a person holding a per-
12 mit to transfer, assign, or sell rights under the permit to
13 a successor, if the Secretary finds, in writing, that the
14 successor—

15 (A) is eligible to receive a permit in accordance
16 with section 215;

17 (B) has submitted evidence of financial assur-
18 ance satisfactory under section 216; and

19 (C) meets any other requirements specified by
20 the Secretary.

21 (3) The successor in interest shall assume the liability
22 and reclamation responsibilities established by the existing
23 permit and shall conduct the mineral activities in full com-
24 pliance with this title, and the terms and conditions of

1 the permit as in effect at the time of transfer, assignment,
2 or sale.

3 (4) Each application for approval of a permit trans-
4 fer, assignment, or sale pursuant to this subsection shall
5 be accompanied by a fee payable to the Secretary of the
6 Interior in such amount as may be established by such
7 Secretary. Such amount shall be equal to the actual or
8 anticipated cost to the Secretary or the Secretary of Agri-
9 culture, as appropriate, of reviewing and approving or dis-
10 approving such transfer, assignment, or sale, as deter-
11 mined by the Secretary of the Interior. All moneys re-
12 ceived under this subsection shall be deposited in the
13 Abandoned Locatable Minerals Mine Reclamation Fund
14 established under subtitle C of this title.

15 **SEC. 214. OPERATIONS PERMIT.**

16 (a) OPERATIONS PERMIT.—Any claim holder may
17 apply to the Secretary, or for National Forest System
18 lands, the Secretary of Agriculture, for an operations per-
19 mit authorizing the claim holder to carry out mineral ac-
20 tivities on Federal lands. The permit shall include such
21 terms and conditions as prescribed by such Secretary to
22 carry out this subtitle.

23 (b) PERMIT APPLICATION REQUIREMENTS.—An ap-
24 plication for an operations permit under this section shall
25 be submitted in a manner satisfactory to the Secretary

1 concerned and shall contain an operations plan, a reclama-
2 tion plan, such documentation as necessary to ensure com-
3 pliance with applicable Federal and State environmental
4 laws and regulations, and each of the following:

5 (1) The name, mailing address, and social secu-
6 rity number or tax identification number, as applica-
7 ble, of each of the following:

8 (A) The applicant for the permit and any
9 agent of the applicant.

10 (B) The operator (if different than the ap-
11 plicant) at the claim concerned.

12 (C) Each claim holder (if different than
13 the applicant) of the claim concerned.

14 (D) Each affiliate and each officer or di-
15 rector of the applicant.

16 (2) A statement of whether a person referred to
17 in subparagraphs (A) through (D) of paragraph (1)
18 is currently in violation of, or was, during the 3-year
19 period preceding the date of application, found to be
20 in violation of, any of the following and if so, a brief
21 explanation of the facts involved, including identi-
22 fication of the site and the nature of the violation:

23 (A) Any provision of this title or any regu-
24 lation under this title.

1 (B) Any applicable toxic substance, solid
2 waste, air, water quality, or fish and wildlife
3 conservation law or regulation at any site where
4 mining, beneficiation, or processing activities
5 are occurring or have occurred.

6 (C) The Surface Mining Control and Rec-
7 lamation Act of 1977 (30 U.S.C. 1201 and fol-
8 lowing) or any regulation under that Act at any
9 site where surface coal mining operations have
10 occurred or are occurring.

11 (3) A statement of any current or previous per-
12 mits or plans of operations issued under the Surface
13 Mining Control and Reclamation Act or the Federal
14 Land Policy and Management Act of 1976.

15 (4) A description of the type and method of
16 mineral activities proposed, the engineering tech-
17 niques proposed to be used and the equipment pro-
18 posed to be used.

19 (5) The anticipated starting and termination
20 dates of each phase of the mineral activities pro-
21 posed, including any planned temporary cessation of
22 operations.

23 (6) Maps, to an appropriate scale, clearly show-
24 ing the lands, watersheds, and surface waters, to be
25 affected by the proposed mineral activities; surface

1 and mineral ownership; facilities, including roads
2 and other man-made structures; proposed disturb-
3 ances; soils and vegetation; topography; and water
4 supply intakes and surface water bodies.

5 (7) A description of the biological resources in
6 or associated with the area subject to mineral activi-
7 ties, including vegetation, fish and wildlife, riparian
8 and wetland habitats.

9 (8) A description of measures planned to ex-
10 clude fish and wildlife resources from the area sub-
11 ject to mineral activities by covering, containment,
12 or fencing of open waters, beneficiation, and proc-
13 essing materials; or maintenance of all facilities in a
14 condition that is not harmful to fish and wildlife.

15 (9) A description of the quantity and quality of
16 surface and ground water resources in or associated
17 with the area subject to mineral activities, based on
18 pre-disturbance monitoring sufficient to establish
19 seasonal variations.

20 (10) An analysis of the probable hydrologic con-
21 sequences of the mineral activities, both on and off
22 the area subject to mineral activities, with respect to
23 the hydrologic regime, quantity and quality of water
24 in surface and ground water systems including the
25 dissolved and suspended solids under seasonal flow

1 conditions and the collection of sufficient data for
2 the mine site and surrounding areas so that an as-
3 sessment can be made by the Secretary concerned of
4 the probable cumulative impacts of the anticipated
5 mineral activities in the area upon the hydrology of
6 the area and particularly upon water availability.

7 (11) A description of the monitoring systems to
8 be used to detect and determine whether compliance
9 has and is occurring consistent with the surface
10 management requirements and to monitor the ef-
11 fects of mineral activities on the site and sur-
12 rounding environment, including but not limited to,
13 ground water, surface water, air, soils, and fish and
14 wildlife resources.

15 (12) Accident contingency plans that include,
16 but are not limited to, immediate response strategies
17 and corrective measures to mitigate environmental
18 impacts and appropriate insurance to cover accident
19 contingencies.

20 (13) Any measures to comply with any condi-
21 tions on minerals activities that may be required in
22 the applicable land use plan or any condition stipu-
23 lated pursuant to section 219.

24 (14) Information determined necessary by the
25 Secretary concerned to assess the cumulative im-

1 pacts of mineral activities, as required to comply
2 with the National Environmental Policy Act of 1969.

3 (15) Such other environmental baseline data as
4 the Secretaries, by joint regulation, shall require suf-
5 ficient to validate the determinations required for
6 issuance of a permit under this title.

7 (16) Evidence of appropriate financial assur-
8 ance as specified in section 216.

9 (17) A description of the site security provisions
10 designed to protect from theft the locatable min-
11 erals, concentrates or products derived therefrom
12 which will be produced or stored on a mining claim.

13 (18) A full characterization of soils and geology
14 in the area to be affected by mineral activities.

15 (19) A copy of the applicant's advertisement to
16 be published as required by section 243 (relating to
17 public participation).

18 (c) RECLAMATION PLAN APPLICATION REQUIRE-
19 MENTS.—The reclamation plan referred to in subsection
20 (b) shall include such reclamation measures as prescribed
21 by the Secretary, or for National Forest System lands the
22 Secretary of Agriculture, and each of the following:

23 (1) A description of the condition of the land,
24 including the fish and wildlife resources and habitat

1 contained thereon, subject to the permit prior to the
2 commencement of any mineral activities.

3 (2) A description of reclamation measures pro-
4 posed pursuant to the requirements of section 217.

5 (3) The engineering techniques to be used in
6 reclamation and the equipment proposed to be used.

7 (4) The anticipated starting and termination
8 dates of each phase of the reclamation proposed.

9 (5) A description of the proposed condition of
10 the land, including the fish and wildlife resources
11 and habitat contained thereon, following the comple-
12 tion of reclamation.

13 (6) A description of the maintenance measures
14 that will be necessary to meet the surface manage-
15 ment requirements of this title, such as, but not lim-
16 ited to, drainage water treatment facilities, or liner
17 maintenance and control.

18 (7) The consideration which has been given to
19 making the condition of the land after the comple-
20 tion of mineral activities and final reclamation con-
21 sistent with the applicable land use plan.

22 (d) PERMIT ISSUANCE OR DENIAL.—(1) After pro-
23 viding notice and opportunity for public comment and
24 hearing, the Secretary, or for National Forest System
25 lands the Secretary of Agriculture, shall issue an oper-

1 ations permit if such Secretary makes each of the fol-
2 lowing determinations in writing, and such Secretary shall
3 deny a permit which he or she finds does not fully meet
4 the requirements of this paragraph:

5 (A) The permit application, operations plan,
6 and reclamation plan are complete and accurate.

7 (B) The applicant has demonstrated that the
8 proposed reclamation in the reclamation plan can be
9 accomplished.

10 (C) The proposed mineral activities and condi-
11 tion of the land including the fish and wildlife re-
12 sources and habitat contained thereon, after the
13 completion of mineral activities and final reclama-
14 tion conform to the land use plan applicable to the
15 area subject to mineral activities.

16 (D) The area subject to the proposed plan is
17 not included within an area designated unsuitable or
18 not open to location for the types of mineral activi-
19 ties proposed.

20 (E) The applicant has demonstrated that the
21 mineral activities will be in compliance with this title
22 and all other applicable Federal requirements, and
23 any State requirements agreed to by the appropriate
24 Secretary pursuant to cooperative agreements under
25 section 218.

1 (F) The assessment of the probable cumulative
2 impact of all anticipated mining in the area on the
3 hydrologic balance specified in subsection (b)(10)
4 has been made and the proposed operation has been
5 designed to minimize disturbances to the prevailing
6 hydrologic balance of the permit area.

7 (G) The applicant has fully complied with the
8 requirements of section 216 (relating to financial as-
9 surance).

10 (2) Issuance of an operations permit under this sec-
11 tion shall be based on information supplied by the appli-
12 cant or other interested parties and the applicant shall
13 have the burden of establishing that the application com-
14 plies with paragraph (1).

15 (3) With respect to any activities specified in the rec-
16 lamation plan referred to in subsection (b) which con-
17 stitute a removal or remedial action under section 101 of
18 the Comprehensive Environmental Response, Compensa-
19 tion and Liability Act of 1980, the Secretary shall consult
20 with the Administrator of the Environmental Protection
21 Agency prior to the issuance of an operating permit. To
22 the extent practicable, the Administrator shall ensure that
23 the reclamation plan does not require activities which
24 would increase the costs or likelihood of removal or reme-
25 dial actions under Comprehensive Environmental Re-

1 sponse, Compensation and Liability Act of 1980 or correc-
2 tive actions under the Solid Waste Disposal Act.

3 (e) TERM OF PERMIT; RENEWAL.—(1) An operations
4 permit shall be for a stated term. The term shall be no
5 greater than that necessary to accomplish the proposed
6 mineral activities subject to the permit, and in no case
7 for more than 10 years, unless the applicant demonstrates
8 to the satisfaction of the Secretary, or for National Forest
9 System lands the Secretary of Agriculture, that a specified
10 longer term is reasonably needed for such mineral activi-
11 ties.

12 (2) Failure by the operator to commence mineral ac-
13 tivities within one year of the date scheduled in an oper-
14 ations permit shall require a modification of the permit
15 unless the Secretary concerned determines that the delay
16 was beyond the control of the applicant.

17 (3) An operations permit shall carry with it the right
18 of successive renewal upon expiration only with respect to
19 operations on areas within the boundaries of the existing
20 permit as issued. A renewal of such permit shall not be
21 issued if such Secretary determines, in writing, any of the
22 following:

23 (A) The terms and conditions of the existing
24 permit are not being met.

1 (B) The operator has not demonstrated that
2 the financial assurance would continue to apply in
3 full force and effect for the renewal term.

4 (C) Any additional revised or updated informa-
5 tion required by the Secretary concerned has not
6 been provided.

7 (D) The applicant has not demonstrated that
8 the mineral activities will be in compliance with the
9 requirements of all other applicable Federal require-
10 ments, and any State requirements agreed to by the
11 Secretary concerned pursuant to cooperative agree-
12 ments under section 218.

13 (4) A renewal of an operations permit shall be for
14 a term of 10 years or for such additional term as the Sec-
15 retary concerned deems appropriate. Application for re-
16 newal shall be made at least one year prior to the expira-
17 tion of the existing permit. Where a renewal application
18 has been timely submitted and a permit expires prior to
19 Secretarial action on the renewal application, reclamation
20 shall and other mineral activities may continue in accord-
21 ance with the terms of the expired permit until the Sec-
22 retary concerned makes a decision on the renewal applica-
23 tion.

24 (f) PERMIT MODIFICATION.—(1) During the term of
25 an operations permit the operator may submit an applica-

1 tion to modify the permit (including the operations plan
2 or reclamation plan, or both). To approve a proposed
3 modification, the Secretary, or for National Forest System
4 lands the Secretary of Agriculture, shall make the same
5 determinations as are required in the case of an original
6 operations permit, except that the Secretaries may estab-
7 lish joint rules regarding the extent to which requirements
8 for original permits under this section shall apply to appli-
9 cations to modify a permit based on whether such modi-
10 fications are deemed significant or minor. Such rules shall
11 provide that all requirements applicable to a new permit
12 shall apply to any extension of the area covered by the
13 permit (except for incidental boundary revisions).

14 (2) The Secretary, or for National Forest System
15 lands the Secretary of Agriculture, may, at any time, re-
16 quire reasonable modification to any operations plan or
17 reclamation plan upon a determination that the require-
18 ments of this title cannot be met if the plan is followed
19 as approved. Such determination shall be based on a writ-
20 ten finding and subject to notice and hearing requirements
21 established by the Secretary concerned.

22 (g) TEMPORARY CESSATION OF OPERATIONS.—(1)
23 No operator conducting mineral activities under an oper-
24 ations permit in effect under this subtitle may temporarily
25 cease mineral activities for a period of 180 days or more

1 under an operations permit unless the Secretary concerned
2 has approved such temporary cessation or unless the tem-
3 porary cessation is permitted under the original permit.
4 Any operator temporarily ceasing mineral activities for a
5 period of 180 days or more under an existing operations
6 permit shall submit, before the expiration of such 180-day
7 period, a complete application for temporary cessation of
8 operations to the Secretary concerned for approval unless
9 the temporary cessation is permitted under the original
10 permit.

11 (2) An application for approval of temporary ces-
12 sation of operations shall include such provisions as pre-
13 scribed by the Secretary concerned, including but not lim-
14 ited to the steps that shall be taken during the cessation
15 of operations period to minimize impacts on the environ-
16 ment. After receipt of a complete application for tem-
17 porary cessation of operations such Secretary shall con-
18 duct an inspection of the area for which temporary ces-
19 sation of operations has been requested.

20 (3) To approve an application for temporary ces-
21 sation of operations, the Secretary concerned shall make
22 each of the following determinations:

23 (A) A determination that the methods for se-
24 curing surface facilities and restricting access to the
25 permit area, or relevant portions thereof, will effec-

1 tively ensure against hazards to the health and safe-
2 ty of the public and fish and wildlife.

3 (B) A determination that reclamation is in com-
4 pliance with the approved reclamation plan, except
5 in those areas specifically designated in the applica-
6 tion for temporary cessation of operations for which
7 a delay in meeting such standards is necessary to fa-
8 cilitate the resumption of operations.

9 (C) A determination that the amount of finan-
10 cial assurance filed with the permit application is
11 sufficient to assure completion of the reclamation ac-
12 tivities identified in the approved reclamation plan in
13 the event of forfeiture.

14 (D) A determination that any outstanding no-
15 tices of violation and cessation orders incurred in
16 connection with the plan for which temporary ces-
17 sation is being requested are either stayed pursuant
18 to an administrative or judicial appeal proceeding or
19 are in the process of being abated to the satisfaction
20 of the Secretary concerned.

21 (h) PERMIT REVIEWS.—The Secretary, or for Na-
22 tional Forest System lands the Secretary of Agriculture,
23 shall review each permit issued under this section every
24 3 years during the term of such permit and, based upon
25 a written finding, such Secretary may require the operator

1 to take such actions as the Secretary deems necessary to
2 assure that mineral activities conform to the permit, in-
3 cluding adjustment of financial assurance requirements.

4 (i) FEES.—Each application for a permit pursuant
5 to this section shall be accompanied by a fee payable to
6 the Secretary of the Interior in such amount as may be
7 established by such Secretary. Such amount shall be equal
8 to the actual or anticipated cost to the Secretary, or for
9 National Forest System lands the Secretary of Agri-
10 culture, of reviewing, administering, and enforcing such
11 permit, as determined by the Secretary of the Interior. All
12 moneys received under this subsection shall be deposited
13 in the Abandoned Locatable Minerals Mine Reclamation
14 Fund established under subtitle C of this title.

15 (j) TRANSFER, ASSIGNMENT, OR SALE OF RIGHTS.—
16 (1) No transfer, assignment, or sale of rights granted by
17 a permit under this section shall be made without the prior
18 written approval of the Secretary, or for National Forest
19 System lands the Secretary of Agriculture.

20 (2) The Secretary, or for National Forest System
21 lands the Secretary of Agriculture, may allow a person
22 holding a permit to transfer, assign, or sell rights under
23 the permit to a successor, if such Secretary finds, in writ-
24 ing, that the successor—

1 (A) is eligible to receive a permit in accordance
2 with section 215;

3 (B) has submitted evidence of financial assur-
4 ance satisfactory under section 216; and

5 (C) meets any other requirements specified by
6 such Secretary.

7 (3) The successor in interest shall assume the liability
8 and reclamation responsibilities established by the existing
9 permit and shall conduct the mineral activities in full com-
10 pliance with this title, and the terms and conditions of
11 the permit as in effect at the time of transfer, assignment,
12 or sale.

13 (4) Each application for approval of a permit trans-
14 fer, assignment, or sale pursuant to this subsection shall
15 be accompanied by a fee payable to the Secretary of the
16 Interior in such amount as may be established by such
17 Secretary. Such amount shall be equal to the actual or
18 anticipated cost to the Secretary or the Secretary of Agri-
19 culture of reviewing and approving or disapproving such
20 transfer, assignment, or sale, as determined by the Sec-
21 retary of the Interior. All moneys received under this sub-
22 section shall be deposited in the Abandoned Locatable
23 Minerals Mine Reclamation Fund established under sub-
24 title C of this title.

1 **SEC. 215. PERSONS INELIGIBLE FOR PERMITS.**

2 (a) CURRENT VIOLATIONS.—Unless corrective action
3 has been taken in accordance with subsection (c), no per-
4 mit under this subtitle shall be issued or transferred to
5 an applicant if the applicant or any agent of the applicant,
6 the operator (if different than the applicant) of the claim
7 concerned, any claim holder (if different than the appli-
8 cant) of the claim concerned, or any affiliate or officer
9 or director of the applicant is currently in violation of any
10 of the following:

11 (1) A provision of this title or any regulation
12 under this title.

13 (2) An applicable toxic substance, solid waste,
14 air, water quality, or fish and wildlife conservation
15 law or regulation at any site where mining,
16 beneficiation, or processing activities are occurring
17 or have occurred.

18 (3) The Surface Mining Control and Reclama-
19 tion Act of 1977 (30 U.S.C. 1201 and following) or
20 any regulation implementing that Act at any site
21 where surface coal mining operations have occurred
22 or are occurring.

23 (b) SUSPENSION.—The Secretary, or for National
24 Forest System lands the Secretary of Agriculture, shall
25 suspend an exploration permit or an operations permit,
26 in whole or in part, if such Secretary determines that any

1 of the entities described in subsection (a) were in violation
2 of any requirement listed in subsection (a) at the time the
3 permit was issued.

4 (c) CORRECTION.—(1) The Secretary, or for National
5 Forest System lands the Secretary of Agriculture, may
6 issue or reinstate a permit under this subtitle if the appli-
7 cant submits proof that the violation referred to in sub-
8 section (a) or (b) has been corrected or is in the process
9 of being corrected to the satisfaction of such Secretary or
10 if the applicant submits proof that the violator has filed
11 and is presently pursuing, a direct administrative or judi-
12 cial appeal to contest the existence of the violation. For
13 purposes of this section, an appeal of any applicant's rela-
14 tionship to an affiliate shall not constitute a direct admin-
15 istrative or judicial appeal to contest the existence of the
16 violation.

17 (2) Any permit which is issued or reinstated based
18 upon proof submitted under this subsection shall be condi-
19 tionally approved or conditionally reinstated, as the case
20 may be. If the violation is not successfully abated or the
21 violation is upheld on appeal, the permit shall be sus-
22 pended or revoked.

23 (d) PATTERN OF WILLFUL VIOLATIONS.—No permit
24 under this title may be issued to any applicant if there
25 is a demonstrated pattern of willful violations of the sur-

1 face management requirements of this title by the appli-
2 cant, any affiliate of the applicant, or the operator or
3 claim holder if different than the applicant, and such vio-
4 lations are of such nature and duration, and with such
5 resulting irreparable damage to the environment, as to
6 clearly indicate an intent not to comply with the surface
7 management requirements.

8 **SEC. 216. FINANCIAL ASSURANCE.**

9 (a) FINANCIAL ASSURANCE REQUIRED.—(1) Before
10 any permit is issued under this subtitle, the operator shall
11 file with the Secretary, or for National Forest System
12 lands the Secretary of Agriculture, evidence of financial
13 assurance payable to the United States on a form pre-
14 scribed and furnished by such Secretary and conditional
15 upon faithful performance of such permit and all other
16 requirements of this title. The financial assurance shall
17 be provided in the form of a surety bond, trust fund, let-
18 ters of credits, government securities, cash or equivalent.

19 (2) The financial assurance shall cover all lands with-
20 in the initial permit area and shall be extended to cover
21 all lands added pursuant to any permit modification made
22 under section 213(f), section 214(f), or section 214(h).
23 The financial assurance shall cover all lands to be affected
24 by mineral activities as described and depicted in the per-
25 mit application.

1 (b) AMOUNT.—The amount of the financial assur-
2 ance required under this section shall be sufficient to as-
3 sure the completion of reclamation satisfying the require-
4 ments of this title if the work were to be performed by
5 the Secretary concerned in the event of forfeiture. The cal-
6 culation of such amount shall take into account the max-
7 imum level of financial exposure which shall arise during
8 the mineral activity.

9 (c) DURATION.—The financial assurance required
10 under this section shall be held for the duration of the
11 mineral activities and for an additional period to cover the
12 operator's responsibility for revegetation as specified
13 under subsection 217(b)(6)(B), and effluent treatment as
14 specified in subsection (g).

15 (d) ADJUSTMENTS.—The amount of the financial as-
16 surance and the terms of the acceptance of the assurance
17 may be adjusted by the Secretary concerned from time to
18 time as the area requiring coverage is increased or de-
19 creased, or where the costs of reclamation or treatment
20 change, or pursuant to section 214(h), but the financial
21 assurance must otherwise be in compliance with this sec-
22 tion. The Secretary concerned shall specify periodic times,
23 or set a schedule, for reevaluating or adjusting the amount
24 of financial assurance.

1 (e) RELEASE.—Upon request, and after notice and
2 opportunity for public comment, and after inspection by
3 the Secretary, or for National Forest System lands the
4 Secretary of Agriculture, such Secretary may, after con-
5 sultation with the Administrator of the Environmental
6 Protection Agency, release in whole or in part the financial
7 assurance required under this section if the Secretary
8 makes both of the following determinations:

9 (1) A determination that reclamation covered
10 by the financial assurance has been accomplished as
11 required by this title.

12 (2) A determination that the operator has de-
13 clared that the terms and conditions of any other
14 applicable Federal requirements, and State require-
15 ments applicable pursuant to cooperative agreements
16 under section 218, have been fulfilled.

17 (f) RELEASE SCHEDULE.—The release referred to in
18 subsection (e) shall be according to the following schedule:

19 (1) After the operator has completed any re-
20 quired backfilling, regrading, and drainage control of
21 an area subject to mineral activities and covered by
22 the financial assurance, and has commenced revege-
23 tation on the regraded areas subject to mineral ac-
24 tivities in accordance with the approved plan, that
25 portion of the total financial assurance secured for

1 the area subject to mineral activities attributable to
2 the completed activities may be released.

3 (2) After the operator has completed success-
4 fully all remaining mineral activities and reclamation
5 activities and all requirements of the operations plan
6 and the reclamation plan (including the provisions of
7 section 217(b)(6)(B) relating to revegetation and ef-
8 fluent treatment required by subsection (g)), and all
9 other requirements of this title have in fact been
10 fully met, the remaining portion of the financial as-
11 surance may be released.

12 During the period following release of the financial assur-
13 ance as specified in paragraph (1), until the remaining
14 portion of the financial assurance is released as provided
15 in paragraph (2), the operator shall be required to comply
16 with the permit issued under this subtitle.

17 (g) EFFLUENT.—Where any discharge resulting from
18 the mineral activities requires treatment in order to meet
19 the applicable effluent limitations, the financial assurance
20 shall include the estimated cost of maintaining such treat-
21 ment for the projected period that will be needed after
22 the cessation of mineral activities. The portion of the fi-
23 nancial assurance attributable to such estimated cost of
24 treatment shall not be released until the discharge has
25 ceased, or, if the discharge continues, until the operator

1 has met all applicable effluent limitations and water qual-
2 ity standards for 5 full years without treatment.

3 (h) ENVIRONMENTAL HAZARDS.—If the Secretary,
4 or for National Forest System lands the Secretary of Agri-
5 culture, determines, after final release of financial assur-
6 ance, that an environmental hazard resulting from the
7 mineral activities exists, or the terms and conditions of
8 the operations permit of this title were not fulfilled in fact
9 at the time of release, such Secretary shall issue an order
10 under section 247 requiring the claimholder or operator
11 (or any person who controls the claimholder or operator)
12 to correct the condition.

13 **SEC. 217. RECLAMATION.**

14 (a) GENERAL RULE.—(1) Except as provided under
15 paragraphs (5) and (7) of subsection (b), the operator
16 shall restore lands subject to mineral activities carried out
17 under a permit issued under this subtitle to a condition
18 capable of supporting—

19 (A) the uses, including fish and wildlife habitat
20 uses, which such lands were capable of supporting
21 prior to surface disturbance by the operator, or

22 (B) other beneficial uses which conform to ap-
23 plicable land use plans as determined by the Sec-
24 retary or for National Forest System lands, the Sec-
25 retary of Agriculture.

1 (2) Reclamation shall proceed as contemporaneously
2 as practicable with the conduct of mineral activities and
3 shall use, with respect to this subsection and subsection
4 (b), the best technology currently available. To the extent
5 practicable, reclamation shall be conducted in a manner
6 that does not increase the costs or likelihood of a removal
7 or remedial action under section 101 of the Comprehensive
8 Environmental Response, Compensation and Liability Act
9 of 1980 or a corrective action under the Solid Waste Dis-
10 posal Act.

11 (b) RECLAMATION STANDARDS.—Mineral activities
12 shall be conducted in accordance with the following stand-
13 ards; as well as any additional standards the Secretaries
14 may jointly promulgate under section 211 and subsection
15 (a) of this section to address specific environmental im-
16 pacts of selected methods of mining:

17 (1) SOILS.—(A) Soils, including topsoils and
18 subsoils removed from lands subject to mineral ac-
19 tivities shall be segregated from waste material and
20 protected for later use in reclamation. If such soil is
21 not replaced on a backfill area within a time-frame
22 short enough to avoid deterioration of the topsoil,
23 vegetative cover or other means shall be used so that
24 the soil is preserved from wind and water erosion,
25 remains free of contamination by acid or other toxic

1 material, and is in a usable condition for sustaining
2 vegetation when restored during reclamation.

3 (B) In the event the topsoil from lands subject
4 to mineral activities is of insufficient quantity or of
5 inferior quality for sustaining vegetation, and other
6 suitable growth media removed from the lands sub-
7 ject to the mineral activities are available that shall
8 support vegetation, the best available growth me-
9 dium shall be removed, segregated and preserved in
10 a like manner as under subparagraph (A) for sus-
11 taining vegetation when restored during reclamation.

12 (C) In the event the soil (other than topsoil)
13 from lands subject to mineral activities is of insuffi-
14 cient quantity or of inferior quality for sustaining
15 vegetation, and other suitable growth media removed
16 from the lands subject to the mineral activities are
17 available that support revegetation, these substitute
18 materials shall be removed, segregated or preserved
19 in a like manner as under subparagraph (A) for
20 later use in reclamation.

21 (D) Mineral activities shall be conducted to pre-
22 vent contamination of soils to the extent possible
23 using the best technology currently available. If con-
24 tamination occurs, the operator shall decontaminate

1 or dispose of any contaminated soils which have re-
2 sulted from the mineral activities.

3 (2) STABILIZATION.—All surface areas subject
4 to mineral activities, including segregated soils or
5 other growth medium, waste material piles, ore piles,
6 subgrade ore piles, and open or partially backfilled
7 mine pits which meet the requirements of paragraph
8 (5) shall be stabilized and protected during mineral
9 activities so as to effectively control fugitive dust
10 and erosion and otherwise comply with toxic sub-
11 stance, solid waste, air and water pollution control
12 laws and other environmental laws.

13 (3) SEDIMENTS, EROSION, AND DRAINAGE.—
14 Facilities such as but not limited to basins, ditches,
15 stream bank stabilization, diversions or other meas-
16 ures, shall be designed, constructed and maintained
17 where necessary to control sediments, erosion, and
18 drainage of the area subject to mineral activities.

19 (4) HYDROLOGIC BALANCE.—(A) Mineral ac-
20 tivities shall be conducted to minimize disturbances
21 to the prevailing hydrologic balance of the permit
22 area and surrounding watershed existing prior to the
23 mineral activities in the permit area and in the sur-
24 rounding watershed, as established by the baseline
25 information provided pursuant to section

1 214(b)(10). Hydrologic balance includes the quality
2 and quantity of ground water and surface water and
3 their interrelationships, including recharge and dis-
4 charge rates. In all cases, the operator shall comply
5 with Federal and State laws related to the quality
6 and quantity of such waters.

7 (B) Mineral activities shall be conducted using
8 the technology standard referred to in subsection
9 (a)(2) to prevent where possible the formation of
10 acidic, toxic or other contaminated water. Where the
11 formation of acidic, toxic or other contaminated
12 water occurs despite the use of such technology
13 standard, mineral activities shall be conducted using
14 such technology so as to minimize the formation of
15 acidic, toxic or other contaminated water.

16 (C) Mineral activities shall prevent any con-
17 tamination of surface and ground water with acid or
18 other toxic mine pollutants and shall prevent or re-
19 move water from contact with acid or toxic pro-
20 ducing deposits.

21 (D) Reclamation shall restore approximate hy-
22 drologic balance existing prior to the mineral activi-
23 ties.

24 (E) Where the quality of surface water or
25 ground water used for domestic, municipal, agricul-

1 tural, or industrial purposes is adversely impacted
2 by mineral activities, such water shall be treated, or
3 replaced with the same quantity and approximate
4 quality of water, comparable to premining conditions
5 as established in paragraph (10) of section 214(b).

6 (5) SURFACE RESTORATION.—(A) The surface
7 area disturbed by mineral activities shall be shaped,
8 graded, and contoured to its natural topography.
9 Backfilling of an open pit mine shall be required
10 only if the Secretary, or for National Forest System
11 lands the Secretary of Agriculture, finds that such
12 open pit or partially backfilled, graded, or contoured
13 pit would pose a significant threat to the public
14 health safety or have a significant adverse effect on
15 the environment in terms of surface water or
16 groundwater pollution.

17 (B) In instances where complete backfilling of
18 an open pit is not required, the pit shall be graded
19 to blend with the surrounding topography as much
20 as practicable and revegetated in accordance with
21 paragraph (6).

22 (6) VEGETATION.—(A) The area subject to
23 mineral activities shall be vegetated in order to es-
24 tablish a diverse, effective and permanent vegetative
25 cover of the same seasonal variety native to the area

1 subject to mineral activities, capable of self-regen-
2 eration and plant succession and at least equal in
3 extent of cover to the natural revegetation of the
4 surrounding area, except that introduced species
5 may be used at the discretion of the Secretary, or
6 for National Forest System lands the Secretary of
7 Agriculture, in consultation with the Director, Fish
8 and Wildlife Service, if such introduction of such
9 species is necessary as an interim step in, and is
10 part of a program to restore a native plant commu-
11 nity. In such instances where the complete backfill
12 of an open mine pit is not required under paragraph
13 (5), such Secretary shall prescribe such vegetation
14 requirements as conform to the applicable land use
15 plan.

16 (B) In order to insure compliance with subpara-
17 graph (A), the period for determining successful re-
18 vegetation shall be for a period of 5 full years after
19 the last year of augmented seeding, fertilizing, irri-
20 gation or other work, except that such period shall
21 be 10 full years where the annual average precipita-
22 tion is 26 inches or less. The period may be for a
23 longer time at the discretion of the Secretary con-
24 cerned where the average precipitation is 26 inches
25 or less.

1 (7) EXCESS WASTE.—(A) Waste material in ex-
2 cess of that required to comply with paragraph (5)
3 shall be transported and placed in approved areas,
4 in a controlled manner in such a way so as to assure
5 long-term mass stability, to prevent mass movement
6 and to facilitate reclamation. In addition to the
7 measures described under paragraph (3), internal
8 drainage systems shall be employed, as may be re-
9 quired, to control erosion and drainage. The design
10 of such excess waste material piles shall be certified
11 by a qualified professional engineer.

12 (B) Excess waste material piles shall be graded
13 and contoured to blend with the surrounding topog-
14 raphy as much as practicable and revegetated in ac-
15 cordance with paragraph (6).

16 (8) SEALING.—All drill holes, and openings on
17 the surface associated with underground mineral ac-
18 tivities, shall be backfilled, sealed or otherwise con-
19 trolled when no longer needed for the conduct of
20 mineral activities to ensure protection of the public
21 and the environment, and management of fish and
22 wildlife and livestock.

23 (9) STRUCTURES.—All buildings, structures or
24 equipment constructed, used or improved during
25 mineral activities shall be removed, unless the Sec-

1 retary concerned in consultation with the affected
2 land managing agency, determines that use of the
3 buildings, structures or equipment would be con-
4 sistent with subsection (a) or for environmental
5 monitoring and the Secretary concerned takes own-
6 ership of such structures.

7 (10) FISH AND WILDLIFE.—Fish and wildlife
8 habitat in areas subject to mineral activities shall be
9 restored in a manner commensurate with or superior
10 to habitat conditions which existed prior to the min-
11 eral activities, including such conditions as may be
12 prescribed by the Director, Fish and Wildlife
13 Service.

14 (c) APPLICATION OF RECLAMATION STANDARDS TO
15 EXPLORATION.—The provisions of this section shall apply
16 to mineral exploration pursuant to a permit under this
17 title, except that paragraphs (5) and (6) of subsection (b)
18 shall not apply during any interim periods between com-
19 pletion of the approved exploration and the commence-
20 ment of further mineral activities, not to exceed 2 years,
21 if the operator maintains a sufficient financial assurance
22 to reclaim the disturbed surface should further mineral ac-
23 tivities not be authorized. The Secretary concerned shall
24 prescribe standards for interim stabilization and revegeta-
25 tion.

1 (d) SPECIAL RULE.—A modified reclamation plan
2 shall not be required for mineral activities related to re-
3 clamation where a mining claim is forfeited, relinquished
4 or lapsed, or a plan is revoked or suspended or has expired
5 in any such case. Reclamation activities shall continue
6 only as approved by the Secretary, or for National Forest
7 System lands the Secretary of Agriculture, pursuant to the
8 previously approved reclamation plan.

9 (e) DEFINITIONS.—As used in this section:

10 (1) The term “best technology currently avail-
11 able” means equipment, devices, systems, methods,
12 or techniques which have demonstrated engineering
13 and economic feasibility, success and practicality.
14 Within the constraints of the surface management
15 requirements of this title, the Secretary, or for Na-
16 tional Forest System lands the Secretary of Agri-
17 culture, shall have the discretion to determine the
18 best technology currently available on a case-by-case
19 basis.

20 (2) The term “waste material” means the mate-
21 rial resulting from mineral activities involving ex-
22 traction, beneficiation and processing, including but
23 not limited to tailings, and such material resulting
24 from mineral activities involving processing, to the
25 extent such material is not subject to subtitle III of

1 the Solid Waste Disposal Act or the Uranium Mill
2 Tailings Radiation Control Act.

3 (3) The term “ore piles” means ore stockpiled
4 for beneficiation prior to the completion of mineral
5 activities.

6 (4) The term “subgrade ore” means ore that is
7 too low in grade to be processed at the time of ex-
8 traction but which could reasonably be processed in
9 the foreseeable future.

10 (5) The term “soil” means the earthy or sandy
11 layer, ranging in thickness from a few inches to sev-
12 eral feet, composed of finely divided rock debris, of
13 whatever origin, mixed with decomposing vegetal and
14 animal matter, which forms the surface of the
15 ground and in which plants grow or may grow.

16 **SEC. 218. STATE LAW AND REGULATION.**

17 (a) STATE LAW.—(1) Any reclamation standard or
18 requirement in State law or regulation that meets or ex-
19 ceeds the requirements of section 217 shall not be con-
20 strued to be inconsistent with any such standard.

21 (2) Any bonding standard or requirement in State
22 law or regulation that meets or exceeds the requirements
23 of section 216 shall not be construed to be inconsistent
24 with such requirements.

1 (3) Any inspection standard or requirement in State
2 law or regulation that meets or exceeds the requirements
3 of section 244 shall not be construed to be inconsistent
4 with such requirements.

5 (b) APPLICABILITY OF OTHER STATE REQUIRE-
6 MENTS.—(1) Nothing in this title shall be construed as
7 affecting any toxic substance, solid waste, or air or water
8 quality, standard or requirement of any State law or regu-
9 lation, or of tribal law or regulation, which may be applica-
10 ble to mineral activities on lands subject to this title.

11 (2) Nothing in this title shall be construed as affect-
12 ing in any way the right of any person to enforce or pro-
13 tect, under applicable law, such person's interest in water
14 resources affected by mineral activities on lands subject
15 to this title.

16 (c) COOPERATIVE AGREEMENTS.—(1) Any State
17 may enter into a cooperative agreement with the Sec-
18 retary, or for National Forest System lands the Secretary
19 of Agriculture, for the purposes of such Secretary applying
20 such standards and requirements referred to in subsection
21 (a) and subsection (b) to mineral activities or reclamation
22 on lands subject to this title.

23 (2) In such instances where the proposed mineral ac-
24 tivities would affect lands not subject to this title in addi-
25 tion to lands subject to this title, in order to approve a

1 plan of operations the Secretary concerned shall enter into
2 a cooperative agreement with the State that sets forth a
3 common regulatory framework consistent with the surface
4 management requirements of this title for the purposes
5 of such plan of operations.

6 (3) The Secretary concerned shall not enter into a
7 cooperative agreement with any State under this section
8 until after notice in the Federal Register and opportunity
9 for public comment.

10 (d) PRIOR AGREEMENTS.—Any cooperative agree-
11 ment or such other understanding between the Secretary
12 concerned and any State, or political subdivision thereof,
13 relating to the surface management of mineral activities
14 on lands subject to this title that was in existence on the
15 date of enactment of this Act may only continue in force
16 until the effective date of this title, after which time the
17 terms and conditions of any such agreement or under-
18 standing shall only be applicable to plans of operations
19 approved by the Secretary concerned prior to the effective
20 date of this title.

21 (e) DELEGATION.—The Secretary, or for National
22 Forest System lands the Secretary of Agriculture, shall
23 not delegate to any State, or political subdivision thereof,
24 the Secretary's authorities, duties and obligations under

1 this title, including with respect to any cooperative agree-
2 ments entered into under this section.

3 (f) PREEMPTION.—Subject to section 252(b), the re-
4 quirements of this title shall preempt any conflicting re-
5 quirements of any State, or political subdivision thereof
6 relating to mineral activities for locatable minerals.

7 **SEC. 219. UNSUITABILITY REVIEW.**

8 (a) AUTHORITY.—(1) As provided for in this section,
9 the Secretary of the Interior, in carrying out the Sec-
10 retary's responsibilities under the Federal Land Policy
11 and Management Act of 1976, and the Secretary of Agri-
12 culture, in carrying out the Secretary's responsibilities
13 under the Forest and Rangeland Renewable Resources
14 Planning Act of 1974, as amended by the National Forest
15 Management Act of 1976, shall each review lands that are
16 subject to this title in order to determine, in accordance
17 with the provisions of subsection (b), whether there are
18 any areas on such lands which are either unsuitable for
19 all types of mineral activities or conditionally suitable for
20 certain types of mineral activities.

21 (2) Any determination made in accordance with sub-
22 section (b) shall be immediately effective. Such determina-
23 tion shall be incorporated into the applicable land use plan
24 when such plan is adopted, revised, or significantly amend-
25 ed pursuant to provisions of law other than this title.

1 (3) In any instance where a determination is made
2 in accordance with subsection (b) that an area is condi-
3 tionally suitable for all or certain mineral activities, the
4 Secretary concerned shall take appropriate steps to notify
5 the public that any operations permit application relevant
6 to that area shall be conditioned accordingly.

7 (b) SPECIAL CHARACTERISTICS.—(1) The Secretary,
8 or for National Forest System lands the Secretary of Agri-
9 culture, shall determine that an area open to location is
10 unsuitable for all or certain mineral activities if such Sec-
11 retary finds that such activities would result in significant,
12 permanent and irreparable damage to special characteris-
13 ties as described in paragraph (3) which cannot be pre-
14 vented by the imposition of conditions in the operations
15 permit required under section 214 (b).

16 (2) The Secretary, or for National Forest System
17 lands, the Secretary of Agriculture, may determine, after
18 notice and opportunity for public comment, that an area
19 is conditionally suitable for all or certain types of mineral
20 activities, if the Secretary concerned determines that any
21 of the special characteristics of such area, as listed in
22 paragraph (3), require protection from the effects of min-
23 eral activities.

1 (3) Any of the following shall be considered special
2 characteristics of an area which contains lands or interests
3 in lands open to location under this title:

4 (A) The existence of significant water quality or
5 supplies in or associated with such area, such as
6 aquifers and aquifer recharge areas.

7 (B) The presence in such area of publicly
8 owned places which are listed on or are determined
9 eligible for listing on the National Register of His-
10 toric Places.

11 (C) The designation of all or any portion of
12 such area or any adjacent area as a National Con-
13 servation System unit.

14 (D) The designation of all or any portion of
15 such area or any adjacent area as critical habitat for
16 threatened or endangered species under the Endan-
17 gered Species Act of 1973.

18 (E) The designation of all or any portion of
19 such area as Class I under section 162 of the Clean
20 Air Act (42 U.S.C. 7401).

21 (F) The presence of such other resource values
22 as the Secretary, or for National Forest System
23 lands, the Secretary of Agriculture, may, by joint
24 rule, specify based upon field testing that verifies
25 such criteria.

1 (c) PERMIT APPLICATION PRIOR TO REVIEW.—(1) If
2 an area covered by an application for a permit required
3 under section 214, has not been reviewed pursuant to sub-
4 section (a) prior to submission of the application, the Sec-
5 retary, or for National Forest System lands, the Secretary
6 of Agriculture, shall review the area that would be affected
7 by the proposed mineral activities to determine, according
8 to the provisions of subsection (b), whether the area is
9 unsuitable for all types of mineral activities or condi-
10 tionally suitable for certain types of mineral activities.
11 Such review and determination shall precede the final de-
12 cision on the permit application.

13 (2) The Secretary concerned shall use such review in
14 the next revision or significant amendment to the applica-
15 ble land use plan to the extent necessary to reflect the
16 unsuitability or conditional suitability of such lands.

17 (d) EFFECT OF DETERMINATION.—(1) In any in-
18 stance in which a determination of unsuitability is made
19 for any area in accordance with subsection (b)(1), all min-
20 eral activities shall be prohibited in such area, and the
21 Secretary shall (with the consent of the Secretary of Agri-
22 culture for National Forest System lands) withdraw such
23 area pursuant to section 204 of the Federal Land Policy
24 and Management Act of 1976 (43 U.S.C. 1714). The Sec-
25 retary's determination under this section shall constitute

1 the documentation required to be provided under section
2 204(c)(12) of the Federal Land Policy and Management
3 Act of 1976 (43 U.S.C. 1714).

4 (2) In any instance where the Secretary, or for Na-
5 tional Forest System lands, the Secretary of Agriculture,
6 determines in accordance with subsection (b)(2) that, by
7 reason of any of the special characteristics listed in sub-
8 section (b)(3), an area is conditionally suitable for all or
9 certain mineral activities, the Secretary concerned shall in-
10 clude such additional conditions in each permit for mineral
11 activities in such area as necessary to limit or control min-
12 eral activities to the extent necessary to protect the special
13 characteristics concerned.

14 (3) Nothing in this section shall be construed as af-
15 fecting lands where mineral activities were being con-
16 ducted on the date of enactment of this Act under ap-
17 proved plans of operations or under notice (as provided
18 for in the regulations of the Secretary of the Interior in
19 effect prior to the date of enactment of this Act relating
20 to operations that cause a cumulative disturbance of 5
21 acres or less).

22 (4) Nothing in this section shall be construed as pro-
23 hibiting mineral activities at a specific site, where substan-
24 tial legal and financial commitments in such mineral ac-
25 tivities were in existence on the date of enactment of this

1 Act, but nothing in this section shall be construed as pro-
2 hibiting either Secretary from regulating such activities in
3 accordance with other authority of law. As used in this
4 paragraph, the term “substantial legal and financial com-
5 mitments” means, with respect to a specific site, signifi-
6 cant investments, expenditures, or undertakings that have
7 been made to explore or develop any mining claim or and
8 millsite located at such site under the general mining laws
9 or converted under this title, such as but not limited to:
10 contracts for minerals produced; construction; contracts
11 for the construction; or commitment to raise capital for
12 the construction of processing, beneficiation, extraction, or
13 refining facilities, or transportation or utility infrastruc-
14 ture; exploration activities conducted to delineate proven
15 or probable ore reserves; acquisition of mining claims (but
16 only if such acquisition is part of other significant invest-
17 ments specified in this paragraph); and such other costs
18 or expenditures related to mineral activities at such site
19 as are similar to the foregoing itemized costs or expendi-
20 tures and as may be specified by the Secretaries by joint
21 rule.

22 (e) WITHDRAWAL REVIEW.—(1) In carrying out the
23 responsibilities referred to in subsection (a), the Secretary
24 or, for National Forest System lands, the Secretary of Ag-
25 riculture, shall review all administrative withdrawals of

1 land under such Secretary's jurisdiction (other than wil-
2 derness study areas) to determine whether the revocation
3 or modification of such withdrawal for the purpose of al-
4 lowing such lands to be opened to the location of mining
5 claims under this title is appropriate as a result of either
6 of the following:

7 (A) The imposition of any conditions imposed
8 as part of the land use planning process or the im-
9 position of any conditions as a result to the review
10 process under subsection (a).

11 (B) The limitation of section 255 (relating to
12 limitation on patent issuance).

13 (2) The Secretary concerned shall publish the review
14 referred to in paragraph (1) in the Federal Register no
15 later than 1 year after the date of enactment of this Act.
16 After providing notice and opportunity for comment, the
17 Secretary may issue a revocation or modification of such
18 administrative withdrawals as he deems appropriate by
19 reason of the criteria listed in subparagraph (A) or (B)
20 of paragraph (1).

21 (f) **EXPLORATION REVIEWS.**—In conjunction with re-
22 view of a permit application submitted pursuant to section
23 213, and upon request of the applicant, the Secretary, or
24 for National Forest System lands, the Secretary of Agri-
25 culture, shall review the area proposed to be affected by

1 mineral activities to determine whether the area would be
2 unsuitable or conditionally suitable for all or certain min-
3 eral activities.

4 **SEC. 220. CERTAIN MINERAL ACTIVITIES COVERED BY**
5 **OTHER LAW.**

6 This subtitle shall not apply to any mineral activities
7 which are subject to the Stock Raising Homestead Act.

8 **Subtitle C—Abandoned Locatable**
9 **Minerals Mine Reclamation Fund**

10 **SEC. 231. ABANDONED LOCATABLE MINERALS MINE REC-**
11 **LAMATION.**

12 (a) ESTABLISHMENT.—(1) There is established on
13 the books of the Treasury of the United States a trust
14 fund to be known as the Abandoned Locatable Minerals
15 Mine Reclamation Fund (hereinafter in this subtitle re-
16 ferred to as the “Fund”). The Fund shall be administered
17 by the Secretary acting through the Director of the Office
18 of Surface Mining Reclamation and Enforcement.

19 (2) The Secretary shall notify the Secretary of the
20 Treasury as to what portion of the Fund is not, in the
21 Secretary’s judgment, required to meet current with-
22 draws. The Secretary of the Treasury shall invest such
23 portion of the Fund in public debt securities with matu-
24 rities suitable for the needs of such Fund and bearing in-
25 terest at rates determined by the Secretary of the Treas-

1 ury, taking into consideration current market yields on
2 outstanding marketplace obligations of the United States
3 of comparable maturities. The income on such investments
4 shall be credited to, and form a part of, the Fund.

5 (b) AMOUNTS.—The following amounts shall be cred-
6 ited to the Fund:

7 (1) All moneys received from the collection of
8 claim maintenance fees under section 207.

9 (2) All moneys collected pursuant to section
10 208 (relating to failure to comply), section 247 (re-
11 lating to enforcement) and section 245 (relating to
12 citizens suits).

13 (3) All permit fees and transfer fees received
14 under sections 213 and 214.

15 (4) All donations by persons, corporations, as-
16 sociations, and foundations for the purposes of this
17 subtitle.

18 (5) All amounts referred to in section 236 (re-
19 lating to royalties and penalties for underreporting).

20 (6) All other receipts from fees, royalties, pen-
21 alties and other sources collected under this title.

22 (c) ADMINISTRATIVE COSTS.—(1) In calculating the
23 amount to be deposited in the Fund during any fiscal year
24 under subsection (b), the enacted appropriation of the De-
25 partment of the Interior during the preceding year attrib-

1 utable to administering this title shall be deducted from
2 the total of the amounts listed in subsection (b) prior to
3 the transfer of such amounts to the Fund.

4 (2) The amount deducted under paragraph (1) of this
5 section shall be available to the Secretary, subject to ap-
6 propriation, for payment of the costs of administering this
7 title.

8 **SEC. 232. USE AND OBJECTIVES OF THE FUND.**

9 (a) IN GENERAL.—The Secretary is authorized, sub-
10 ject to appropriations, to use moneys in the Fund for the
11 reclamation and restoration of land and water resources
12 adversely affected by past mineral activities on lands the
13 legal and beneficial title to which resides in the United
14 States, land within the exterior boundary of any national
15 forest system unit, or other lands described in subsection
16 (d) or section 233, including any of the following:

17 (1) Prevention, abatement, treatment and con-
18 trol of water pollution created by abandoned mine
19 drainage.

20 (2) Reclamation and restoration of abandoned
21 surface and underground mined areas.

22 (3) Reclamation and restoration of abandoned
23 milling and processing areas.

24 (4) Backfilling, sealing, or otherwise control-
25 ling, abandoned underground mine entries.

1 (5) Revegetation of land adversely affected by
2 past mineral activities to prevent erosion and sedi-
3 mentation and to enhance wildlife habitat.

4 (6) Control of surface subsidence due to aban-
5 doned underground mines.

6 Moneys in the Fund shall also be available for purposes
7 of compensation (and other payments) under section 263.

8 (b) PRIORITIES.—To the extent that moneys in the
9 fund are in excess of the amount of compensation (and
10 other payments) paid under section 263, expenditures of
11 moneys from the Fund shall reflect the following priorities
12 in the order stated:

13 (1) The protection of public health, safety, gen-
14 eral welfare and property from extreme danger from
15 the adverse effects of past mineral activities, espe-
16 cially as relates to surface water and groundwater
17 contaminates.

18 (2) The protection of public health, safety, and
19 general welfare from the adverse effects of past min-
20 eral activities.

21 (3) The restoration of land, water and fish and
22 wildlife resources previously degraded by the adverse
23 effects of past mineral activities.

24 (c) HABITAT.—Reclamation and restoration activities
25 under this subtitle, particularly those identified under sub-

1 section (a)(4), shall include appropriate mitigation meas-
2 ures to provide for the continuation of any established
3 habitat for wildlife in existence prior to the commencement
4 of such activities.

5 (d) OTHER AFFECTED LANDS.—Where mineral ex-
6 ploration, mining, beneficiation, processing, or reclamation
7 activities have been carried out with respect to any mineral
8 which would be a locatable mineral if the legal and bene-
9 ficial title to the mineral were in the United States, if such
10 activities directly affect lands managed by the Bureau of
11 Land Management as well as other lands and if the legal
12 and beneficial title to more than 50 percent of the affected
13 lands resides in the United States, the Secretary is author-
14 ized, subject to appropriations, to use moneys in the fund
15 for reclamation and restoration under subsection (a) for
16 all directly affected lands.

17 (e) RESPONSE OR REMOVAL ACTIONS.—Reclamation
18 and restoration activities under this subtitle which con-
19 stitute a removal or remedial action under section 101 of
20 the Comprehensive Environmental Response, Compensa-
21 tion and Liability Act of 1980, shall be conducted with
22 the concurrence of the Administrator of the Environ-
23 mental Protection Agency. The Secretary and the Admin-
24 istrator shall enter into a Memorandum of Understanding
25 to establish procedures for consultation, concurrence,

1 training, exchange of technical expertise and joint activi-
2 ties under the appropriate circumstances, which provide
3 assurances that reclamation or restoration activities under
4 this subtitle, to the extent practicable, shall not be con-
5 ducted in a manner that increases the costs or likelihood
6 of removal or remedial actions under the Comprehensive
7 Environmental Response, Compensation and Liability Act
8 of 1980, and which avoid oversight by multiple agencies
9 to the maximum extent practicable.

10 **SEC. 233. ELIGIBLE LANDS AND WATERS.**

11 (a) **ELIGIBILITY.**—Reclamation expenditures under
12 this subtitle may only be made with respect to Federal
13 lands or Indian lands or water resources that traverse or
14 are contiguous to Federal lands or Indian lands where
15 such lands or water resources have been affected by past
16 mineral activities, including any of the following:

17 (1) Lands and water resources which were used
18 for, or affected by, mineral activities and abandoned
19 or left in an inadequate reclamation status before
20 the effective date of this Act.

21 (2) Lands for which the Secretary makes a de-
22 termination that there is no continuing reclamation
23 responsibility of a claim holder, operator, or other
24 person who abandoned the site prior to completion

1 of required reclamation under State or other Federal
2 laws.

3 (3) Lands for which it can be established that
4 such lands do not contain locatable minerals which
5 could economically be extracted through the reproc-
6 essing or remining of such lands, unless such consid-
7 erations are in conflict with the priorities set forth
8 under paragraphs (1) and (2) of section 232(b).

9 (b) SPECIFIC SITES AND AREAS NOT ELIGIBLE.—
10 The provisions of section 411(d) of the Surface Mining
11 Control and Reclamation Act of 1977 shall apply to ex-
12 penditures made from the Fund established under this
13 subtitle.

14 (c) INVENTORY.—The Secretary shall prepare and
15 maintain an inventory of abandoned locatable minerals
16 mines on Federal lands and any abandoned mine on In-
17 dian lands which may be eligible for expenditures under
18 this subtitle.

19 **SEC. 234. FUND EXPENDITURES.**

20 Moneys available from the Fund may be expended for
21 the purposes specified in section 232 directly by the Direc-
22 tor of the Office of Surface Mining Reclamation and En-
23 forcement. The Director may also make such money avail-
24 able for such purposes to the Director of the Bureau of
25 Land Management, the Chief of the United States Forest

1 Service, the Director of the National Park Service, Direc-
2 tor of the United States Fish and Wildlife Service, to any
3 other agency of the United States, to an Indian tribe, or
4 to any public entity that volunteers to develop and imple-
5 ment, and that has the ability to carry out, all or a signifi-
6 cant portion of a reclamation program under this subtitle.

7 **SEC. 235. AUTHORIZATION OF APPROPRIATIONS.**

8 Amounts credited to the Fund are authorized to be
9 appropriated for the purpose of this subtitle without fiscal
10 year limitation.

11 **SEC. 236. ROYALTY.**

12 (a) **RESERVATION OF ROYALTY.**—Production of all
13 locatable minerals from any mining claim located or con-
14 verted under this title, or mineral concentrates or products
15 derived from locatable minerals from any mining claim lo-
16 cated or converted under this title, as the case may be,
17 shall be subject to a royalty of 8 percent of the net smelter
18 return from such production. The claimholder and any op-
19 erator to whom the claimholder has assigned the obliga-
20 tion to make royalty payments under the claim and any
21 person who controls such claimholder or operator shall be
22 jointly and severally liable for payment of such royalties.

23 (b) **DUTIES OF CLAIM HOLDERS, OPERATORS, AND**
24 **TRANSPORTERS.**—(1) A person—

1 (A) who is required to make any royalty pay-
2 ment under this section shall make such payments
3 to the United States at such times and in such man-
4 ner as the Secretary may by rule prescribe; and

5 (B) shall notify the Secretary, in the time and
6 manner as may be specified by the Secretary, of any
7 assignment that such person may have made of the
8 obligation to make any royalty or other payment
9 under a mining claim.

10 (2) Any person paying royalties under this section
11 shall file a written instrument, together with the first roy-
12 alty payment, affirming that such person is liable to the
13 Secretary for making proper payments for all amounts due
14 for all time periods for which such person has a payment
15 responsibility. Such liability for the period referred to in
16 the preceding sentence shall include any and all additional
17 amounts billed by the Secretary and determined to be due
18 by final agency or judicial action. Any person liable for
19 royalty payments under this section who assigns any pay-
20 ment obligation shall remain jointly and severally liable
21 for all royalty payments due for the claim for the period.

22 (3) A person conducting mineral activities shall—

23 (A) develop and comply with the site security
24 provisions in operations permit designed to protect
25 from theft the locatable minerals, concentrates or

1 products derived therefrom which are produced or
2 stored on a mining claim, and such provisions shall
3 conform with such minimum standards as the Sec-
4 retary may prescribe by rule, taking into account the
5 variety of circumstances on mining claims; and

6 (B) not later than the 5th business day after
7 production begins anywhere on a mining claim, or
8 production resumes after more than 90 days after
9 production was suspended, notify the Secretary, in
10 the manner prescribed by the Secretary, of the date
11 on which such production has begun or resumed.

12 (4) The Secretary may by rule require any person en-
13 gaged in transporting a locatable mineral, concentrate, or
14 product derived therefrom to carry on his or her person,
15 in his or her vehicle, or in his or her immediate control,
16 documentation showing, at a minimum, the amount, ori-
17 gin, and intended destination of the locatable mineral, con-
18 centrate, or product derived therefrom in such cir-
19 cumstances as the Secretary determines is appropriate.

20 (c) RECORDKEEPING AND REPORTING REQUIRE-
21 MENTS.—(1) A claim holder, operator, or other person di-
22 rectly involved in developing, producing, processing, trans-
23 porting, purchasing, or selling locatable minerals, con-
24 centrates, or products derived therefrom, subject to this
25 title, through the point of royalty computation shall estab-

1 lish and maintain any records, make any reports, and pro-
2 vide any information that the Secretary may reasonably
3 require for the purposes of implementing this section or
4 determining compliance with rules or orders under this
5 section. Such records shall include, but not be limited to,
6 periodic reports, records, documents, and other data. Such
7 reports may also include, but not be limited to, pertinent
8 technical and financial data relating to the quantity, qual-
9 ity, composition volume, weight, and assay of all minerals
10 extracted from the mining claim. Upon the request of any
11 officer or employee duly designated by the Secretary or
12 any State conducting an audit or investigation pursuant
13 to this section, the appropriate records, reports, or infor-
14 mation which may be required by this section shall be
15 made available for inspection and duplication by such offi-
16 cer or employee or State.

17 (2) Records required by the Secretary under this sec-
18 tion shall be maintained for 6 years after release of finan-
19 cial assurance under section 216 unless the Secretary noti-
20 fies the operator that he or she has initiated an audit or
21 investigation involving such records and that such records
22 must be maintained for a longer period. In any case when
23 an audit or investigation is underway, records shall be
24 maintained until the Secretary releases the operator of the
25 obligation to maintain such records.

1 (d) AUDITS.—The Secretary is authorized to conduct
2 such audits of all claim holders, operators, transporters,
3 purchasers, processors, or other persons directly or indi-
4 rectly involved in the production or sales of minerals cov-
5 ered by this title, as the Secretary deems necessary for
6 the purposes of ensuring compliance with the require-
7 ments of this section. For purposes of performing such
8 audits, the Secretary shall, at reasonable times and upon
9 request, have access to, and may copy, all books, papers
10 and other documents that relate to compliance with any
11 provision of this section by any person.

12 (e) COOPERATIVE AGREEMENTS.—(1) The Secretary
13 is authorized to enter into cooperative agreements with the
14 Secretary of Agriculture to share information concerning
15 the royalty management of locatable minerals, con-
16 centrates, or products derived therefrom, to carry out in-
17 spection, auditing, investigation, or enforcement (not in-
18 cluding the collection of royalties, civil or criminal pen-
19 alties, or other payments) activities under this section in
20 cooperation with the Secretary, and to carry out any other
21 activity described in this section.

22 (2) Except as provided in paragraph (4)(A) of this
23 subsection (relating to trade secrets), and pursuant to a
24 cooperative agreement, the Secretary of Agriculture shall,
25 upon request, have access to all royalty accounting infor-

1 mation in the possession of the Secretary respecting the
2 production, removal, or sale of locatable minerals, con-
3 centrates, or products derived therefrom from claims on
4 lands open to location under this title.

5 (3) Trade secrets, proprietary, and other confidential
6 information shall be made available by the Secretary pur-
7 suant to a cooperative agreement under this subsection to
8 the Secretary of Agriculture upon request only if—

9 (A) the Secretary of Agriculture consents in
10 writing to restrict the dissemination of the informa-
11 tion to those who are directly involved in an audit
12 or investigation under this section and who have a
13 need to know;

14 (B) the Secretary of Agriculture accepts liabil-
15 ity for wrongful disclosure; and

16 (C) the Secretary of Agriculture demonstrates
17 that such information is essential to the conduct of
18 an audit or investigation under this subsection.

19 (f) INTEREST AND SUBSTANTIAL UNDERREPORTING
20 ASSESSMENTS.—(1) In the case of mining claims where
21 royalty payments are not received by the Secretary on the
22 date that such payments are due, the Secretary shall
23 charge interest on such underpayments at the same inter-
24 est rate as is applicable under section 6621(a)(2) of the
25 Internal Revenue Code of 1986. In the case of an under-

1 payment, interest shall be computed and charged only on
2 the amount of the deficiency and not on the total amount.

3 (2) If there is any underreporting of royalty owed on
4 production from a claim for any production month by any
5 person liable for royalty payments under this section, the
6 Secretary may assess a penalty of 10 percent of the
7 amount of that underreporting.

8 (3) If there is a substantial underreporting of royalty
9 owed on production from a claim for any production
10 month by any person responsible for paying the royalty,
11 the Secretary may assess a penalty of 10 percent of the
12 amount of that underreporting.

13 (4) For the purposes of this subsection, the term
14 “substantial underreporting” means the difference be-
15 tween the royalty on the value of the production which
16 should have been reported and the royalty on the value
17 of the production which was reported, if the value which
18 should have been reported is greater than the value which
19 was reported. An underreporting constitutes a “substan-
20 tial underreporting” if such difference exceeds 10 percent
21 of the royalty on the value of production which should
22 have been reported.

23 (5) The Secretary shall not impose the assessment
24 provided in paragraph (2) or (3) of this subsection if the
25 person liable for royalty payments under this section cor-

1 rects the underreporting before the date such person re-
2 ceives notice from the Secretary that an underreporting
3 may have occurred, or before 90 days after the date of
4 the enactment of this section, whichever is later.

5 (6) The Secretary shall waive any portion of an as-
6 sessment under paragraph (2) or (3) of this subsection
7 attributable to that portion of the underreporting for
8 which the person responsible for paying the royalty dem-
9 onstrates that—

10 (A) such person had written authorization from
11 the Secretary to report royalty on the value of the
12 production on basis on which it was reported, or

13 (B) such person had substantial authority for
14 reporting royalty on the value of the production on
15 the basis on which it was reported, or

16 (C) such person previously had notified the Sec-
17 retary, in such manner as the Secretary may by rule
18 prescribe, of relevant reasons or facts affecting the
19 royalty treatment of specific production which led to
20 the underreporting, or

21 (D) such person meets any other exception
22 which the Secretary may, by rule, establish.

23 (7) All penalties collected under this subsection shall
24 be deposited in the Fund.

1 (g) DELEGATION.—For the purposes of this section,
2 the term “Secretary” means the Secretary of the Interior
3 acting through the Director of the Minerals Management
4 Service.

5 (h) EXPANDED ROYALTY OBLIGATIONS.—Each per-
6 son liable for royalty payments under this section shall
7 be jointly and severally liable for royalty on all locatable
8 minerals, concentrates, or products derived therefrom lost
9 or wasted from a mining claim located or converted under
10 this section when such loss or waste is due to negligence
11 on the part of any person or due to the failure to comply
12 with any rule, regulation, or order issued under this sec-
13 tion.

14 (i) EXCEPTION.—No royalty shall be payable under
15 subsection (a) with respect to minerals processed at a fa-
16 cility by the same person or entity which extracted the
17 minerals if an urban development action grant has been
18 made under section 119 of the Housing and Community
19 Development Act of 1974 with respect to any portion of
20 such facility.

21 (j) DEFINITION.—For the proposes of this section,
22 for any locatable mineral, the term “net smelter return”
23 shall have the same meaning as the term defined in section
24 613(c)(1) of the Internal Revenue Code of 1986.

1 (k) EFFECTIVE DATE.—The royalty under this sec-
2 tion shall take effect with respect to the production of
3 locatable minerals after the enactment of this Act, but any
4 royalty payments attributable to production during the
5 first 12 calendar months after the enactment of this Act
6 shall be payable at the expiration of such 12-month period.

7 **Subtitle D—Administrative and** 8 **Miscellaneous Provisions**

9 **PART 1—ADMINISTRATIVE PROVISIONS**

10 **SEC. 241. POLICY FUNCTIONS.**

11 (a) MINERALS POLICY.—Section 2 of the Mining and
12 Minerals Policy Act of 1970 (30 U.S.C. 21a) is amended
13 by adding at the end thereof the following: “It shall also
14 be the responsibility of the Secretary of Agriculture to
15 carry out the policy provisions of paragraphs (1) and (2)
16 of this section.”.

17 (b) MINERAL DATA.—Section 5(e)(3) of the National
18 Materials and Minerals Policy, Research and Development
19 Act of 1980 (30 U.S.C. 1604) is amended by inserting
20 before the period the following: “, except that for National
21 Forest System lands the Secretary of Agriculture shall
22 promptly initiate actions to improve the availability and
23 analysis of mineral data in Federal land use decision-
24 making”.

1 **SEC. 242. USER FEES.**

2 The Secretary and the Secretary of Agriculture are
3 each authorized to establish and collect from persons sub-
4 ject to the requirements of this title such user fees as may
5 be necessary to reimburse the United States for the ex-
6 penses incurred in administering such requirements. Fees
7 may be assessed and collected under this section only in
8 such manner as may reasonably be expected to result in
9 an aggregate amount of the fees collected during any fiscal
10 year which does not exceed the aggregate amount of ad-
11 ministrative expenses referred to in this section.

12 **SEC. 243. PUBLIC PARTICIPATION REQUIREMENTS.**

13 (a) OPERATIONS PERMIT.—(1) Concurrent with sub-
14 mittal of an application for an operations permit under
15 section 214 or a renewal or significant modification there-
16 of, the applicant shall publish a notice in a newspaper of
17 local circulation at least once a week for 4 consecutive
18 weeks. The notice shall include: the name of the applicant,
19 the location of the proposed mineral activities, the type
20 and expected duration of the proposed mineral activities,
21 the proposed use of the land after the completion of min-
22 eral activities and a location where such plans are publicly
23 available. The applicant shall also notify in writing other
24 Federal, State and local government agencies and Indian
25 tribes that regulate mineral activities or land planning de-
26 cisions in the area subject to mineral activities or that

1 manage lands adjacent to the area subject to mineral ac-
2 tivities. The applicant shall provide proof of such notifica-
3 tion to the Secretary, or for National Forest System lands
4 the Secretary of Agriculture.

5 (2) The applicant for an operations permit shall make
6 copies of the complete permit application available for
7 public review at the office of the responsible Federal sur-
8 face management agency located nearest to the location
9 of the proposed mineral activities, and at such other public
10 locations deemed appropriate by the State or local govern-
11 ment for the county in which the proposed mineral activi-
12 ties will occur prior to final decision by the Secretary, or
13 for National Forest System lands the Secretary of Agri-
14 culture. Any person, and the authorized representative of
15 a Federal, State or local governmental agency or Indian
16 tribe, shall have the right to file written comments relating
17 to the approval or disapproval of the permit application
18 until 30 days after the last day of newspaper publication.
19 The Secretary concerned shall promptly make such com-
20 ments available to the applicant.

21 (3) Any person may file written comments during the
22 comment period specified in paragraph (2) and any person
23 who is, or may be, adversely affected by the proposed min-
24 eral activities may request a nonadjudicatory public hear-
25 ing to be held in the county in which the mineral activities

1 are proposed. The Secretary concerned shall consider all
2 written comments filed during such period. If a hearing
3 is requested by any person who is, or may be, adversely
4 affected by the proposed mineral activities, the Secretary
5 concerned shall consider such request and may conduct
6 such hearing. When a hearing is to be held, notice of such
7 hearing shall be published in a newspaper of local circula-
8 tion at least once a week for 2 weeks prior to the hearing
9 date.

10 **SEC. 244. INSPECTION AND MONITORING.**

11 (a) INSPECTIONS.—(1) The Secretary, or for Na-
12 tional Forest System lands the Secretary of Agriculture,
13 shall make inspections of mineral activities so as to ensure
14 compliance with the surface management requirements of
15 subtitle B.

16 (2) The Secretary concerned shall establish a fre-
17 quency of inspections for mineral activities conducted
18 under a permit issued under subtitle B, but in no event
19 shall such inspection frequency be less than one complete
20 inspection per calendar quarter or, two per calendar quar-
21 ter in the case of a permit for which the Secretary con-
22 cerned approves an application under section 214(g) (re-
23 lating to temporary cessation of operations). After revege-
24 tation has been established in accordance with a reclama-
25 tion plan, such Secretary shall conduct annually 2 com-

1 plete inspections. Such Secretary shall have the discretion
2 to modify the inspection frequency for mineral activities
3 that are conducted on a seasonal basis. Inspections shall
4 continue under this subsection until final release of finan-
5 cial assurance.

6 (3)(A) Any person who has reason to believe he or
7 she is or may be adversely affected by mineral activities
8 due to any violation of the surface management require-
9 ments may request an inspection. The Secretary, or for
10 National Forest System lands the Secretary of Agri-
11 culture, shall determine within 10 working days of receipt
12 of the request whether the request states a reason to be-
13 lieve that a violation exists. If the person alleges and pro-
14 vides reason to believe that an imminent threat to the en-
15 vironment or danger to the health or safety of the public
16 exists, the 10-day period shall be waived and the inspec-
17 tion shall be conducted immediately. When an inspection
18 is conducted under this paragraph, the Secretary con-
19 cerned shall notify the person requesting the inspection,
20 and such person shall be allowed to accompany the Sec-
21 retary concerned or the Secretary's authorized representa-
22 tive during the inspection. The Secretary shall not incur
23 any liability for allowing such person to accompany an au-
24 thorized representative. The identity of the person sup-
25 plying information to the Secretary relating to a possible

1 violation or imminent danger or harm shall remain con-
2 fidential with the Secretary if so requested by that person,
3 unless that person elects to accompany an authorized rep-
4 resentative on the inspection.

5 (B) The Secretaries shall, by joint rule, establish pro-
6 cedures for the review of (i) any decision by an authorized
7 representative not to inspect or (ii) any refusal by such
8 representative to ensure that remedial actions are taken
9 with respect to any alleged violation. The Secretary con-
10 cerned shall furnish such persons requesting the review
11 a written statement of the reasons for the Secretary's final
12 disposition of the case.

13 (b) MONITORING.—(1) The Secretary, or for Na-
14 tional Forest System lands the Secretary of Agriculture,
15 shall require all operators to develop and maintain a moni-
16 toring and evaluation system which shall identify compli-
17 ance with all surface management requirements.

18 (2) Monitoring shall be conducted as close as tech-
19 nically feasible to the mineral activity involved, and in all
20 cases such monitoring shall be conducted within the per-
21 mit area.

22 (3) The point of compliance referred to in paragraph
23 (1) shall be as close to the mineral activity involved as
24 is technically feasible, but in any event shall be located
25 to comply with applicable State and Federal standards.

1 In no event shall the point of compliance be outside the
2 permit area.

3 (4) The Secretary concerned may require additional
4 monitoring be conducted as necessary to assure compli-
5 ance with the reclamation and other environmental stand-
6 ards of this title.

7 (5) The operator shall file reports with the Secretary,
8 or for National Forest System lands the Secretary of Agri-
9 culture, on a frequency determined by the Secretary con-
10 cerned, on the results of the monitoring and evaluation
11 process, except that if the monitoring and evaluation show
12 a violation of the surface management requirements, it
13 shall be reported immediately to the Secretary concerned.
14 Information received pursuant to this subsection from any
15 natural person shall not be used against any such natural
16 person in any criminal case, except a prosecution for per-
17 jury or for giving a false statement. The Secretary shall
18 evaluate the reports submitted pursuant to this para-
19 graph, and based on those reports and any necessary in-
20 spection shall take enforcement action pursuant to this
21 section.

22 (6) The Secretary, or for National Forest System
23 lands the Secretary of Agriculture, shall determine what
24 information must be reported by the operator pursuant
25 to paragraph (5). A failure to report as required by the

1 Secretary concerned shall constitute a violation of this title
2 and subject the operator to enforcement action pursuant
3 to section 247.

4 **SEC. 245. CITIZENS SUITS.**

5 (a) IN GENERAL.—Except as provided in subsection
6 (b), any person having an interest which is or may be ad-
7 versely affected may commence a civil action on his or her
8 own behalf to compel compliance—

9 (1) against any person (including the Secretary
10 or the Secretary of Agriculture) alleged to have vio-
11 lated (if there is evidence the alleged violation has
12 been repeated), or to be in violation of, any of the
13 provisions of subtitle B or section 244 of this title
14 or any regulation promulgated pursuant to subtitle
15 B or section 244 of this title or any term or condi-
16 tion of any permit issued under subtitle B of this
17 title; or

18 (2) against the Secretary or the Secretary of
19 Agriculture where there is alleged a failure of such
20 Secretary to perform any act or duty under subtitle
21 B or section 244 of this title, or to promulgate any
22 regulation under subtitle B or section 244 of this
23 title, which is not within the discretion of the Sec-
24 retary concerned.

1 The United States district courts shall have jurisdiction
2 over actions brought under this section, without regard to
3 the amount in controversy or the citizenship of the parties,
4 including actions brought to apply any civil penalty under
5 this title. The district courts of the United States shall
6 have jurisdiction to compel agency action unreasonably de-
7 layed, except that an action to compel agency action re-
8 viewable under section 246 may only be filed in a United
9 States District Court within the circuit in which such ac-
10 tion would be reviewable under section 246.

11 (b) EXCEPTIONS.—(1) No action may be commenced
12 under subsection (a) prior to 60 days after the plaintiff
13 has given notice in writing of such alleged violation to the
14 Secretary, or for National Forest System lands the Sec-
15 retary of Agriculture, except that any such action may be
16 brought immediately after such notification if the violation
17 complained of constitutes an imminent threat to the envi-
18 ronment or to the health or safety of the public.

19 (2) No action may be brought against any person
20 other than the Secretary or the Secretary of Agriculture
21 under subsection (a)(1) if such Secretary has commenced
22 and is diligently prosecuting a civil or criminal action in
23 a court of the United States to require compliance.

24 (3) No action may be commenced under paragraph
25 (2) of subsection (a) against either Secretary to review any

1 rule promulgated by, or to any permit issued or denied
2 by such Secretary if such rule or permit issuance or denial
3 is judicially reviewable under section 246 or under any
4 other provision of law at any time after such promulga-
5 tion, issuance, or denial is final.

6 (c) VENUE.—Venue of all actions brought under this
7 section shall be determined in accordance with section
8 1391 of title 28 of the United States Code.

9 (d) INTERVENTION; NOTICE.—(1) In any action
10 under this section, the Secretary, or for National Forest
11 System lands the Secretary of Agriculture, may intervene
12 as a matter of right at any time. A judgment in an action
13 under this section to which the United States is not a
14 party shall not have any binding effect upon the United
15 States.

16 (2) Whenever an action is brought under this section
17 the plaintiff shall serve a copy of the complaint on the
18 Attorney General of the United States and on the Sec-
19 retary, or for National Forest System lands the Secretary
20 of Agriculture. No consent judgment shall be entered in
21 an action brought under this section in which the United
22 States is not a party prior to 45 days following the date
23 on which a copy of the proposed consent judgment is sub-
24 mitted to the Attorney General and the Secretary, or for
25 National Forest System lands the Secretary of Agri-

1 culture. During such 45-day period the Attorney General
2 or such Secretary may submit comments on the proposed
3 consent judgment to the court and parties or may inter-
4 vene as a matter of right.

5 (e) COSTS.—The court, in issuing any final order in
6 any action brought pursuant to this section may award
7 costs of litigation (including attorney and expert witness
8 fees) to any prevailing party whenever the court deter-
9 mines such award is appropriate. The court may, if a tem-
10 porary restraining order or preliminary injunction is
11 sought, require the filing of a bond or equivalent security
12 in accordance with the Federal Rules of Civil Procedure.

13 (f) SAVINGS CLAUSE.—Nothing in this section shall
14 restrict any right which any person (or class of persons)
15 may have under chapter 7 of title 5 of the United States
16 Code, under section 246 of this title or under any other
17 statute or common law to bring an action to seek any relief
18 against the Secretary or the Secretary of Agriculture or
19 against any other person, including any action for any vio-
20 lation of this title or of any regulation or permit issued
21 under this title or for any failure to act as required by
22 law. Nothing in this section shall affect the jurisdiction
23 of any court under any provision of title 28 of the United
24 States Code, including any action for any violation of this
25 title or of any regulation or permit issued under this title

1 or for any failure to act as required by law. Nothing in
2 this title shall be construed to be a waiver of the sovereign
3 immunity of an Indian tribe except as provided for in sec-
4 tion 212(c).

5 **SEC. 246. ADMINISTRATIVE AND JUDICIAL REVIEW.**

6 (a) REVIEW BY SECRETARY.—(1)(A) Any person
7 issued a notice of violation or cessation order under sec-
8 tion 247, or any person having an interest which is or
9 may be adversely affected by such notice or order, may
10 apply to the Secretary, or for National Forest System
11 lands the Secretary of Agriculture, for review of the notice
12 or order within 30 days of receipt thereof, or as the case
13 may be, within 30 days of such notice or order being modi-
14 fied, vacated or terminated.

15 (B) Any person who is subject to a penalty assessed
16 under section 218, section 219(c), or section 247 may
17 apply to the Secretary concerned for review of the assess-
18 ment within 30 days of notification of such penalty.

19 (C) Any person having an interest which is or may
20 be adversely affected by a decision made by the Secretary
21 or the Secretary of Agriculture under section 213, 214,
22 215, 216, 219, or 244(a)(3) may apply to such Secretary
23 for review of the decision within 30 days after it is made.

24 (2) The Secretary concerned shall provide an oppor-
25 tunity for a public hearing at the request of any party

1 to the proceeding as specified in paragraph (1). The filing
2 of an application for review under this subsection shall not
3 operate as a stay of any order or notice issued under sec-
4 tion 247.

5 (3) For any review proceeding under this subsection,
6 the Secretary concerned shall make findings of fact and
7 shall issue a written decision incorporating therein an
8 order vacating, affirming, modifying or terminating the
9 notice, order or decision, or with respect to an assessment,
10 the amount of penalty that is warranted. Where the appli-
11 cation for review concerns a cessation order issued under
12 section 247, the Secretary concerned shall issue the writ-
13 ten decision within 30 days of the receipt of the applica-
14 tion for review or within 30 days after the conclusion of
15 any hearing referred to in paragraph (2), whichever is
16 later, unless temporary relief has been granted by the Sec-
17 retary concerned under paragraph (4).

18 (4) Pending completion of any review proceedings
19 under this subsection, the applicant may file with the Sec-
20 retary, or for National Forest System lands the Secretary
21 of Agriculture, a written request that the Secretary grant
22 temporary relief from any order issued under section 247
23 together with a detailed statement giving reasons for such
24 relief. The Secretary concerned shall expeditiously issue
25 an order or decision granting or denying such relief. The

1 Secretary concerned may grant such relief under such con-
2 ditions as he may prescribe only if such relief shall not
3 adversely affect the health or safety of the public or cause
4 significant, imminent environmental harm to land, air or
5 water resources.

6 (5) The availability of review under this subsection
7 shall not be construed to limit the operation of rights
8 under section 245.

9 (b) JUDICIAL REVIEW.—(1) Any final action by the
10 Secretaries of the Interior and Agriculture in promul-
11 gating regulations to implement this title, or any other
12 final actions constituting rulemaking to implement this
13 title, shall be subject to judicial review only in the United
14 States Court of Appeals for the District of Columbia. Any
15 action subject to judicial review under this subsection shall
16 be affirmed unless the court concludes that such action
17 is arbitrary, capricious, or otherwise inconsistent with law.
18 A petition for review of any action subject to judicial re-
19 view under this subsection shall be filed within 60 days
20 from the date of such action, or after such date if the
21 petition is based solely on grounds arising after the six-
22 tieth day. Any such petition may be made by any person
23 who commented or otherwise participated in the rule-
24 making or any person who may be adversely affected by
25 the action of the Secretaries.

1 (2) Final agency action under this title, including
2 such final action on those matters described under sub-
3 section (a), shall be subject to judicial review in accord-
4 ance with paragraph (4) and pursuant to section 1391 of
5 title 28 of the United States Code on or before 60 days
6 from the date of such final action. Any action subject to
7 judicial review under this subsection shall be affirmed un-
8 less the court concludes that such action is arbitrary, ca-
9 pricious, or otherwise inconsistent with law.

10 (3) The availability of judicial review established in
11 this subsection shall not be construed to limit the oper-
12 ations of rights under section 245 (relating to citizens
13 suits).

14 (4) The court shall hear any petition or complaint
15 filed under this subsection solely on the record made be-
16 fore the Secretary or Secretaries concerned. The court
17 may affirm or vacate any order or decision or may remand
18 the proceedings to the Secretary or Secretaries for such
19 further action as it may direct.

20 (5) The commencement of a proceeding under this
21 section shall not, unless specifically ordered by the court,
22 operate as a stay of the action, order or decision of the
23 Secretary or Secretaries concerned.

24 (c) COSTS.—Whenever a proceeding occurs under
25 subsection (a) or (b), at the request of any person, a sum

1 equal to the aggregate amount of all costs and expenses
2 (including attorney fees) as determined by the Secretary
3 or Secretaries concerned or the court to have been reason-
4 ably incurred by such person for or in connection with par-
5 ticipation in such proceedings, including any judicial re-
6 view of the proceeding, may be assessed against either
7 party as the court, in the case of judicial review, or the
8 Secretary or Secretaries concerned in the case of adminis-
9 trative proceedings, deems proper if it is determined that
10 such party prevailed in whole or in part, achieving some
11 success on the merits, and that such party made a sub-
12 stantial contribution to a full and fair determination of
13 the issues.

14 **SEC. 247. ENFORCEMENT.**

15 (a) ORDERS.—(1) If the Secretary, or for National
16 Forest System lands the Secretary of Agriculture, or an
17 authorized representative of such Secretary, determines
18 that any person is in violation of any surface management
19 or monitoring requirement, such Secretary or authorized
20 representative shall issue to such person a notice of viola-
21 tion describing the violation and the corrective measures
22 to be taken. The Secretary concerned, or the authorized
23 representative of such Secretary, shall provide such person
24 with a period of time not to exceed 30 days to abate the
25 violation. Such period of time may be extended by the Sec-

1 retary concerned upon a showing of good cause by such
2 person. If, upon the expiration of time provided for such
3 abatement, the Secretary concerned, or the authorized
4 representative of such Secretary, finds that the violation
5 has not been abated he shall immediately order a cessation
6 of all mineral activities or the portion thereof relevant to
7 the violation.

8 (2) If the Secretary concerned, or the authorized rep-
9 resentative of the Secretary concerned, determines that
10 any condition or practice exists, or that any person is in
11 violation of any surface management or monitoring re-
12 quirement, and such condition, practice or violation is
13 causing, or can reasonably be expected to cause—

14 (A) an imminent danger to the health or safety
15 of the public; or

16 (B) significant, imminent environmental harm
17 to land, air, water, fish or wildlife resources;

18 such Secretary or authorized representative shall imme-
19 diately order a cessation of mineral activities or the por-
20 tion thereof relevant to the condition, practice or violation.

21 (3)(A) A cessation order pursuant to paragraphs (1)
22 or (2) shall remain in effect until such Secretary, or au-
23 thorized representative, determines that the condition,
24 practice or violation has been abated, or until modified,
25 vacated or terminated by the Secretary or authorized rep-

1 representative. In any such order, the Secretary or authorized
2 representative shall determine the steps necessary to abate
3 the violation in the most expeditious manner possible and
4 shall include the necessary measures in the order. The
5 Secretary concerned shall require appropriate financial as-
6 surances to ensure that the abatement obligations are met.

7 (B) Any notice or order issued pursuant to para-
8 graphs (1) or (2) may be modified, vacated or terminated
9 by the Secretary concerned or an authorized representa-
10 tive of such Secretary. Any person to whom any such no-
11 tice or order is issued shall be entitled to a hearing on
12 the record.

13 (4) If, after 30 days of the date of the order referred
14 to in paragraph (3)(A) the required abatement has not
15 occurred the Secretary concerned shall take such alter-
16 native enforcement action against the claimholder or oper-
17 ator (or any person who controls the claimholder or oper-
18 ator) as will most likely bring about abatement in the most
19 expeditious manner possible. Such alternative enforcement
20 action may include, but is not necessarily limited to, seek-
21 ing appropriate injunctive relief to bring about abatement.
22 Nothing in this paragraph shall preclude the Secretary,
23 or for National Forest System lands the Secretary of Agri-
24 culture, from taking alternative enforcement action prior
25 to the expiration of 30 days.

1 (5) If a claimholder or operator (or any person who
2 controls the claimholder or operator) fails to abate a viola-
3 tion or defaults on the terms of the permit, the Secretary,
4 or for National Forest System lands the Secretary of Agri-
5 culture, shall forfeit the financial assurance for the plan
6 as necessary to ensure abatement and reclamation under
7 this title. The Secretary concerned may prescribe condi-
8 tions under which a surety may perform reclamation in
9 accordance with the approved plan in lieu of forfeiture.

10 (6) The Secretary, or for National Forest System
11 lands the Secretary of Agriculture, shall not cause for-
12 feiture of the financial assurance while administrative or
13 judicial review is pending.

14 (7) In the event of forfeiture, the claim holder, oper-
15 ator, or any affiliate thereof, as appropriate as determined
16 by the Secretary by rule, shall be jointly and severally lia-
17 ble for any remaining reclamation obligations under this
18 title.

19 (b) COMPLIANCE.—The Secretary, or for National
20 Forest System lands the Secretary of Agriculture, may re-
21 quest the Attorney General to institute a civil action for
22 relief, including a permanent or temporary injunction or
23 restraining order, or any other appropriate enforcement
24 order, including the imposition of civil penalties, in the dis-

1 triet court of the United States for the district in which
2 the mineral activities are located whenever a person—

3 (1) violates, fails or refuses to comply with any
4 order issued by the Secretary concerned under sub-
5 section (a); or

6 (2) interferes with, hinders or delays the Sec-
7 retary concerned in carrying out an inspection under
8 section 244.

9 Such court shall have jurisdiction to provide such relief
10 as may be appropriate. Any relief granted by the court
11 to enforce an order under paragraph (1) shall continue
12 in effect until the completion or final termination of all
13 proceedings for review of such order unless the district
14 court granting such relief sets it aside.

15 (c) DELEGATION.—Notwithstanding any other provi-
16 sion of law, the Secretary may utilize personnel of the Of-
17 fice of Surface Mining Reclamation and Enforcement to
18 ensure compliance with the requirements of this title.

19 (d) PENALTIES.—(1) Any person who fails to comply
20 with any surface management requirement shall be liable
21 for a penalty of not more than \$25,000 per violation. Each
22 day of violation may be deemed a separate violation for
23 purposes of penalty assessments.

24 (2) A person who fails to correct a violation for which
25 a cessation order has been issued under subsection (a)

1 within the period permitted for its correction shall be as-
2 sessed a civil penalty of not less than \$1,000 per violation
3 for each day during which such failure continues, but in
4 no event shall such assessment exceed a 30-day period.

5 (3) Whenever a corporation is in violation of a surface
6 management requirement or fails or refuses to comply
7 with an order issued under subsection (a), any director,
8 officer or agent of such corporation who knowingly author-
9 ized, ordered, or carried out such violation, failure or re-
10 fusal shall be subject to the same penalties as may be im-
11 posed upon the person referred to in paragraph (1).

12 (e) SUSPENSIONS OR REVOCATIONS.—The Secretary,
13 or for National Forest System lands the Secretary of Agri-
14 culture, may suspend or revoke a permit issued under sub-
15 title B, in whole or in part, if the operator or person con-
16 ducting mineral activities—

17 (1) knowingly made or knowingly makes any
18 false, inaccurate, or misleading material statement
19 in any mining claim, notice of location, application,
20 record, report, plan, or other document filed or re-
21 quired to be maintained under this title;

22 (2) fails to abate a violation covered by a ces-
23 sation order issued under subsection (a);

24 (3) fails to comply with an order of the Sec-
25 retary concerned;

1 (4) refuses to permit an audit pursuant to this
2 title;

3 (5) fails to maintain an adequate financial as-
4 surance under section 216;

5 (6) fails to pay claim maintenance fees or other
6 moneys due and owing under this title; or

7 (7) with regard to plans conditionally approved
8 under section 215(c)(2), fails to abate a violation to
9 the satisfaction of the Secretary concerned, or if the
10 validity of the violation is upheld on the appeal
11 which formed the basis for the conditional approval.

12 (f) FALSE STATEMENTS; TAMPERING.—Any person
13 who knowingly—

14 (1) makes any false material statement, rep-
15 resentation, or certification in, or omits or conceals
16 material information from, or unlawfully alters, any
17 mining claim, notice of location, application, record,
18 report, plan, or other documents filed or required to
19 be maintained under this title; or

20 (2) falsifies, tampers with, renders inaccurate,
21 or fails to install any monitoring device or method
22 be required to be maintained under this title,

23 shall upon conviction, be punished by a fine of not more
24 than \$10,000, or by imprisonment for not more than 2
25 years, or by both. If a conviction of a person is for a viola-

1 tion committed after a first conviction of such person
2 under this paragraph, punishment shall be by a fine of
3 not more than \$20,000 per day of violation, or by impris-
4 onment of not more than 4 years, or both. Each day of
5 continuing violation may be deemed a separate violation
6 for purposes of penalty assessments.

7 (g) KNOWING VIOLATIONS.—Any person who
8 knowingly—

9 (1) engages in mineral activities without a per-
10 mit required under subtitle B, or

11 (2) violates any other surface management re-
12 quirement of this title or any provision of a permit
13 issued under this title (including any exploration or
14 operations plan on which such permit is based), or
15 condition or limitation thereof,

16 shall upon conviction be punished by a fine of not less
17 than \$5,000 nor more than \$50,000 per day of violation,
18 or by imprisonment for not more than 3 years, or both.

19 If a conviction of a person is for a violation committed
20 after the first conviction of such person under this para-
21 graph, punishment shall be a fine of not less than \$10,000
22 per day of violation, or by imprisonment of not more than
23 6 years, or both.

24 (h) FAILURE TO COMPLY WITH ROYALTY REQUIRE-
25 MENTS.—(1) Any person who fails to comply with the re-

1 requirements of section 236 or any regulation or order
2 issued to implement section 236 shall be liable for a civil
3 penalty under section 109 of the Federal Oil and Gas Roy-
4 alty Management Act of 1982 (30 U.S.C. 1719) to the
5 same extent as if the claim located or converted under this
6 title were a lease under that Act.

7 (2) Any person who knowingly and willfully commits
8 an act for which a civil penalty is provided in paragraph
9 (1) shall, upon conviction, be punished by a fine of not
10 more than \$50,000, or by imprisonment for not more than
11 2 years, or both.

12 (i) DEFINITION. For purposes of this section, the
13 term “person” includes a person as defined in section 3(a)
14 and any officer, agent, or employee of any such person.

15 **SEC. 248. REGULATIONS; EFFECTIVE DATES.**

16 (a) EFFECTIVE DATE.—The provisions of this title
17 shall take effect on the date of enactment of this Act, ex-
18 cept as otherwise provided in this title.

19 (b) REGULATIONS.—The Secretary and the Secretary
20 of Agriculture may issue such regulations as may be nec-
21 essary under this title. The regulations implementing sub-
22 title B and the provisions of subtitle D which affect the
23 United States Forest Service shall be joint regulations
24 issued by both Secretaries.

1 (c) NOTICE.—Within 180 days after the date of en-
2 actment of this Act, the Secretary shall give notice to hold-
3 ers of mining claims and mill sites maintained under the
4 general mining laws as to the requirements of sections
5 206, 207, and 218.

6 **PART 2—MISCELLANEOUS PROVISIONS**

7 **SEC. 249. TRANSITIONAL RULES; SURFACE MANAGEMENT**
8 **REQUIREMENTS.**

9 (a) NEW CLAIMS.—Notwithstanding any other provi-
10 sion of law, any mining claim for a locatable mineral on
11 lands subject to this title located after the date of enact-
12 ment of this Act shall be subject to the requirements of
13 subtitle B.

14 (b) PREEXISTING CLAIMS.—(1) Notwithstanding any
15 other provision of law, any unpatented mining claim or
16 mill site located under the general mining laws before the
17 date of enactment of this Act for which a plan of operation
18 has not been approved or a notice filed prior to the date
19 of enactment shall upon the effective date of this title, be
20 subject to the requirements of subtitle B, except as pro-
21 vided in paragraphs (2) and (3).

22 (2)(A) If a plan of operations had been approved for
23 mineral activities on any claim or site referred to in para-
24 graph (1) prior to the date of enactment this Act, for a
25 period of 5 years after the effective date of this title min-

1 eral activities at such claim or site shall be subject to such
2 plan of operations (or a modification or amendment there-
3 to prepared in accordance with the provisions of law appli-
4 cable prior to the enactment of this Act). During such 5-
5 year period, modifications of, or amendments to, any such
6 plan may be made in accordance with the provisions of
7 law applicable prior to the enactment of this Act if such
8 modifications or amendments are deemed minor by the
9 Secretary concerned. After such 5-year period the require-
10 ments of subtitle B shall apply, subject to the limitations
11 of section 219. In order to meet the requirements of sub-
12 title B, the person conducting mineral activities under
13 such plan of operations (or modified or amended plan)
14 shall apply for a modification under section 213(f) and
15 214(f) no later than 3 years after the date of enactment
16 of this Act. For purposes of this paragraph, any modifica-
17 tion or amendment which extends the area covered by the
18 plan (except for incidental boundary revisions) or which
19 significantly increases the risk of adverse effects on the
20 environment shall not be subject to this paragraph and
21 shall be subject to other provisions of this title.

22 (B) During the 5-year period referred to in subpara-
23 graph (A) the provisions of section 244 (relating to inspec-
24 tion and monitoring) and section 247 (relating to enforce-
25 ment) shall apply on the basis of the surface management

1 requirements applicable to such plans of operations prior
2 to the effective date of this title.

3 (C) Where an application for modification or amend-
4 ment of a plan of operations referred to in subparagraph
5 (A) has been timely submitted and an approved plan ex-
6 pires prior to Secretarial action on the application, mineral
7 activities and reclamation may continue in accordance
8 with the terms of the expired plan until the Secretary
9 makes an administrative decision on the application.

10 (3)(A) If a substantially complete application for ap-
11 proval of a plan of operations or for a modification of,
12 or amendment to, a plan of operations had been submitted
13 by May 1, 1999, and either a scoping document or an En-
14 vironmental Assessment prepared for purposes of compli-
15 ance with the National Environmental Policy Act of 1969
16 had been published with respect to such plan, modifica-
17 tion, or amendment before the date of the enactment of
18 this Act but the submitted plan of operations or modifica-
19 tion or amendment had not been approved for mineral ac-
20 tivities on any claim or site referred to in paragraph (1)
21 prior to such date of enactment, for a period of 5 years
22 after the effective date of this title mineral activities at
23 such claim or site shall be subject to the provisions of law
24 applicable prior to the enactment of this Act. During such
25 5-year period, subsequent modifications of, or amend-

1 ments to, any such plan may be made in accordance with
2 the provisions of law applicable prior to the enactment of
3 this Act if such subsequent modifications or amendments
4 are deemed minor by the Secretary concerned. After such
5 5-year period, the requirements of subtitle B shall apply,
6 subject to the limitations of section 219. For purposes of
7 this paragraph, any subsequent modification or amend-
8 ment which extends the area covered by the plan (except
9 for incidental boundary revisions) or which significantly
10 increases the risk of adverse effects on the environment
11 shall not be subject to this paragraph and shall be subject
12 to other provisions of this title.

13 (B) In order to meet the requirements of subtitle B,
14 the person conducting mineral activities under a plan of
15 operations (or modified or amended plan referred to in
16 subparagraph (A)) shall apply for a modification under
17 sections 213(f) and 214(f) no later than 3 years after the
18 date of enactment of this Act. During such 5-year period
19 the provisions of section 244 (relating to inspection and
20 monitoring) and section 247 (relating to enforcement)
21 shall apply on the basis of the surface management re-
22 quirements applicable to such plans of operations prior to
23 the effective date of this Act.

24 (C) Where an application for modification or amend-
25 ment of a plan of operations referred to in subparagraph

1 (A) has been timely submitted and an approved plan ex-
2 pires prior to Secretarial action on the application, mineral
3 activities and reclamation may continue in accordance
4 with the terms of the expired plan until the Secretary
5 makes an administrative decision on the application.

6 (4) If a notice or notice of intent had been filed with
7 the authorized officer in the applicable office of the Bu-
8 reau of Land Management or the United States Forest
9 Service (as provided for in the regulations of the Secretary
10 of the Interior or the Secretary of Agriculture, respec-
11 tively, in effect prior to the date of enactment of this Act)
12 prior to the date of enactment this Act, mineral activities
13 may continue under such notice or notice of intent for a
14 period of 2 years after the effective date of this Act, after
15 which time the requirements of subtitle B shall apply, sub-
16 ject to the limitations of section 219(d)(2). In order to
17 meet the requirements of subtitle B, the person con-
18 ducting mineral activities under such notice or notice of
19 intent must apply for a permit under section 213 or 214
20 no later than 18 months after the effective date of this
21 title, unless such mineral activities are conducted pursuant
22 to section 212(b). During such 2-year period the provi-
23 sions of section 244 (relating to inspection and moni-
24 toring) and 247 (relating to enforcement) shall apply on

1 the basis of the surface management requirements appli-
2 cable to such notices prior to the effective date of this title.

3 **SEC. 250. CLAIMS SUBJECT TO SPECIAL RULES.**

4 (a) CERTAIN CLAIMS NOT CONVERTED.—Notwith-
5 standing any other provision of law, except as provided
6 under subsection (c), an unpatented mining claim referred
7 to in section 37 of the Mineral Leasing Act (30 U.S.C.
8 193) shall not be converted under section 206 of this title
9 until the Secretary determines that the claim was valid
10 on the date of enactment of the Mineral Leasing Act and
11 has been maintained in compliance with the general min-
12 ing laws.

13 (b) CONTEST PROCEEDINGS.—As soon as practicable
14 after the date of enactment of this Act, the Secretary shall
15 initiate contest proceedings challenging the validity of all
16 unpatented claims referred to in subsection (a), including
17 those claims for which a patent application has not been
18 filed. If a claim is determined to be invalid, the Secretary
19 shall promptly declare the claim to be null and void. If,
20 as a result of such proceeding, a claim is determined valid,
21 the claim shall be converted and thereby become subject
22 to this title's provisions on the date of the completion of
23 the contest proceeding.

24 (c) OIL SHALE CLAIMS.—(1) The provisions of sec-
25 tion 251 shall apply to oil shale claims referred to in sec-

1 tion 2511(e)(2) of the Energy Policy Act of 1992 (Public
2 Law 102–486).

3 (2) Section 2511(f) of the Energy Policy Act of 1992
4 (Public Law 102–486) is amended as follows:

5 (A) Strike “as prescribed by the Secretary”.

6 (B) Insert the following before the period: “in
7 the same manner as if such claims were subject to
8 subtitle B of the Mineral Exploration and Develop-
9 ment Act of 1999”.

10 **SEC. 251. PURCHASING POWER ADJUSTMENT.**

11 The Secretary shall adjust all location fees, claim
12 maintenance rates, penalty amounts, and other dollar
13 amounts established in this title for changes in the pur-
14 chasing power of the dollar every 10 years following the
15 date of enactment of this Act, employing the Consumer
16 Price Index for all-urban consumers published by the De-
17 partment of Labor as the basis for adjustment, and round-
18 ing according to the adjustment process of conditions of
19 the Federal Civil Penalties Inflation Adjustment Act of
20 1990 (104 Stat. 890).

21 **SEC. 252. SAVINGS CLAUSE.**

22 (a) SPECIAL APPLICATION OF MINING LAWS.—Noth-
23 ing in this title shall be construed as repealing or modi-
24 fying any Federal law, regulation, order or land use plan,
25 in effect prior to the date of enactment of this Act that

1 prohibits or restricts the application of the general mining
2 laws, including laws that provide for special management
3 criteria for operations under the general mining laws as
4 in effect prior to the date of enactment of this Act, to
5 the extent such laws provide environmental protection
6 greater than required under this title, and any such prior
7 law shall remain in force and effect with respect to claims
8 located (or proposed to be located) or converted under this
9 title. Nothing in this title shall be construed as applying
10 to or limiting mineral investigations, studies, or other min-
11 eral activities conducted by any Federal or State agency
12 acting in its governmental capacity pursuant to other au-
13 thority. Nothing in this title shall affect or limit any as-
14 sessment, investigation, evaluation or listing pursuant to
15 the Comprehensive Environmental Response, Compensa-
16 tion and Liability Act of 1980, or the Solid Waste Dis-
17 posal Act.

18 (b) EFFECT ON OTHER FEDERAL LAWS.—The provi-
19 sions of this title shall supersede the general mining laws,
20 but, except for the general mining laws, nothing in this
21 title shall be construed as superseding, modifying, amend-
22 ing or repealing any provision of Federal law not expressly
23 superseded, modified, amended or repealed by this title.
24 Nothing in this title shall be construed as altering, affect-
25 ing, amending, modifying, or changing, directly or indi-

1 rectly, any law which refers to and provides authorities
2 or responsibilities for, or is administered by, the Environ-
3 mental Protection Agency or the Administrator of the En-
4 vironmental Protection Agency, including the Federal
5 Water Pollution Control Act, title XIV of the Public
6 Health Service Act (the Safe Drinking Water Act), the
7 Clean Air Act, the Pollution Prevention Act of 1990, the
8 Toxic Substances Control Act, the Federal Insecticide,
9 Fungicide, and Rodenticide Act, the Federal Food, Drug,
10 and Cosmetic Act, the Motor Vehicle Information and
11 Cost Savings Act, the Federal Hazardous Substances Act,
12 the Atomic Energy Act, the Noise Control Act of 1972,
13 the Solid Waste Disposal Act, the Comprehensive Environ-
14 mental Response, Compensation, and Liability Act of
15 1980, the Superfund Amendments and Reauthorization
16 Act of 1986, the Ocean Dumping Act, the Environmental
17 Research, Development, and Demonstration Authorization
18 Act, the Pollution Prosecution Act of 1990, and the Fed-
19 eral Facilities Compliance Act of 1992, or any statute con-
20 taining amendment to any of such Acts. Nothing in this
21 title shall be construed as modifying or affecting any pro-
22 vision of the Native American Graves Protection and Re-
23 patriation Act (Public Law 101–601) or any provision of
24 the American Indian Religious Freedom Act (42 U.S.C.
25 1996).

1 (c) PROTECTION OF CONSERVATION AREAS.—In
2 order to protect the resources and values of National Con-
3 servation System units, the Secretary, as appropriate,
4 shall utilize authority under this title and other applicable
5 law to the fullest extent necessary to prevent mineral ac-
6 tivities within the boundaries of such units that could have
7 an adverse impact on the resources or values for which
8 such units were established.

9 **SEC. 253. AVAILABILITY OF PUBLIC RECORDS.**

10 Copies of records, reports, inspection materials or in-
11 formation obtained by the Secretary or the Secretary of
12 Agriculture under this title shall be made immediately
13 available to the public, consistent with section 552 of title
14 5 of the United States Code, in central and sufficient loca-
15 tions in the county, multi county, and State area of min-
16 eral activity or reclamation so that such items are conven-
17 iently available to residents in the area proposed or ap-
18 proved for mineral activities.

19 **SEC. 254. MISCELLANEOUS POWERS.**

20 (a) IN GENERAL.—In carrying out his or her duties
21 under this title, the Secretary, or for National Forest Sys-
22 tem lands the Secretary of Agriculture, may conduct any
23 investigation, inspection, or other inquiry necessary and
24 appropriate and may conduct, after notice, any hearing

1 or audit, necessary and appropriate to carrying out his
2 duties.

3 (b) ANCILLARY POWERS.—In connection with any
4 hearing, inquiry, investigation, or audit under this title,
5 the Secretary, or for National Forest System lands the
6 Secretary of Agriculture, is authorized to take any of the
7 following actions:

8 (1) Require, by special or general order, any
9 person to submit in writing such affidavits and an-
10 swers to questions as the Secretary concerned may
11 reasonably prescribe, which submission shall be
12 made within such reasonable period and under oath
13 or otherwise, as may be necessary.

14 (2) Administer oaths.

15 (3) Require by subpoena the attendance and
16 testimony of witnesses and the production of all
17 books, papers, records, documents, matter, and ma-
18 terials, as such Secretary may request.

19 (4) Order testimony to be taken by deposition
20 before any person who is designated by such Sec-
21 retary and who has the power to administer oaths,
22 and to compel testimony and the production of evi-
23 dence in the same manner as authorized under para-
24 graph (3) of this subsection.

1 (5) Pay witnesses the same fees and mileage as
2 are paid in like circumstances in the courts of the
3 United States.

4 (c) ENFORCEMENT.—In cases of refusal to obey a
5 subpoena served upon any person under this section, the
6 district court of the United States for any district in which
7 such person is found, resides, or transacts business, upon
8 application by the Attorney General at the request of the
9 Secretary concerned and after notice to such person, shall
10 have jurisdiction to issue an order requiring such person
11 to appear and produce documents before the Secretary
12 concerned. Any failure to obey such order of the court may
13 be punished by such court as contempt thereof and subject
14 to a penalty of up to \$10,000 a day.

15 (d) ENTRY AND ACCESS.—Without advance notice
16 and upon presentation of appropriate credentials, the Sec-
17 retary, or for National Forest System lands the Secretary
18 of Agriculture, or any authorized representative thereof—

19 (1) shall have the right of entry to, upon, or
20 through the site of any claim, mineral activities, or
21 any premises in which any records required to be
22 maintained under this title are located;

23 (2) may at reasonable times, and without delay,
24 have access to copy any records, inspect any moni-

1 toring equipment or method of operation required
2 under this title;

3 (3) may engage in any work and to do all
4 things necessary or expedient to implement and ad-
5 minister the provisions of this title;

6 (4) may, on any mining claim located or con-
7 verted under this title, and without advance notice,
8 stop and inspect any motorized form of transpor-
9 tation that he has probable cause to believe is car-
10 rying locatable minerals, concentrates, or products
11 derived therefrom from a claim site for the purpose
12 of determining whether the operator of such vehicle
13 has documentation related to such locatable min-
14 erals, concentrates, or products derived therefrom as
15 required by law, if such documentation is required
16 under this title; and

17 (5) may, if accompanied by any appropriate law
18 enforcement officer, or an appropriate law enforce-
19 ment officer alone may stop and inspect any motor-
20 ized form of transportation which is not on a claim
21 site if he has probable cause to believe such vehicle
22 is carrying locatable minerals, concentrates, or prod-
23 ucts derived therefrom from a claim site on Federal
24 lands or allocated to such claim site. Such inspection
25 shall be for the purpose of determining whether the

1 operator of such vehicle has the documentation re-
2 quired by law, if such documentation is required
3 under this title.

4 **SEC. 255. LIMITATION ON PATENT ISSUANCE.**

5 (a) MINING CLAIMS.—After April 30, 1999, no pat-
6 ent shall be issued by the United States for any mining
7 claim located under the general mining laws or under this
8 title unless the Secretary determines that, for the claim
9 concerned—

10 (1) a patent application was filed with the Sec-
11 retary on or before April 30, 1999; and

12 (2) all requirements established under sections
13 2325 and 2326 of the Revised Statutes (30 U.S.C.
14 29 and 30) for vein or lode claims and sections
15 2329, 2330, 2331, and 2333 of the Revised Statutes
16 (30 U.S.C. 35, 36, and 37) for placer claims were
17 fully complied with by that date.

18 If the Secretary makes the determinations referred to in
19 paragraphs (1) and (2) for any mining claim, the holder
20 of the claim shall be entitled to the issuance of a patent
21 in the same manner and degree to which such claim holder
22 would have been entitled to prior to the enactment of this
23 Act, unless and until such determinations are withdrawn
24 or invalidated by the Secretary or by a court of the United
25 States.

1 (b) MILL SITES.—After April 30, 1999, no patent
2 shall be issued by the United States for any mill site claim
3 located under the general mining laws unless the Secretary
4 determines that for the mill site concerned—

5 (1) a patent application for such land was filed
6 with the Secretary on or before April 30, 1999; and

7 (2) all requirements applicable to such patent
8 application were fully complied with by that date.

9 If the Secretary makes the determinations referred to in
10 paragraphs (1) and (2) for any mill site claim, the holder
11 of the claim shall be entitled to the issuance of a patent
12 in the same manner and degree to which such claim holder
13 would have been entitled to prior to the enactment of this
14 Act, unless and until such determinations are withdrawn
15 or invalidated by the Secretary or by a court of the United
16 States.

17 **SEC. 256. MULTIPLE MINERAL DEVELOPMENT AND SUR-**
18 **FACE RESOURCES.**

19 The provisions of sections 4 and 6 of the Act of Au-
20 gust 13, 1954 (30 U.S.C. 524 and 526), commonly known
21 as the Multiple Minerals Development Act, and the provi-
22 sions of section 4 of the Act of July 23, 1955 (30 U.S.C.
23 612), shall apply to all mining claims located or converted
24 under this title.

1 **SEC. 257. MINERAL MATERIALS.**

2 (a) DETERMINATIONS.—Section 3 of the Act of July
3 23, 1955 (30 U.S.C. 611), is amended as follows:

4 (1) Insert “(a)” before the first sentence.

5 (2) Insert “mineral materials, including but not
6 limited to” after “varieties of” in the first sentence.

7 (3) Strike “or cinders” and insert in lieu there-
8 of “cinders, and clay”.

9 (4) Add the following new subsection at the end
10 thereof:

11 “(b)(1) Subject to valid existing rights, after the date
12 of enactment of the Mineral Exploration and Development
13 Act of 1999, notwithstanding the reference to common va-
14 rieties in subsection (a) and to the exception to such term
15 relating to a deposit of materials with some property giv-
16 ing it distinct and special value, all deposits of mineral
17 materials referred to in such subsection, including the
18 block pumice referred to in such subsection, shall be sub-
19 ject to disposal only under the terms and conditions of
20 the Materials Act of 1947.

21 “(2) For purposes of paragraph (1), the term ‘valid
22 existing rights’ means that a mining claim located for any
23 such mineral material had some property giving it the dis-
24 tinct and special value referred to in subsection (a), or
25 as the case may be, met the definition of block pumice
26 referred to in such subsection, was properly located and

1 maintained under the general mining laws prior to the
2 date of enactment of the Mineral Exploration and Devel-
3 opment Act of 1999, and was supported by a discovery
4 of a valuable mineral deposit within the meaning of the
5 general mining laws as in effect immediately prior to the
6 date of enactment of the Mineral Exploration and Devel-
7 opment Act of 1999 and that such claim continues to be
8 valid under this Act.”.

9 (b) MINERAL MATERIALS DISPOSAL CLARIFICA-
10 TION.—Section 4 of the Act of July 23, 1955 (30 U.S.C.
11 612), is amended as follows:

12 (1) In subsection (b) insert “and mineral mate-
13 rial” after “vegetative”.

14 (2) In subsection (c) insert “and mineral mate-
15 rial” after “vegetative”.

16 (c) CONFORMING AMENDMENT.—Section 1 of the
17 Act of July 31, 1947, entitled “An Act to provide for the
18 disposal of materials on the public lands of the United
19 States” (30 U.S.C. 601 and following) is amended by
20 striking “common varieties of” in the first sentence.

21 (d) SHORT TITLES.—

22 (1) SURFACE RESOURCES.—The Act of July
23 23, 1955, is amended by inserting after section 7
24 the following new section:

1 “SEC. 8. This Act may be cited as the ‘Surface Re-
2 sources Act of 1955’.”.

3 (2) MINERAL MATERIALS.—The Act of July 31,
4 1947, entitled “An Act to provide for the disposal of
5 materials on the public lands of the United States”
6 (30 U.S.C. 601 and following) is amended by insert-
7 ing after section 4 the following new section:

8 “SEC. 5. This Act may be cited as the ‘Materials Act
9 of 1947’.”.

10 (e) REPEALS.—(1) Subject to valid existing rights,
11 the Act of August 4, 1892 (27 Stat. 348, 30 U.S.C. 161)
12 commonly known as the Building Stone Act is hereby re-
13 pealed.

14 (2) Subject to valid existing rights, the Act of Janu-
15 ary 31, 1901 (30 U.S.C. 162) commonly known as the
16 Saline Placer Act is hereby repealed.

17 **SEC. 258. APPLICATION OF ACT TO BENEFICIATION AND**
18 **PROCESSING OF NONFEDERAL MINERALS ON**
19 **FEDERAL LANDS.**

20 The provisions of this title (including the surface
21 management requirements of subtitle B) shall apply in the
22 same manner and to the same extent to Federal lands
23 used for beneficiation or processing activities for any min-
24 eral without regard to whether or not the legal and bene-
25 ficial title to the mineral is held by the United States. This

1 section applies only to minerals which are locatable min-
2 erals or minerals which would be locatable minerals if the
3 legal and beneficial title to such minerals were held by the
4 United States.

5 **SEC. 259. COMPLIANCE WITH BUY AMERICAN ACT.**

6 No funds appropriated pursuant to this title may be
7 expended by an entity unless the entity agrees that in ex-
8 pending the funds the entity will comply with section 2
9 through 4 of the Act of March 3, 1933 (41 U.S.C. 10a-
10 10c), popularly known as the “Buy American Act”.

11 **SEC. 260. SENSE OF CONGRESS.**

12 In the case of any equipment or products purchased
13 with funding provided under this title, it is the sense of
14 the Congress that such funding should be used to pur-
15 chase only American-made equipment and products.

16 **SEC. 261. PROHIBITION OF CONTRACTS.**

17 If it has been finally determined by a court of Federal
18 agency that any person intentionally affixed a label bear-
19 ing a “Made in America” inscription, or any inscription
20 with the same meaning, to any product sold in or shipped
21 to the United States that is not made in the United
22 States, such person shall be ineligible to receive any con-
23 tract or subcontract made with funds provided pursuant
24 to this title, pursuant to the debarment, suspension, and

1 ineligibility procedures described in sections 9.400 through
2 9.409 of title 48 of the Code of Federal Regulations.

3 **SEC. 262. SEVERABILITY.**

4 If any provision of this title or the applicability there-
5 of to any person or circumstances is held invalid, the re-
6 mainder of this title and the application of such provision
7 to other persons or circumstances shall not be affected
8 thereby.

9 **SEC. 263. AWARD OF COMPENSATION FOR TAKINGS FROM**
10 **FUND.**

11 To the extent a court of competent jurisdiction, after
12 adjudication, finds that Federal action undertaken pursu-
13 ant to this title effects a taking under the Fifth Amend-
14 ment of the United States Constitution and enters a final
15 judgment against the United States, the court shall award
16 just compensation to the plaintiff, from the fund estab-
17 lished under subtitle C, subject to appropriation, together
18 with appropriate reasonable fees and expenses to the ex-
19 tent provided by section 304 of the Uniform Relocation
20 Assistance and Real Property Acquisition Policies Act of
21 1970 (42 U.S.C. 4654(c)). In any case in which the Attor-
22 ney General effects a settlement of any proceeding brought
23 under section 1346(a)(2) or 1491 of title 28 of the United
24 States Code alleging that any Federal action undertaken
25 pursuant to this title effects a taking under the Fifth

1 Amendment of the United States Constitution, the Attor-
2 ney General shall use amounts available in the Fund sub-
3 ject to appropriations to pay any award necessary pursu-
4 ant to such settlement.

5 **SEC. 264. REPORT TO CONGRESS ON MINING CLAIMS IN**
6 **THE UNITED STATES HELD BY FOREIGN**
7 **FIRMS.**

8 (a) REPORT.—Not later than one year after the date
9 of enactment of this Act and annually thereafter, the Sec-
10 retary of the Interior shall submit a report to the Congress
11 describing the percentage of each mining claim held by
12 a foreign firm.

13 (b) FOREIGN FIRM.—(1) For the purposes of this
14 section, the term “foreign firm” means any firm that is
15 not a domestic firm.

16 (2) For the purposes of paragraph (1), the term “do-
17 mestic firm” means a business entity—

18 (A) that is incorporated or organized in the
19 United States;

20 (B) that conducts business operations in the
21 United States; and

22 (C) the assets of which at least 50 percent are
23 held by United States citizens, permanent resident
24 aliens, or other domestic firms.

1 **TITLE III—REVENUES DEDI-**

4 **SEC. 301. DEFICIT REDUCTION LOCK-BOX.**

5 No changes in revenues or direct spending estimated
6 to result from the enactment of this Act shall be counted
7 for purposes of section 252(d) of the Balanced Budget and
8 Emergency Deficit Control Act of 1985.
