To authorize appropriations for the United States Fire Administration for fiscal years 2000 and 2001, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

1 SECTION 1. SHORT TITLE.

- 2 This Act may be cited as the "Fire Administration
- 3 Authorization Act of 1999".
- 4 SEC. 2. AUTHORIZATION OF APPROPRIATIONS.
- 5 Section 17 of the Federal Fire Prevention and Con-
- 6 trol Act of 1974 (15 U.S.C. 2216) is amended to read
- 7 as follows:
- 8 "AUTHORIZATION OF APPROPRIATIONS
- 9 "Sec. 17. Except as otherwise specifically provided
- 10 with respect to the payment of claims under section 11
- 11 of this Act, there are authorized to be appropriated to
- 12 carry out the purposes of this Act—
- "(1) \$30,554,000 for fiscal year 1999;
- "(2) \$46,130,000 for fiscal year 2000, of which
- \$2,200,000 shall be used for research activities, and
- \$250,000 shall be used for contracts or grants to
- 17 non-Federal entities for data analysis, including gen-
- eral fire profiles and special fire analyses and report
- projects, and of which \$6,000,000 shall be for anti-
- terrorism training, including associated curriculum
- development, for fire and emergency services per-
- sonnel; and
- 23 "(3) \$49,500,000 for fiscal year 2001, of which
- \$3,000,000 shall be used for research activities, and
- \$250,000 shall be used for contracts or grants to
- 26 non-Federal entities for data analysis, including gen-

- 1 eral fire profiles and special fire analyses and report
- 2 projects, and of which \$8,000,000 shall be for anti-
- 3 terrorism training, including associated curriculum
- 4 development, for fire and emergency services per-
- 5 sonnel.
- 6 None of the funds authorized by paragraph (3) may be
- 7 obligated unless the Administrator has certified to the
- 8 Committee on Science of the House of Representatives
- 9 and the Committee on Commerce, Science, and Transpor-
- 10 tation of the Senate that the obligation of funds is con-
- 11 sistent with the strategic plan transmitted under section
- 12 3 of the Fire Administration Authorization Act of 1999.".
- 13 SEC. 3. STRATEGIC PLAN.
- 14 (a) REQUIREMENT.—Not later than April 30, 2000,
- 15 the Administrator of the United States Fire Administra-
- 16 tion shall prepare and transmit to the Committee on
- 17 Science of the House of Representatives and the Com-
- 18 mittee on Commerce, Science, and Transportation of the
- 19 Senate a 5-year strategic plan of program activities for
- 20 the United States Fire Administration.
- 21 (b) Contents of Plan.—The plan required by sub-
- 22 section (a) shall include—
- 23 (1) a comprehensive mission statement covering
- the major functions and operations of the United
- 25 States Fire Administration in the areas of training,

- research, data collection and analysis, and public education;
 - (2) general goals and objectives, including those related to outcomes, for the major functions and operations of the United States Fire Administration;
 - (3) a description of how the goals and objectives identified under paragraph (2) are to be achieved, including operational processes, skills and technology, and the human, capital, information, and other resources required to meet those goals and objectives;
 - (4) an identification of the fire-related activities of the National Institute of Standards and Technology, the Department of Defense, and other Federal agencies, and a discussion of how those activities can be coordinated with and contribute to the achievement of the goals and objectives identified under paragraph (2);
 - (5) a description of objective, quantifiable performance goals needed to define the level of performance achieved by program activities in training, research, data collection and analysis, and public education, and how these performance goals relate to the general goals and objectives in the strategic plan;

- 1 (6) an identification of key factors external to 2 the United States Fire Administration and beyond 3 its control that could affect significantly the achieve-4 ment of the general goals and objectives;
 - (7) a description of program evaluations used in establishing or revising general goals and objectives, with a schedule for future program evaluations;
 - (8) a plan for the timely distribution of information and educational materials to State and local firefighting services, including volunteer, career, and combination services throughout the United States;
 - (9) a description of how the strategic plan prepared under this section will be incorporated into the strategic plan and the performance plans and reports of the Federal Emergency Management Agency; and
 - (10)(A) a description of the current and planned use of the Internet for the delivery of training courses by the National Fire Academy, including a listing of the types of courses and whether they provide real time interaction between instructor and students, and including the number of students enrolled, and the geographic distribution of students, for the most recent fiscal year;

1 (B) an assessment of the availability and actual
2 use by the National Fire Academy of Federal facili3 ties suitable for distance education applications, in4 cluding facilities with teleconferencing capabilities;
5 and

(C) an assessment of the benefits and problems associated with delivery of instructional courses using the Internet, including limitations due to network bandwidth at training sites, the availability of suitable course materials, and the effectiveness of such courses in terms of student performance.

12 SEC. 4. RESEARCH AGENDA.

13 (a) REQUIREMENT.—Not later than 120 days after the date of the enactment of this Act, the Administrator 14 15 of the United States Fire Administration, in consultation with the Director of the Federal Emergency Management 16 Agency, the Director of the National Institute of Stand-17 ards and Technology, representatives of trade associa-18 19 tions, State and local firefighting services, and other appropriate entities, shall prepare and transmit to the Com-21 mittee on Science of the House of Representatives and the Committee on Commerce, Science, and Transportation of 22 23 the Senate a report describing the United States Fire Administration's research agenda and including a plan for implementing that agenda.

1	(b) Contents of Report.—The report required by
2	subsection (a) shall—
3	(1) identify research priorities;
4	(2) describe how the proposed research agenda
5	will be coordinated and integrated with the programs
6	and capabilities of the National Institute of Stand-
7	ards and Technology, the Department of Defense,
8	and other Federal agencies;
9	(3) identify potential roles of academic and
10	other research institutions in achieving the research
11	agenda;
12	(4) provide cost estimates, anticipated per-
13	sonnel needs, and a schedule for completing the var-
14	ious elements of the research agenda;
15	(5) describe ways to leverage resources through
16	partnerships, cooperative agreements, and other
17	means; and
18	(6) discuss how the proposed research agenda
19	will enhance training, improve State and local fire-
20	fighting services, impact standards and codes, in-
21	crease firefighter and public safety, and advance
22	firefighting techniques.
23	(c) USE IN PREPARING STRATEGIC PLAN.—The re-
24	search agenda prepared under this section shall be used

- 1 in the preparation of the strategic plan required by section
- 2 3.
- 3 SEC. 5. SURPLUS AND EXCESS FEDERAL EQUIPMENT.
- 4 The Federal Fire Prevention and Control Act of 1974
- 5 is amended by adding at the end the following new section:
- 6 "SEC. 33. SURPLUS AND EXCESS FEDERAL EQUIPMENT.
- 7 "The Administrator shall make publicly available, in-
- 8 cluding through the Internet, information on procedures
- 9 for acquiring surplus and excess Federal fire, emergency,
- 10 hazardous material, or other equipment or property that
- 11 may be useful to State and local fire and emergency serv-
- 12 ices.".
- 13 SEC. 6. COOPERATIVE AGREEMENTS WITH FEDERAL FA-
- 14 CILITIES.
- 15 The Federal Fire Prevention and Control Act of 1974
- 16 is amended by adding at the end the following new section:
- 17 "SEC. 34. COOPERATIVE AGREEMENTS WITH FEDERAL FA-
- 18 CILITIES.
- 19 "The Administrator shall make publicly available, in-
- 20 cluding through the Internet, information on procedures
- 21 for establishing cooperative agreements between State and
- 22 local fire and emergency services and Federal facilities in
- 23 their region relating to the provision of fire and emergency
- 24 services.".

1 SEC. 7. MISCELLANEOUS REPEALS.

2	The Federal Fire Prevention and Control Act of 1974
3	is amended—
4	(1) by repealing section 10(b) and redesignating
5	subsection (c) of that section as subsection (b);
6	(2) by repealing section 23;
7	(3) in section 24—
8	(A) by striking "(a) The" and inserting
9	"The"; and
10	(B) by repealing subsection (b);
11	(4) by repealing section 26; and
12	(5) by repealing section 27.
13	SEC. 8. NEED FOR ADDITIONAL TRAINING IN
14	COUNTERTERRORISM.
15	(a) In General.—The Administrator of the United
16	States Fire Administration shall conduct an assessment
17	of the need for additional capabilities for Federal
18	counterterrorism training of emergency response per-
19	sonnel.
20	(b) Contents of Assessment.—The assessment
21	conducted under this section shall include—
22	(1) a review of the counterterrorism training
23	programs offered by the United States Fire Admin-
24	istration and other Federal agencies;
25	(2) an estimate of the number and types of
26	emergency response personnel that have, during the

- 1 period between January 1, 1994, and June 1, 1999,
- 2 sought training described in paragraph (1), but have
- 3 been unable to receive that training as a result of
- 4 the oversubscription of the training capabilities; and
- 5 (3) a recommendation on the need to provide
- 6 additional Federal counterterrorism training centers,
- 7 including—
- 8 (A) an analysis of existing Federal facili-
- 9 ties that could be used as counterterrorism
- training facilities; and
- 11 (B) a cost-benefit analysis of the establish-
- ment of counterterrorism training facilities in
- regions where many applicants for such training
- reside.
- 15 (c) Report.—Not later than 180 days after the date
- 16 of the enactment of this Act, the Administrator shall pre-
- 17 pare and submit to the Congress a report on the results
- 18 of the assessment conducted under this section.

19 SEC. 9. NATIONAL FIRE ACADEMY CURRICULUM REVIEW.

- 20 (a) In General.—The Administrator of the United
- 21 States Fire Administration, in consultation with the
- 22 Board of Visitors and representatives of trade and profes-
- 23 sional associations, State and local firefighting services,
- 24 and other appropriate entities, shall conduct a review of
- 25 the courses of instruction available at the National Fire

- 1 Academy to ensure that they are up-to-date and com-
- 2 plement, not duplicate, courses of instruction offered else-
- 3 where. Not later than 180 days after the date of enact-
- 4 ment of this Act, the Administrator shall prepare and sub-
- 5 mit a report to the Committee on Science of the House
- 6 of Representatives and the Committee on Commerce,
- 7 Science, and Transportation of the Senate.
- 8 (b) Contents of Report.—The report required by
- 9 subsection (a) shall—
- 10 (1) examine and assess the courses of instruc-
- tion offered by the National Fire Academy;
- 12 (2) identify redundant and out-of-date courses
- of instruction;
- 14 (3) examine the current and future impact of
- information technology on National Fire Academy
- 16 curricula, methods of instruction, and delivery of
- 17 services; and
- 18 (4) make recommendations for updating the
- 19 curriculum, methods of instruction, and delivery of
- services by the National Fire Academy considering
- current and future needs, State-based curricula, ad-
- vances in information technologies, and other rel-
- evant factors.

1 SEC. 10. INTERNET AVAILABILITY OF INFORMATION.

- 2 The Administrator of the United States Fire Admin-
- 3 istration shall make available through the Internet home
- 4 page of the United States Fire Administration the ab-
- 5 stracts relating to all research grants and awards made
- 6 with funds authorized by the amendments made by this
- 7 Act. Nothing in this section shall be construed to require
- 8 or permit the release of any information prohibited by law
- 9 or regulation from being released to the public.
- 10 SEC. 11. REPEAL OF EXCEPTION TO FIRE SAFETY REQUIRE-
- 11 MENT.
- 12 (a) Repeal.—Section 4 of Public Law 103–195 (107)
- 13 Stat. 2298) is hereby repealed.
- 14 (b) Effective Date.—Subsection (a) shall take ef-
- 15 fect 1 year after the date of the enactment of this section.
