9 (b) **AUTHORIZED METHODS OF ACQUISITION.**—

10 (1) **ACQUISITION OF CERTAIN LANDS BY DONA-**
 11 **TION.**—Section 3(a) of Public Law 101–214 (16
 12 U.S.C. 4251(a)) is amended by adding at the end the
 13 following new sentence: “However, the lands des-
 14 ignated ‘P04–04’ on the map referred to in section
 15 2(a) numbered 326–40072E/89/A and dated Sep-
 16 tember 1990 may be acquired only by donation.”

17 (2) **REMOVAL OF RESTRICTION ON ACQUISITION**

11 (A) by striking “The Secretary” and insert-
12 ing “(1) Except as provided in paragraph (2),
13 the Secretary”; and

14 (B) by adding at the end the following new
15 paragraph:

16 “(2) The lands designated ‘P04–04’ on the map re-
17 ferred to in section 2(a) numbered 326–40072E/89/A and
18 dated September 1990 may be acquired only by donation,
19 and the lands designated ‘P04–01’, ‘P04–02’, and ‘P04–03’
20 on such map may be acquired only by donation, purchase
21 from willing sellers, or exchange.”.
