

In the Senate of the United States,

October 5 (legislative day, September 22), 2000.

Resolved, That the bill from the House of Representatives (H.R. 1695) entitled “An Act to provide for the conveyance of certain Federal public lands in the Ivanpah Valley, Nevada, to Clark County, Nevada, for the development of an airport facility, and for other purposes.”, do pass with the following

AMENDMENTS:

1 **(1)**Page 2, lines 24 and 25, strike out **[assessment]** and
2 insert: *assessment, using the airspace management plan re-*
3 *quired by section 4(a),*

4 **(2)**Page 3, strike out lines 15 through 22 and insert:

5 (2) *DEPOSIT IN SPECIAL ACCOUNT.—(A) The*
6 *Secretary shall deposit the payments received under*
7 *paragraph (1) into the special account described in*
8 *section 4(e)(1)(C) of the Southern Nevada Public*
9 *Land Management Act of 1998 (112 Stat. 2345).*
10 *Such funds may be expended only for the acquisition*

1 *of private inholdings in the Mojave National Preserve*
 2 *and for the protection and management of the*
 3 *petroglyph resources in Clark County, Nevada. The*
 4 *second sentence of section 4(f) of such Act (112 Stat.*
 5 *2346) shall not apply to interest earned on amounts*
 6 *deposited under this paragraph.*

7 *(B) The Secretary may not expend funds pursu-*
 8 *ant to this section until—*

9 *(i) the provisions of section 5 of this Act*
 10 *have been completed; and*

11 *(ii) a final Record of Decision pursuant to*
 12 *the National Environmental Policy Act of 1969*
 13 *(42 U.S.C. 4321 et seq.) has been issued which*
 14 *permits development of an airport at the*
 15 *Ivanpah site.*

16 **(3)**Page 3, strike out all after line 22 over to and includ-
 17 ing line 2 on page 4 and insert:

18 *(d) REVERSION AND REENTRY.—If, following comple-*
 19 *tion of compliance with section 5 of this Act and in accord-*
 20 *ance with the findings made by the actions taken in compli-*
 21 *ance with such section, the Federal Aviation Administra-*
 22 *tion and the County determine that an airport should not*
 23 *be constructed on the conveyed lands—*

1 **(4)**Page 4, line 23, strike out **[Secretary,]** and insert:
2 *Secretary, prior to the conveyance of the land referred to*
3 *in section 2(a),*

4 **(5)**Page 5, line 18, after “agencies.” insert: *Any actions*
5 *conducted in accordance with this section shall specifically*
6 *address any impacts on the purposes for which the Mojave*
7 *National Preserve was created.*
