A BILL

To amend the Agricultural Trade Act of 1978 to require the President to report to Congress on any selective embargo on agricultural commodities, to provide a termination date for the embargo, to provide greater assurances for contract sanctity, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Selective Agricultural
 5 Embargoes Act of 1999”.

6 **SEC. 2. REPORTING ON SELECTIVE EMBARGOES.**

7 The Agricultural Trade Act of 1978 (7 U.S.C. 5711
 8 et seq.) is amended by adding at the end of title VI:

9 **“SEC. 604. REPORTING ON SELECTIVE EMBARGOES.**

10 “(a) REPORT.—If the President takes any action,
 11 pursuant to statutory authority, to embargo the export
 12 under an export sales contract (as defined in subsection
 13 (e)) of an agricultural commodity to a country that is not

1 part of an embargo on all exports to the country, not later
2 than 5 days after imposing the embargo, the President
3 shall submit a report to Congress that sets forth in detail
4 the reasons for the embargo and specifies the proposed
5 period during which the embargo will be effective.

6 “(b) APPROVAL OF EMBARGO.—If a joint resolution
7 approving the embargo becomes law during the 100-day
8 period beginning on the date of receipt of the report pro-
9 vided for in subsection (a), the embargo shall terminate
10 on the earlier of—

11 “(1) a date determined by the President; or

12 “(2) the date that is 1 year after the date of
13 enactment of the joint resolution approving the em-
14 bargo.

15 “(c) DISAPPROVAL OF EMBARGO.—If a joint resolu-
16 tion disapproving the embargo becomes law during the
17 100-day period referred to in subsection (b), the embargo
18 shall terminate on the expiration of the 100-day period.

19 “(d) EXCEPTION.—Notwithstanding any other provi-
20 sion of this section, an embargo may take effect and con-
21 tinue in effect during any period in which the United
22 States is in a state of war declared by Congress or na-
23 tional emergency, requiring such action, declared by the
24 President.

25 “(e) DEFINITIONS.—As used in this section—

1 “(1) the term ‘agricultural commodity’ includes
2 plant nutrient materials;

3 “(2) the term ‘under an export sales contract’
4 means under an export sales contract entered into
5 before the President has transmitted to Congress no-
6 tice of the proposed embargo; and

7 “(3) the term ‘embargo’ includes any prohibi-
8 tion or curtailment.”.

9 **SEC. 3. ADDITION OF PLANT NUTRIENT MATERIALS TO**
10 **PROTECTION OF CONTRACT SANCTITY.**

11 Section 602(c) of the Agricultural Trade Act of 1978
12 (7 U.S.C. 5712(c)) is amended by inserting “(including
13 plant nutrient materials)” after “agricultural commodity”
14 each place it appears.
