- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

1 SECTION 1. SHORT TITLE.

- 2 This Act may be cited as the "Stalking Prevention
- 3 and Victim Protection Act of 1999".
- 4 SEC. 2. EXPANSION OF THE PROHIBITION ON STALKING.
- 5 (a) IN GENERAL.—Section 2261A of title 18, United
- 6 States Code, is amended to read as follows:

7 "§ **2261A.** Stalking

- 8 "(a) Whoever—
- 9 "(1) for the purpose of stalking an individual,
- travels or causes another to travel in interstate or
- foreign commerce, uses or causes another to use the
- mail or any facility in interstate or foreign com-
- merce, or enters or leaves, or causes another to
- enter or leave, Indian country; or
- 15 "(2) within the special maritime and territorial
- jurisdiction of the United States or within Indian
- 17 country, stalks an individual,
- 18 shall be punished as provided in section 2261.
- "(b) For purposes of this section, a person stalks an
- 20 individual if that person engages in conduct—
- 21 "(1) with the intent to injure or harass the in-
- dividual; and
- "(2) that places the individual in reasonable
- fear of the death of, or serious bodily injury (as de-
- 25 fined for the purposes of section 2119) to, that indi-
- vidual, a member of that individual's immediate

- family (as defined in section 115), or that individ-
- 2 ual's intimate partner.
- 3 "(c) The court shall at the time of sentencing for an
- 4 offense under this section issue an appropriate protection
- 5 order designed to protect the victim from further stalking
- 6 by the convicted person. Such an order shall remain in
- 7 effect for such time as the court deems necessary, and may
- 8 be modified, extended or terminated at any time after no-
- 9 tice to the victim and opportunity for a hearing.".
- 10 (b) DETENTION PENDING TRIAL.—Section
- 11 3156(a)(4)(C) of title 18, United States Code, is amended
- 12 by inserting ", or section 2261A" after "117".
- 13 (c) Clerical Amendment.—The table of sections
- 14 at the beginning of chapter 110A of title 18, United States
- 15 Code, is amended by striking the item relating to section
- 16 2261A and inserting the following:

"2261A. Stalking.".
