## A BILL

To reauthorize the Junior Duck Stamp Conservation and  
Design Program Act of 1994.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1 **SECTION 1. REAUTHORIZATION OF JUNIOR DUCK STAMP**  
2 **CONSERVATION AND DESIGN PROGRAM ACT**  
3 **OF 1994.**

4 Section 5 of the Junior Duck Stamp Conservation  
5 and Design Program Act of 1994 (16 U.S.C. 719c) is  
6 amended by striking “for each of the fiscal years 1995  
7 through 2000” and inserting “for each of the fiscal years  
8 2001 through 2005”.

9 **SECTION 1. REAUTHORIZATION OF JUNIOR DUCK STAMP**  
10 **CONSERVATION AND DESIGN PROGRAM ACT**  
11 **OF 1994.**

12 *Section 5 of the Junior Duck Stamp Conservation and*  
13 *Design Program Act of 1994 (16 U.S.C. 719c) is amended*  
14 *by striking “for each of the fiscal years 1995 through 2000”*  
15 *and inserting “for each of the fiscal years 2001 through*  
16 *2005”.*

17 **SEC. 2. EXPANSION OF PROGRAM TO INSULAR AREAS.**

18 *The Junior Duck Stamp Conservation and Design*  
19 *Program Act of 1994 is amended—*

20 *(1) in section 2(c) (16 U.S.C. 719(c)) by striking*  
21 *“50 States” each place it appears and inserting*  
22 *“States”;*

23 *(2) by redesignating section 5 (16 U.S.C. 719c),*  
24 *as amended by section 1 of this Act, as section 6; and*

25 *(3) by inserting after section 4 the following:*

1 **“SEC. 5. DEFINITION OF STATE.**

2       *“For the purposes of this Act, the term ‘State’ includes*  
3 *the District of Columbia, the Commonwealth of Puerto Rico,*  
4 *the Commonwealth of the Northern Mariana Islands, Amer-*  
5 *ican Samoa, Guam, the Virgin Islands, and any other terri-*  
6 *tory or possession of the United States.”.*
