2	Congress finds that—
3	(1) it is estimated that at least 5 percent of the
4	Nation's elderly are victims of moderate to severe
5	abuse and that the rate for all forms of abuse may
6	be as high as 10 percent;
7	(2) elder abuse takes on many forms, including
8	physical abuse, sexual abuse, psychological (emo-
9	tional) abuse, neglect (intended or unintended), and
10	financial exploitation;
11	(3) of the more than $1,000,000$ persons age 65
12	and over who are victims of abuse each year, at least
13	two-thirds are women;
14	(4) the number of reports of elder abuse in the
15	United States increased by 150 percent between
16	1986 and 1996 and is expected to continue growing;
17	(5) elder abuse is severely underreported, with
18	only a fraaction of cases reported, according to the
19	most recent studies;
20	(6) many older or disabled persons, particularly
21	women and minorities, fail to report abuse because
22	of shame, privacy concerns, or as a result of prior
23	unsatisfactory experiences with individuals, agencies

1	or others who lacked sensitivity to the concerns or
2	needs of older or disabled people;
3	(7) many older or disabled persons fail to re-
4	port abuse because they are dependent on their
5	abusers and fear being abandoned or institutional-
6	ized;
7	(8) public and professional awareness and iden-
8	tification of elder abuse is difficult because older or
9	disabled persons are not tied into many social net-
10	works (such as schools or jobs), and may become
11	isolated in their homes, which can increase the risk
12	of elder abuse;
13	(9) there are relatively few statistics and re-
14	search studies regarding violence against older or
15	disabled persons; and
16	(10) older or disabled persons would greatly
17	benefit from policies that develop, strengthen, and
18	implement programs for the prevention of abuse, in-
19	cluding neglect and exploitation, and provide related
20	assistance for victims.

- "(C) Referring the victims to public and nonprofit private entities that provide services for such victims.

porting suspected financial exploitation of an older or disabled individual to State, Federal, or local law enforce-3 ment entities, or government-regulated adult protective 4 services entities. Such report may include only the name or other identifying information concerning an older or disabled individual, the account involved, and the nature 6 of any suspected financial exploitation, including pertinent 8 documentation. Any financial institution, or officer, employee, or agent thereof, making a disclosure of informa-10 tion and documentation pursuant to this paragraph shall not be liable to the customer under any law or regulation 12 of the United States or any constitution, law, or regulation of any State or political subdivision thereof, for such disclosure. For purposes of this paragraph, the term "older 14 15 or disabled individual" means an individual who is 65 years of age or older or disabled, and the term "exploitation" means any fraud, abuse, or other conduct that constitutes a violation of any Federal or State law, includ-18 ing any legally enforceable professional standard applica-19 ble with regard to any profession or occupation, and the 21 unauthorized use of an older or disabled individual's funds, property, or resources for another person's profit 23 or advantage.".
