**AN ACT**To make technical corrections to the Water Resources  
Development Act of 1999.

1       *Be it enacted by the Senate and House of Representa-*  
 2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. ENVIRONMENTAL INFRASTRUCTURE.**

4       (a) ~~JACKSON COUNTY, MISSISSIPPI.—Section 219 of~~

3           (2) by striking subsection (e)(5) and inserting:

4           “(5) JACKSON COUNTY, MISSISSIPPI.—Provi-  
5 sion of an alternative water supply and a project for  
6 the elimination or control of combined sewer over-  
7 flows for Jackson County, Mississippi.”.

8           (b) ELIZABETH AND NORTH HUDSON, NEW JER-  
9 SEY.—Subsection (f) of section 219 of the Water Re-  
10 sources Development Act of 1992 is amended—

11           (1) in paragraph (33) by striking  
12 “\$20,000,000” and inserting “\$10,000,000”;

13           (2) in paragraph (34) by striking  
14 “\$10,000,000” and inserting “\$20,000,000”; and

15           (3) in paragraph (34) by striking “city of  
16 North Hudson” and inserting “for the North Hud-  
17 son Sewerage Authority”.

18 **SECTION 1. ENVIRONMENTAL INFRASTRUCTURE.**

19           (a) JACKSON COUNTY, MISSISSIPPI.—Section 219 of  
20 the Water Resources Development Act of 1992 (106 Stat.  
21 4835; 110 Stat. 3757) is amended—

22           (1) in subsection (c), by striking paragraph (5)  
23 and inserting the following:

24           “(5) JACKSON COUNTY, MISSISSIPPI.—Provision  
25 of an alternative water supply and a project for the

2 *Jackson County, Mississippi.”; and*

3 (2) *in subsection (e)(1), by striking*  
4 *“\$10,000,000” and inserting “\$20,000,000”.*

5 (b) *MANCHESTER, NEW HAMPSHIRE.—Section*  
6 *219(e)(3) of the Water Resources Development Act of 1992*  
7 *(106 Stat. 4835; 110 Stat. 3757) is amended by striking*  
8 *“\$10,000,000” and inserting “\$30,000,000”.*

9 (c) *ATLANTA, GEORGIA.—Section 219(f)(1) of the*  
10 *Water Resources Development Act of 1992 (106 Stat. 4835;*  
11 *113 Stat. 335) is amended by striking “\$25,000,000 for”.*

12 (d) *PATERSON, PASSAIC COUNTY, AND PASSAIC VAL-*  
13 *LEY, NEW JERSEY.—Section 219(f)(2) of the Water Re-*  
14 *sources Development Act of 1992 (106 Stat. 4835; 113 Stat.*  
15 *335) is amended by striking “\$20,000,000 for”.*

16 (e) *ELIZABETH AND NORTH HUDSON, NEW JERSEY.—*  
17 *Section 219(f) of the Water Resources Development Act of*  
18 *1992 (106 Stat. 4835; 113 Stat. 335) is amended—*

19 (1) *in paragraph (33), by striking*  
20 *“\$20,000,000” and inserting “\$10,000,000”; and*

21 (2) *in paragraph (34)—*

22 (A) *by striking “\$10,000,000” and inserting*  
23 *“\$20,000,000”; and*

1                   (B) by striking “in the city of North Hud-  
2                   son” and inserting “for the North Hudson Sew-  
3                   erage Authority”.

4 **SEC. 2. UPPER MISSISSIPPI RIVER ENVIRONMENTAL MAN-**  
5 **AGEMENT PROGRAM.**

6           Section 1103(e)(5) of the Water Resources Development  
7 Act of 1986 (33 U.S.C. 652(e)(5)) (as amended by section  
8 509(c)(3) of the Water Resources Development Act of 1999  
9 (113 Stat. 340)) is amended by striking “paragraph  
10 (1)(A)(i)” and inserting “paragraph (1)(B)”.

11 **SEC. 3. DELAWARE RIVER, PENNSYLVANIA AND DELAWARE.**

12           Section 346 of the Water Resources Development Act  
13 of 1999 (113 Stat. 309) is amended by striking “economy-  
14 cally acceptable” and inserting “environmentally accept-  
15 able”.

16 **SEC. 4. PROJECT REAUTHORIZATIONS.**

17           Section 364 of the Water Resources Development Act  
18 of 1999 (113 Stat. 313) is amended—

19                   (1) by striking “Each” and inserting “Subject to  
20                   section 1001(b)(2) of the Water Resources Develop-  
21                   ment Act of 1986 (33 U.S.C. 579a(b)(2)), each”;

22                   (2) by striking paragraph (1); and

23                   (3) by redesignating paragraphs (2) through (6)  
24                   as paragraphs (1) through (5), respectively.

1 **SEC. 5. SHORE PROTECTION.**

2        *Section 103(d)(2)(A) of the Water Resources Develop-*  
3 *ment Act of 1986 (33 U.S.C. 2213(d)(2)(A)) (as amended*  
4 *by section 215(a)(2) of the Water Resources Development*  
5 *Act of 1999 (113 Stat. 292)) is amended by striking “or*  
6 *for which a feasibility study is completed after that date,”*  
7 *and inserting “except for a project for which a District En-*  
8 *gineer’s Report is completed by that date,”.*

9 **SEC. 6. DAM SAFETY.**

10        *Section 504(a)(2) of the Water Resources Development*  
11 *Act of 1999 (113 Stat. 338) is amended by inserting “No.*  
12 *5” after “Dam”.*
