A BILL

- To amend the Elementary and Secondary Education Act of 1965 to provide up-to-date school library media resources and well-trained, professionally certified school library media specialists for elementary schools and secondary schools, and for other purposes.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,

3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Elementary and Sec5 ondary School Library Media Resources, Training, and
6 Advanced Technology Assistance Act".

1 SEC. 2. PURPOSE.

2 The purposes of this Act are—

3 (1) to improve academic achievement of stu4 dents by providing students with increased access to
5 up-to-date school library materials, a well-equipped,
6 technologically advanced school library media center,
7 and well-trained, professionally certified school li8 brary media specialists;

9 (2) to support the acquisition of up-to-date 10 school library media resources for the use of stu-11 dents, school library media specialists, and teachers 12 in elementary schools and secondary schools;

(3) to provide school library media specialists
with the tools and training opportunities necessary
for the specialists to facilitate the development and
enhancement of the information literacy, information
retrieval, and critical thinking skills of students; and
(4)(A) to ensure the effective coordination of
resources for library, technology, and professional

20 development activities for elementary schools and
21 secondary schools; and

(B) to ensure collaboration between school library media specialists, and elementary school and
secondary school teachers and administrators, in developing curriculum-based instructional activities for

9 "Subpart 1—Library Media Resources

10 "SEC. 3701. STATE ALLOTMENTS.

11 "The Secretary shall allot to each eligible State educational agency for a fiscal year an amount that bears the 12 same relation to the amount appropriated under section 13 14 3710 and not reserved under section 3709 for the fiscal 15 year as the amount the State educational agency received under part A of title I for the preceding fiscal year bears 16 17 to the amount all State educational agencies received under part A of title I for the preceding fiscal year. 18

19 "SEC. 3702. STATE APPLICATIONS.

20 "To be eligible to receive an allotment under section 21 3701 for a State for a fiscal year, the State educational 22 agency shall submit to the Secretary an application at 23 such time, in such manner, and containing such informa-24 tion as the Secretary shall require. The application shall 25 contain a description of—

1 "(1) the manner in which the State educational 2 agency will use the needs assessment described in 3 section 3705 and poverty data to allocate funds 4 made available through the allotment to the local educational agencies in the State with the greatest 5 6 need for school library media improvement; 7 "(2) the manner in which the State educational 8 agency will effectively coordinate all Federal and 9 State funds available for library, technology, and 10 professional development activities to assist local 11 educational agencies, elementary schools, and sec-12 ondary schools in— "(A) acquiring up-to-date school library 13 14 media resources in all formats, including books 15 and advanced technology such as Internet con-16 nections; 17 "(B) providing training for school library 18 media specialists; and 19 "(C) facilitating resource-sharing among 20 schools and school library media centers; 21 "(3) the manner in which the State educational 22 agency will develop standards for the incorporation 23 of new technologies into the curricula of elementary 24 schools and secondary schools through school library 25 media programs to develop and enhance the information literacy, information retrieval, and critical
 thinking skills of students; and

"(4) the manner in which the State educational
agency will evaluate the quality and impact of activities carried out under this subpart by local educational agencies to make determinations regarding
the need of the agencies for technical assistance and
whether to continue funding the agencies under this
subpart.

10 "SEC. 3703. STATE RESERVATION.

11 "A State educational agency that receives an allot-12 ment under section 3701 may reserve not more than 3 13 percent of the funds made available through the allotment 14 to provide technical assistance, disseminate information 15 about effective school library media programs, and pay ad-16 ministrative costs, relating to this subpart.

17 "SEC. 3704. LOCAL ALLOCATIONS.

18 "(a) IN GENERAL.—A State educational agency that 19 receives an allotment under section 3701 for a fiscal year 20 shall use the funds made available through the allotment 21 and not reserved under section 3703 to make allocations 22 to local educational agencies.

23 "(b) AGENCIES.—The State educational agency shall
24 allocate the funds to the local educational agencies in the
25 State that have—

"(1) the greatest need for school library media
 improvement according to the needs assessment de scribed in section 3705; and

4 "(2) the highest percentages of poverty, as
5 measured in accordance with section 1113(a)(5).

6 "SEC. 3705. LOCAL APPLICATION.

7 "To be eligible to receive an allocation under section
8 3704 for a fiscal year, a local educational agency shall sub9 mit to the State educational agency an application at such
10 time, in such manner, and containing such information as
11 the State educational agency shall require. The application
12 shall contain—

"(1) a needs assessment relating to need for 13 14 school library media improvement, based on the age 15 and condition of school library media resources (including book collections), access of school library 16 17 media centers to advanced technology, including 18 Internet connections, and the availability of well-19 trained, professionally certified school library media 20 specialists, in schools served by the local educational 21 agency;

"(2) a description of the manner in which the
local educational agency will use the needs assessment to assist schools with the greatest need for
school library media improvement;

"(3) a description of the manner in which the 1 2 local educational agency will use the funds provided 3 through the allocation to carry out the activities de-4 scribed in section 3706; "(4) a description of the manner in which the 5 6 local educational agency will develop and carry out 7 the activities described in section 3706 with the ex-8 tensive participation of school library media special-9 ists, elementary school and secondary school teach-10 ers and administrators, and parents; 11 "(5) a description of the manner in which the 12 local educational agency will effectively coordinate— "(A) funds provided under this subpart 13 with the Federal, State, and local funds re-14 15 ceived by the agency for library, technology, 16 and professional development activities; and 17 "(B) activities carried out under this sub-18 part with the Federal, State, and local library, 19 technology, and professional development activi-

"(6) a description of the manner in which the
local educational agency will collect and analyze data
on the quality and impact of activities carried out

3 "SEC. 3706. LOCAL ACTIVITIES.

4 "A local educational agency that receives a local allo5 cation under section 3704 may use the funds made avail6 able through the allocation—

7 "(1) to acquire up-to-date school library media
8 resources, including books, for the use of students,
9 school library media specialists, and teachers in ele10 mentary schools and secondary schools;

"(2) to acquire and utilize advanced technology,
incorporated into the curricula of the schools, to develop and enhance the information literacy, information retrieval, and critical thinking skills of students;

"(3) to acquire and utilize advanced technology,
including Internet links, to facilitate resource-sharing among schools and school library media centers,
and public and academic libraries, where possible;

19 "(4) to provide professional development oppor20 tunities for school library media specialists; and

"(5) to foster increased collaboration between
school library media specialists and elementary
school and secondary school teachers and administrators.

1 "SEC. 3707. ACCOUNTABILITY AND CONTINUATION OF2FUNDS.

3 "Each local educational agency that receives funding
4 under this subpart for a fiscal year shall be eligible to con5 tinue to receive the funding—

6 "(1) for each of the 2 following fiscal years; and
7 "(2) for each fiscal year subsequent to the 2
8 following fiscal years, if the local educational agency
9 demonstrates that the agency has increased—

"(A) the availability of, and the access of
students, school library media specialists, and
elementary and secondary teachers to, up-todate school library media resources, including
books and advanced technology, in elementary
schools and secondary schools served by the
local educational agency;

17 "(B) the number of well-trained, profes18 sionally certified school library media specialists
19 in those schools; and

20 "(C) collaboration between school library
21 media specialists and elementary school and
22 secondary school teachers and administrators
23 for those schools.

24 "SEC. 3708. SUPPLEMENT NOT SUPPLANT.

25 "Funds made available under this subpart shall be26 used to supplement and not supplant other Federal, State,

and local funds expended to carry out activities relating
 to library, technology, or professional development activi ties.

4 "SEC. 3709. NATIONAL ACTIVITIES.

5 "The Secretary shall reserve not more than 3 percent
6 of the amount appropriated under section 3710 for a fiscal
7 year—

8 "(1) for an annual, independent, national eval9 uation of the activities assisted under this subpart,
10 to be conducted not later than 3 years after the date
11 of enactment of this subpart; and

"(2) to broadly disseminate information to help
States, local educational agencies, school library
media specialists, and elementary and secondary
teachers and administrators learn about effective
school library media programs.

17 "SEC. 3710. AUTHORIZATION OF APPROPRIATIONS.

18 "There are authorized to be appropriated to carry out
19 this subpart \$250,000,000 for fiscal year 2000 and such
20 sums as may be necessary for each of fiscal years 2001
21 through 2004.

22 "Subpart 2—School Library Access Program 23 "SEC. 3721. PROGRAM.

24 "(a) IN GENERAL.—The Secretary may make grants
25 to local educational agencies to provide students with ac-

cess to libraries in elementary schools and secondary
 schools during non-school hours, including the hours be fore and after school, weekends, and summer vacation pe riods.

5 "(b) APPLICATIONS.—To be eligible to receive a
6 grant under subsection (a), a local educational agency
7 shall submit an application to the Secretary at such time,
8 in such manner, and containing such information as the
9 Secretary may require.

"(c) PRIORITY.—In making grants under subsection
(a), the Secretary shall give priority to local educational
agencies that demonstrate, in applications submitted
under subsection (b), that the agencies—

14 "(1) seek to provide activities that will increase15 reading skills and student achievement;

"(2) have effectively coordinated services and
funding with entities involved in other Federal,
State, and local efforts, to provide programs and activities for students during the non-school hours described in subsection (a); and

21 "(3) have a high level of community support.

22 "(d) AUTHORIZATION OF APPROPRIATIONS.—There23 are authorized to be appropriated to carry out this subpart

 $1\$ \$25,000,000 for fiscal year 2000 and such sums as may

2~ be necessary for each of fiscal years 2001 through 2004.".
