**AN ACT**

To designate certain facilities of the United States Postal Service in South Carolina.

1        *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. LAYFORD R. JOHNSON POST OFFICE.**

4        (a) DESIGNATION.—The United States Post Office  
5 located at 301 Main Street in Eastover, South Carolina,  
6 shall be known and designated as the “Layford R. John-  
7 son Post Office”.

8        (b) REFERENCES.—Any reference in any law, map,  
9 regulation, document, paper, or other record of the United  
10 States to the United States Post Office referred to in sub-

1 section (a) shall be deemed to be a reference to the  
2 “Layford R. Johnson Post Office”.

3 **SEC. 2. RICHARD E. FIELDS POST OFFICE.**

4 (a) DESIGNATION.—The United States Post Office  
5 located at 78 Sycamore Street in Charleston, South Caro-  
6 lina, shall be known and designated as the “Richard E.  
7 Fields Post Office”.

8 (b) REFERENCES.—Any reference in any law, map,  
9 regulation, document, paper, or other record of the United  
10 States to the United States Post Office referred to in sub-  
11 section (a) shall be deemed to be a reference to the “Rich-  
12 ard E. Fields Post Office”.

13 **SEC. 3. MARYBELLE H. HOWE POST OFFICE.**

14 (a) DESIGNATION.—The United States Post Office  
15 located at 557 East Bay Street in Charleston, South Caro-  
16 lina, shall be known and designated as the “Marybelle H.  
17 Howe Post Office”.

18 (b) REFERENCES.—Any reference in any law, map,  
19 regulation, document, paper, or other record of the United  
20 States to the United States Post Office referred to in sub-  
21 section (a) shall be deemed to be a reference to the  
22 “Marybelle H. Howe Post Office”.

23 **SEC. 4. MAMIE G. FLOYD POST OFFICE.**

24 (a) DESIGNATION.—The United States Post Office  
25 located at 4026 Lamar Street in (the Eau Claire commu-

1 nity of) Columbia, South Carolina, shall be known and  
2 designated as the “Mamie G. Floyd Post Office”.

3 (b) REFERENCES.—Any reference in any law, map,  
4 regulation, document, paper, or other record of the United  
5 States to the United States Post Office referred to in sub-  
6 section (a) shall be deemed to be a reference to the  
7 “Mamie G. Floyd Post Office”.
