AN ACT

To direct the Secretary of the Interior, the Bureau of Reclamation, to conduct a feasibility study on the Jicarilla Apache Reservation in the State of New Mexico, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. FINDINGS.**

4 Congress finds that—

5 (1) there are major deficiencies with regard to
6 adequate and sufficient water supplies available to

1 residents of the Jicarilla Apache Reservation in the
2 State of New Mexico;

3 (2) the existing municipal water system that
4 serves the Jicarilla Apache Reservation is under the
5 ownership and control of the Bureau of Indian Af-
6 fairs and is outdated, dilapidated, and cannot ade-
7 quately and safely serve the existing and future
8 growth needs of the Jicarilla Apache Tribe;

9 (3) the federally owned municipal water system
10 on the Jicarilla Apache Reservation has been unable
11 to meet the minimum Federal water requirements
12 necessary for discharging wastewater into a public
13 watercourse and has been operating without a Fed-
14 eral discharge permit;

15 (4) the federally owned municipal water system
16 that serves the Jicarilla Apache Reservation has
17 been cited by the United States Environmental Pro-
18 tection Agency for violations of Federal safe drink-
19 ing water standards and poses a threat to public
20 health and safety both on and off the Jicarilla
21 Apache Reservation;

22 (5) the lack of reliable supplies of potable water
23 impedes economic development and has detrimental
24 effects on the quality of life and economic self-suffi-
25 ciency of the Jicarilla Apache Tribe;

1 (6) due to the severe health threats and impedi-
2 ments to economic development, the Jicarilla Apache
3 Tribe has authorized and expended \$4,500,000 of
4 tribal funds for the repair and replacement of the
5 municipal water system on the Jicarilla Apache Res-
6 ervation; and

7 (7) the United States has a trust responsibility
8 to ensure that adequate and safe water supplies are
9 available to meet the economic, environmental, water
10 supply, and public health needs of the Jicarilla
11 Apache Indian Reservation.

12 **SEC. 2. AUTHORIZATION.**

13 (a) AUTHORIZATION.—Pursuant to reclamation laws,
14 the Secretary of the Interior, through the Bureau of Rec-
15 lamation and in consultation and cooperation with the
16 Jicarilla Apache Tribe, shall conduct a feasibility study
17 to determine the most feasible method of developing a safe
18 and adequate municipal, rural, and industrial water sup-
19 ply for the residents of the Jicarilla Apache Indian Res-
20 ervation in the State of New Mexico.

21 (b) REPORT.—Not later than 1 year after funds are
22 appropriated to carry out this Act, the Secretary of the
23 Interior shall transmit to Congress a report containing the
24 results of the feasibility study required by subsection (a).

1 **SEC. 3. AUTHORIZATION OF APPROPRIATIONS.**

2 There are authorized to be appropriated \$200,000 to
3 carry out this Act.
