## A BILL

To amend the Robert T. Stafford Disaster Relief and Emergency Assistance Act to establish a grant program for assisting small businesses and agricultural enterprises in meeting disaster-related expenses.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SMALL BUSINESS AND AGRICULTURAL ENTER-
- 4 PRISE GRANT PROGRAM.
- 5 Title IV of the Robert T. Stafford Disaster Relief and
- 6 Emergency Assistance Act (42 U.S.C. 5170a-42 U.S.C.
- 7 5189b) is amended by adding at the end the following:

### 1 "SEC. 425. SMALL BUSINESS AND AGRICULTURAL ENTER-2 PRISE GRANT PROGRAM. 3 "(a) In General.—The President is authorized to make grants for the purposes of assisting small businesses 4 5 and agricultural enterprises adversely affected by a major disaster in meeting their disaster-related expenses, includ-6 7 ing the costs of nonstructural repairs and replacement of 8 noninsured contents and inventory. "(b) No Relocation Assistance.—No small busi-9 10 ness or agricultural enterprise receiving a grant under this 11 section may use the proceeds of such grant for relocation, although such proceeds may be used for appropriate pur-12 13 poses in a new location, at the discretion of the President, for safety, health, or mitigation purposes. 15 "(c) Duplicative Assistance.— 16 "(1) Liability.—A small business or agricul-17 tural enterprise receiving assistance under this sec-18 tion shall be liable to the United States to the extent 19 that such assistance duplicates benefits provided to 20 the small business or agricultural enterprise for the 21 same purpose from another Federal agency. "(2) Collection by Federal Agencies.—A 22 23 Federal agency which provides any duplicative as-24 sistance described in paragraph (1) shall collect an 25 amount equal to the value of such duplicative assist-

ance from the recipient in accordance with chapter

- 1 37 of title 31, United States Code, relating to debt
- 2 collection, when the head of such agency considers it
- 3 to be in the best interest of the Federal Government.
- 4 "(3) Nonapplicability.—Section 312 shall
- 5 not apply to assistence provided under this section.
- 6 "(d) Limits on Grants.—No small business or agri-
- 7 cultural enterprise shall be eligible for assistance under
- 8 this section in relation to more than one major disaster,
- 9 and the maximum aggregate of such assistance to such
- 10 business or enterprise shall be \$20,000 with respect to
- 11 such disaster.
- 12 "(e) Limit on Time Period for Making
- 13 Grants.—The President may only make a grant under
- 14 this section during the 90-day period beginning on the
- 15 date of declaration of a major disaster under this title.
- 16 "(f) Regulations.—The President shall promulgate
- 17 regulations to carry out this section and such regulations
- 18 shall include criteria, standards, and procedures for the
- 19 determination of eligibility for grants and the administra-
- 20 tion of grants under this section.
- 21 "(g) Definitions.—In this section, the following
- 22 definitions apply:
- "(1) AGRICULTURAL ENTERPRISE.—The term
- 24 'agricultural enterprise' includes—

1	"(A) a farm not larger than a family farm
2	within the meaning of such phrase under sec-
3	tion 321 of the Consolidated Farm and Rural
4	Development Act (7 U.S.C. 1961); and
5	"(B) an enterprise engaged in the business
6	of production of food and fiber, ranching and
7	raising of livestock, aquaculture, and all other
8	farming and agricultural related industries
9	within the meaning of such phrase under sec-
10	tion 3(a) of the Small Business Act (15 U.S.C.
11	632(a)).
12	"(2) Small business.—The term 'small busi-
13	ness' has the meaning the term 'small business con-
14	cern' has under section 3 of the Small Business Act
15	(15 U.S.C. 632).".
16	SEC. 2. APPLICABILITY.
17	The amendments made by section 1 shall apply to
18	any major disaster declared after September 1, 1999, and
19	before the date of enactment of this Act. For purposes
20	of section 425(d) of the Robert T. Stafford Disaster Relief
