# A BILL

  - 1 Be it enacted by the Senate and House of Representa-
  - 2 tives of the United States of America in Congress assembled,

### **3** SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Empowering Women

5 Business Owners Act".

### 6 SEC. 2. FINDINGS.

7 Congress finds the following:

1	(1) There is a need to increase the authoriza-
2	tion of appropriations for the women's business cen-
3	ters established under the Small Business Act be-
4	cause these centers are the only organizations na-
5	tionally that focus exclusively on entrepreneurial
6	training programs for women.
7	(2) Increased funding would make possible the
8	establishment of new centers and subcenters and the
9	continued funding of existing centers, including the
10	on-line women's business center.
11	(3) Increased funding will help the Small Busi-
12	ness Administration to achieve the goal of establish-
13	ing and sustaining at least one women's business
14	center in each State.
15	SEC. 3. AUTHORIZATION OF APPROPRIATIONS.
16	Section $29(k)(1)$ of the Small Business Act (15
17	U.S.C. 656(k)(1)) is amended to read as follows:
18	"(1) AUTHORIZATION.—There are authorized to
19	be appropriated to carry out the projects authorized
20	under this section—
21	"(A) \$9,000,000 for fiscal year 2000;
22	"(B) \$10,000,000 for fiscal year 2001; and
23	"(C) \$11,000,000 for fiscal year 2002.".

### 1 SEC. 4. EFFECTIVE DATE.

- 3 tive on October 1, 1999.
