3	SECTION 1. SHORT TITLE.				
4	This Act may be cited as "Palace of the Governor				
5	Expansion Act".				
6	SEC. 2. CONSTRUCTION OF PALACE OF THE GOVERNORS				
7	EXPANSION.				
8	(a) FINDINGS.—Congress makes the following find				
9	ings:				
10	(1) The United States has an enriched legac				
11	of Hispanic influence in politics, government, eco				
12	nomic development, and cultural expression.				
13	(2) The Palace of the Governors has been the				
14	center of administrative and cultural activity over a				
15	vast region of the Southwest since its construction				
16	as New Mexico's second capitol in Santa Fe by Gov				
17	ernor Pedro de Peralta in 1610.				
18	(3) The Palace of the Governors is the oldes				
19	continuously occupied public building in the United				
20	States and has been occupied for 390 years.				
21	(4) Since its creation, the Museum of New Mex				
22	ico has worked to protect and promote Southwest				
23	Hispanic, and Native American arts and crafts.				
24	(5) The Palace of the Governors is the history				
25	division of the Museum of New Mexico and was once				

1	proposed by Teddy Roosevelt to be part of the					
2	Smithsonian Museum and known as the "Smithso-					
3	nian West."					
4	(6) The Museum has an extensive and priceless					
5	collection of the following:					
6	(A) Spanish Colonial and Iberian Colonial					
7	paintings, including the Sagesser Hyde paint					
8	ings on buffalo hide dating back to 1706.					
9	(B) Pre-Columbian Art.					
10	(C) Historic artifacts including the fol-					
11	lowing:					
12	(i) Helmets and armor worn by the					
13	Don Juan Onate expedition conquistadors					
14	who established the first capital in the					
15	United States, San Juan de los Caballeros,					
16	in July of 1598.					
17	(ii) The Vara Stick used to measure					
18	land grants and other real property bound-					
19	aries in Dona Ana County, New Mexico.					
20	(iii) The Columbus, New Mexico Rail-					
21	way Station clock that was shot, stopping					
22	the pendulum, freezing for all history the					
23	moment when Pancho Villa's raid began,					
24	which marks the beginning of the last in-					
25	vasion of the continental United States					

1	(iv) The field desk of Brigadier Gen-				
2	eral Stephen Watts Kearny who was post-				
3	ed to New Mexico during the Mexican War				
4	and whose Army of the West traveled the				
5	Santa Fe trail to occupy the territories of				
6	New Mexico and California.				
7	(v) More than 800,000 other historic				
8	photographs, guns, costumes, maps, books				
9	and handicrafts.				
10	(7) The Palace of the Governors and the				
11	Sagesser Hyde paintings were designated National				
12	Treasures by the National Trust for Historic Preser-				
13	vation.				
14	(8) The facilities both for exhibiting and stor-				
15	age of this irreplaceable collection are so totally in-				
16	adequate and dangerously unsuitable that there ex-				
17	istence is endangered and their preservation is in				
18	jeopardy.				
19	(b) Definitions.—In this section:				
20	(1) Annex.—The terms "Palace of the Gov-				
21	ernors Expansion Annex' and "Annex" mean the				
22	Palace of the Governors, Museum of New Mexico ad-				
23	dition to be located directly behind the historic Pal-				
24	ace of the Governors building at 110 Lincoln Ave-				

nue, Santa Fe, New Mexico.

1	(2) Secretary.—The term "Secretary" means					
2	the Secretary of the Interior.					
3	3 (c) Construction of the Annex.—Subject to the					
4	4 availability of appropriations, the Secretary shall award					
5	grant to the State of New Mexico to pay for the Federa					
6	share of the costs of the final design, construction, fur					
7	nishing, and equipping of the Palace of the Governors Ex					
8	pansion Annex.					
9	(d) Grant Requirements.—					
10	(1) In general.—In order to receive a grant					
11	awarded under subsection (c), the State of Ne					
12	Mexico, acting through the Office of Cultural Affairs					
13	of the State—					
14	(A) shall submit to the Secretary, within					
15	30 days of the date of enactment of this sec-					
16	tion, a copy of the architectural blueprints for					
17	the Palace of the Governors Expansion Annex.					
18	(B) shall exercise due diligence to obtain					
19	an appropriation from the New Mexico State					
20	Legislature for at least \$8,000,000 for the de-					
21	sign, construction, furnishing, and equipping of					
22	the Annex.					
23	(C) shall exercise due diligence to expedi-					
24	tiously execute a memorandum of under-					
25	standing recognizing that time is of the essence					

1	for the construction for the Annex because
2	2010 marks the 400th anniversary of the con-
3	tinuous occupation and use of the Palace of the
4	Governors.
5	(2) Memorandum of understanding.—The
6	memorandum of understanding described in para-
7	graph (1) shall provide—
8	(A) the date of completion of the construc-
9	tion of the Annex.
10	(B) that Office of Cultural Affairs shall
11	award the contract for construction of the
12	Annex in accordance with the New Mexico Pro-
13	curement Code; and
14	(C) that the contract for the construction
15	of the Annex shall be awarded pursuant to a
16	competitive bidding process.
17	(3) Federal share.—The Federal share of
18	the costs described in subsection (c) shall be 50 per-
19	cent.
20	(4) Non-federal share.—The non-federal
21	share of the costs described in section (c) shall be
22	in cash or in kind fairly evaluated, including land,
23	art and artifact collections, plant, equipment, or
24	services. The non-Federal share shall include any

contribution received by the State of New Mexico for

- 1 the design, land acquisition, library acquisition, li-
- 2 brary renovation, Palace of the Governors conserva-
- 3 tion, and construction, furnishing, equipping of the
- 4 Annex, or donations of art collections to the Mu-
- 5 seum of New Mexico prior to the date of enactment
- of this section. The non-Federal share of the costs
- described in subsection (c) shall include the fol-
- 8 lowing:
- 9 (A) Cost of the land at 110 Lincoln Ave-
- 10 nue, Santa Fe, New Mexico.
- 11 (B) Library acquisition expenditures.
- 12 (C) Library renovation expenditures.
- 13 (D) Palace conservation expenditures.
- 14 (E) New Mexico Foundation and other en-
- dowment funds.
- 16 (F) Donations of art collections or other
- 17 artifacts.
- 18 (e) Use of Funds for Construction—Fur-
- 19 NISHING AND EQUIPMENT.—Subject to funds being ap-
- 20 propriated, the funds received under a grant awarded
- 21 under subsection (c) shall be used only for the final design,
- 22 construction, management, inspection, furnishing, and
- 23 equipment of the Annex.
- 24 (f) AUTHORIZATION OF APPROPRIATIONS.—There is
- 25 authorized to be appropriated to the Secretary to award

- 1 the grant described in subsection (c) a total of
- 2 \$15,000,000 for fiscal year 2001 and succeeding fiscal
- 3 years. Funds appropriated pursuant to this authorization
- 4 of appropriations shall remain available until the grant is
- 5 awarded, but the authority of the Secretary to award the
- 6 grant is conditioned upon the New Mexico State legisla-
- 7 ture appropriating at least \$8,000,000 as provided in sub-
- 8 section (d)(1)(B) before January 1, 2010, and other non-
- 9 Federal sources providing enough funds, when combined
- 10 with the New Mexico State legislature appropriations, to
- 11 ensure that the grant is based on a fifty-fifty match.
