A BILL

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. INTERPRETIVE CENTER AND MUSEUM, DIA-
- 4 MOND VALLEY LAKE, HEMET, CALIFORNIA.
- 5 (a) Assistance for Establishment of Center
- 6 AND MUSEUM.—The Secretary of the Interior shall enter
- 7 into an agreement with an appropriate entity for the pur-
- 8 pose of sharing costs incurred to design, construct, fur-
- 9 nish, and operate an interpretive center and museum, to
- 10 be located on lands under the jurisdiction of the Metropoli-
- 11 tan Water District of Southern California, intended to
- 12 preserve, display, and interpret the paleontology discov-
- 13 eries made at and in the vicinity of the Diamond Valley
- 14 Lake, near Hemet, California, and to promote other his-
- 15 torical and cultural resources of the area.
- 16 (b) Assistance for Nonmotorized Trails.—The
- 17 Secretary shall enter into an agreement with the State of
- 18 California, a political subdivision of the State, or a com-
- 19 bination of State and local public agencies for the purpose
- 20 of sharing costs incurred to design, construct, and main-
- 21 tain a system of trails around the perimeter of the Dia-
- 22 mond Valley Lake for use by pedestrians and non-
- 23 motorized vehicles.
- 24 (c) Matching Requirement.—The Secretary shall
- 25 require the other parties to an agreement under this sec-

- 1 tion to secure an amount of funds from non-Federal
- 2 sources that is at least equal to the amount provided by
- 3 the Secretary.
- 4 (d) Time for Agreement.—The Secretary shall
- 5 enter into the agreements required by this section not
- 6 later than 180 days after the date on which funds are first
- 7 made available to carry out this section.
- 8 (e) AUTHORIZATION OF APPROPRIATIONS.—There is
- 9 authorized to be appropriated not more than \$14,000,000
- 10 to carry out this section.
