## A BILL

To reauthorize the Atlantic Coastal Fisheries Cooperative  
Management Act.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Atlantic Coastal Fish-*  
5 *eries Act of 2000”.*

1 **SEC. 2. REAUTHORIZATION OF ATLANTIC COASTAL FISHERIES COOPERATIVE MANAGEMENT ACT.**

2  
3 (a) *AUTHORIZATION OF APPROPRIATIONS.*—Section  
4 811 of the Atlantic Coastal Fisheries Cooperative Manage-  
5 ment Act (16 U.S.C. 5108) is amended to read as follows:

6 **“SEC. 811. AUTHORIZATION OF APPROPRIATIONS.**

7 “(a) *IN GENERAL.*—To carry out this title, there are  
8 authorized to be appropriated \$10,000,000 for each of fiscal  
9 years 2001 through 2005.

10 “(b) *COOPERATIVE STATISTICS PROGRAM.*—Amounts  
11 authorized under subsection (a) may be used by the Sec-  
12 retary to support the Commission’s cooperative statistics  
13 program.

14 “(c) *REPORTS.*—

15 “(1) *ANNUAL REPORT TO THE SECRETARY.*—The  
16 Secretary shall require, as a condition of providing  
17 financial assistance under this title, that the Commis-  
18 sion and each State receiving such assistance submit  
19 to the Secretary an annual report that provides a de-  
20 tailed accounting of the use of the assistance.

21 “(2) *BIENNIAL REPORTS TO THE CONGRESS.*—  
22 The Secretary shall submit biennial reports to the  
23 Committee on Resources of the House of Representa-  
24 tives and the Committee on Commerce, Science, and  
25 Transportation of the Senate on the use of Federal as-  
26 sistance provided to the Commission and the States

1       *under this title. Each biennial report shall evaluate*  
2       *the success of such assistance in implementing this*  
3       *title.”.*

4       ***(b) TECHNICAL CORRECTIONS.—***

5               ***(1) IN GENERAL.—Such Act is amended—***

6                       ***(A) in section 802(3) (16 U.S.C. 5101(3))***  
7                       ***by striking “such resources in” and inserting***  
8                       ***“such resources is”; and***

9                       ***(B) by striking section 812 and the second***  
10                      ***section 811.***

11               ***(2) AMENDMENTS TO REPEAL NOT AFFECTED.—***

12                      ***The amendments made by paragraph (1)(B) shall not***  
13                      ***affect any amendment or repeal made by the sections***  
14                      ***struck by that paragraph.***

15               ***(3) SHORT TITLE REFERENCES.—Such Act is***  
16                      ***further amended by striking “Magnuson Fishery”***  
17                      ***each place it appears and inserting “Magnuson-Ste-***  
18                      ***vens Fishery”.***
