- 3 SECTION 1. SHORT TITLE.
- 4 This title may be cited as the "Reclamation Reform
- 5 Refund Act of 2000".

- 3 (a) Refund Required.—Subject to the availability
- 4 of appropriations, the Secretary of the Interior is author-
- 5 ized and directed to refund fully amounts received by the
- 6 United States as payments for charges assessed by the
- 7 Secretary before January 1, 1994, for failure to file or
- 8 properly file certain certification or reporting forms pursu-
- 9 ant to sections 206 and 224(c) of the Reclamation Reform
- 10 Act of 1982 (43 U.S.C. 390ff, 390ww(c)) prior to the re-
- 11 ceipt of irrigation water. Such refunds shall be made re-
- 12 gardless of whether such payments were required by the
- 13 United States, were made pursuant to a compromise or
- 14 settlement (whether court approved or otherwise), or were
- 15 otherwise received by the United States. Any refund
- 16 issued pursuant to this subsection shall include the
- 17 amount of associated interest assessed by the Secretary
- 18 and paid to the United States pursuant to section 224(i)
- 19 of that Act (43 U.S.C. 390ww(i)).
- 20 (b) Administrative Fee.—Except with respect to
- 21 the 1987 water year, refunds made pursuant to subsection
- 22 (a) shall be reduced by an administrative fee of \$260 for
- 23 each failure to file a certification or reporting form.
- (c) Authorization of Appropriations.—There
- 25 are authorized to be appropriated to carry out this section
- 26 \$3,000,000.
