A BILL

To make certain adjustments to the boundaries of the Mount Nebo Wilderness Area, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Mount Nebo Wilder-
- 5 ness Boundary Adjustment Act".
- 6 SEC. 2. BOUNDARY ADJUSTMENTS.
- 7 (a) Lands Removed.—The boundary of the Mount
- 8 Nebo Wilderness is adjusted to exclude the following:
- 9 (1) Private property in andrews can-
- 10 YON.—The approximately 21.26 acres of private

- property located in Andrews Canyon, Utah, and de picted on the Map as "Dale".
- 3 (2) MONUMENT SPRINGS.—The approximately
 4 26.045 acres of land depicted on the Map as "Monu5 ment Springs".
- 6 (3) Gardner Canyon.—The approximately
 7 202.084 acres of land depicted on the Map as
 8 "Gardner Canyon".
 - (4) BIRCH CREEK.—The approximately 26.045 acres of land depicted on the Map as "Birch Creek".
- 11 (5) Ingram Canyon.—The approximately 12 17.296 acres of land depicted on the Map as 13 "Ingram Canyon".
- 14 (6) WILLOW CREEK SOUTH.—The approxi-15 mately 68.156 acres of land depicted on the Map as 16 "Willow Creek South".
- 17 (7) WILLOW CREEK NORTH.—The approxi-18 mately 50.38 acres of land depicted on the Map as 19 "Willow Creek North".
- 20 (8) MENDENHALL CANYON.—The approximately 16.350 acres of land depicted on the Map as "Mendenhall Canyon".
- 23 (9) Wash Canyon.—The approximately 44.302 24 acres of land depicted on the Map as "Wash Can-25 yon".

- 1 (b) Lands Added.—Subject to valid existing rights,
- 2 the boundary of the Mount Nebo Wilderness is adjusted
- 3 to include the approximately 439.209 acres of land de-
- 4 picted on the Map for addition to the Mount Nebo Wilder-
- 5 ness. The Utah Wilderness Act of 1984 (Public Law 94–
- 6 428) shall apply to the land added to the Mount Nebo
- 7 Wilderness pursuant to this subsection.
- 8 SEC. 3. MAP.
- 9 (a) DEFINITION.—For the purpose of this Act, the
- 10 term "Map" shall mean the map entitled "Mt. Nebo Wil-
- 11 derness Boundary Adjustment", numbered 1255, and
- 12 dated July 10, 2000.
- 13 (b) Map on File.—The Map shall be on file and
- 14 available for inspection in the office of the Chief of the
- 15 Forest Service, Department of Agriculture.
- 16 (c) Corrections.—The Secretary of Agriculture
- 17 may make technical corrections to the Map.
- 18 SEC. 4. ACCESS FOR MAINTENANCE OF ESTABLISHED
- 19 WATER SYSTEMS.
- Section 305 of the Utah Wilderness Act of 1984
- 21 (Public Law 98–428) is amended—
- 22 (1) by inserting "or systems" before ", or any
- combination of the foregoing"; and

1	(2) by inserting "established water system oper-
2	ations," before "and water reservoir operation pur-
3	poses.".
