## A BILL

To amend title XVIII of the Social Security Act to provide for coverage under part B of the Medicare Program of paramedic intercept services provided in support of public, volunteer, or non-profit providers of ambulance services.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Community Ambulance  
5 Support Act of 2000”.

1 **SEC. 2. MEDICARE COVERAGE OF CERTAIN PARAMEDIC**  
2 **INTERCEPT SERVICES.**

3 (a) COVERAGE.—

4 (1) IN GENERAL.—Section 1861(s)(7) of the  
5 Social Security Act (42 U.S.C. 1395x(s)(7)) is  
6 amended by striking “regulations;” and inserting  
7 “regulations, including paramedic intercept services  
8 (as described in subsection (uu));”.

9 (2) SERVICES DESCRIBED.—Section 1861 of  
10 the Social Security Act (42 U.S.C. 1395x) is amend-  
11 ed by adding at the end the following new sub-  
12 section:

13 “Paramedic Intercept Services

14 “(uu)(1) The term ‘paramedic intercept services’  
15 means ambulance services consisting of advanced life sup-  
16 port services provided by a qualified provider of ambulance  
17 services under this title in support of an entity that is a  
18 qualified public, volunteer, or non-profit provider of ambu-  
19 lance services (as defined in paragraph (2)).

20 “(2) In paragraph (1), the term ‘qualified public, vol-  
21 unteer, or non-profit provider of ambulance services’  
22 means a public, volunteer, or non-profit provider of ambu-  
23 lance services that is licensed, certified, or approved by  
24 a State to provide such services (including basic life sup-  
25 port services and transportation services) with or without  
26 charge to individuals receiving such services.”.

1           (3) LIMITATION ON AMOUNT OF PAYMENT.—  
2           Section 1833(a)(1) of the Social Security Act (42  
3           U.S.C. 1395l(a)(1)) is amended—

4                   (A) by striking “and” before “(S)”; and

5                   (B) by inserting before the semicolon at  
6           the end the following: “, and (T) with respect  
7           to expenses for paramedic intercept services (as  
8           defined in section 1861(uu)), the amounts paid  
9           may not exceed any applicable limits established  
10          on payments for such services by the State in  
11          which the services are provided”.

12          (4) CONFORMING REPEAL.—Section 4531 of  
13          the Balanced Budget Act of 1997 (42 U.S.C. 1395x  
14          note), as amended by section 412(a) of the Medi-  
15          care, Medicaid, and SCHIP Balanced Budget Re-  
16          finement Act of 1999 (113 Stat. 1501A–377), as en-  
17          acted into law by section 1000(a)(6) of Public Law  
18          106–113, is amended by striking subsection (c).

19          (b) EFFECTIVE DATE.—The amendments made by  
20          subsection (a) shall apply to paramedic intercept services  
21          provided on or after January 1, 2001.
