A BILL

To provide funds for the purchase of automatic external defibrillators and the training of individuals in advanced cardiac life support.

1 *Be it enacted by the Senate and House of Representa-
2 tives of the United States of America in Congress assembled,*

3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the “Rural Access to Emer-
5 gency Devices Act” or the “Rural AED Act”.

1 **SEC. 2. FINDINGS.**

2 Congress makes the following findings:

3 (1) Heart disease is the leading cause of death
4 in the United States.5 (2) The American Heart Association estimates
6 that 250,000 Americans die from sudden cardiac ar-
7 rest each year.8 (3) A cardiac arrest victim's chance of survival
9 drops 10 percent for every minute that passes before
10 his or her heart is returned to normal rhythm.11 (4) Because most cardiac arrest victims are ini-
12 tially in ventricular fibrillation, and the only treat-
13 ment for ventricular fibrillation is defibrillation,
14 prompt access to defibrillation to return the heart to
15 normal rhythm is essential.16 (5) Lifesaving technology, the automated exter-
17 nal defibrillator, has been developed to allow trained
18 lay rescuers to respond to cardiac arrest by using
19 this simple device to shock the heart into normal
20 rhythm.21 (6) Those people who are likely to be first on
22 the scene of a cardiac arrest situation in many com-
23 munities, particularly smaller and rural commu-
24 nities, lack sufficient numbers of automated external
25 defibrillators to respond to cardiac arrest in a timely
26 manner.

5 (8) Legislation should be enacted to encourage
6 greater public access to automated external
7 defibrillators in communities across the United
8 States.

9 SEC. 3. GRANTS.

10 (a) IN GENERAL.—The Secretary of Health and
11 Human Services, acting through the Rural Health Out-
12 reach Office of the Health Resources and Services Admin-
13 istration, shall award grants to community partnerships
14 that meet the requirements of subsection (b) to enable
15 such partnerships to purchase equipment and provide
16 training as provided for in subsection (c).

17 (b) COMMUNITY PARTNERSHIPS.—A community
18 partnership meets the requirements of this subsection if
19 such partnership—

20 (1) is composed of local emergency response en-
21 tities such as community training facilities, local
22 emergency responders, fire and rescue departments,
23 police, community hospitals, and local non-profit en-
24 tities and for-profit entities concerned about cardiac
25 arrest survival rates;

10 (c) USE OF FUNDS.—Amounts provided under a
11 grant under this section shall be used—

12 (1) to purchase automatic external defibrillators
13 that have been approved, or cleared for marketing,
14 by the Food and Drug Administration; and

20 (d) REPORT.—Not later than 4 years after the date
21 of enactment of this Act, the Secretary of Health and
22 Human Services shall prepare and submit to the appro-
23 priate committees of Congress a report containing data
24 relating to whether the increased availability of
25 defibrillators has affected survival rates in the commu-

1 nities in which grantees under this section operated. The
2 procedures under which the Secretary obtains data and
3 prepares the report under this subsection shall not impose
4 an undue burden on program participants under this sec-
5 tion.

6 (e) AUTHORIZATION OF APPROPRIATIONS.—There is
7 authorized to be appropriated \$25,000,000 for fiscal years
8 2001 through 2003 to carry out this section.
