- 7 "(e) REGULATIONS OR GUIDELINES.—Not later than
- 8 180 days after the date of the enactment of this section,
- 9 the Administrator, in consultation with the Secretary of
- 10 Agriculture, shall issue such regulations or guidelines as
- 11 the Administrator determines to be necessary to carry out
- 12 this section, including regulations or guidelines that pro-

3 SEC. 3. PREPOSITIONING OF COMMODITIES.

- 4 Section 407(c) of the Agricultural Trade Develop-
- 5 ment and Assistance Act of 1954 (7 U.S.C. 1736a(c)) is
- 6 amended by adding at the end the following new para-
- 7 graph:
- 8 "(4) Prepositioning.—Funds made available
- 9 for fiscal years 2001 and 2002 to carry out titles II
- and III of this Act may be used by the Adminis-
- trator to procure, transport, and store agricultural
- commodities for prepositioning within the United
- 13 States and in foreign countries, except that for each
- such fiscal year not more than \$2,000,000 of such
- funds may be used to store agricultural commodities
- for prepositioning in foreign countries.".
