 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,

1 SECTION 1. PROMOTION OF ADOPTION OF MILITARY

- 2 **WORKING DOGS.**
- 3 (a) Adoption of Military Working Dogs.—
- 4 Chapter 153 of title 10, United States Code, is amended
- 5 by adding at the end the following new section:

6 "§ 2582. Military working dogs: transfer and adoption

7 at end of useful working life

- 8 "(a) AVAILABILITY FOR ADOPTION.—The Secretary
- 9 of Defense shall make a military working dog of the De-
- 10 partment of Defense available for adoption by a person
- 11 or entity referred to in subsection (c) at the end of the
- 12 dog's useful working life or when the dog is otherwise ex-
- 13 cess to the needs of the Department, unless the dog has
- 14 been determined to be unsuitable for adoption under sub-
- 15 section (b).
- 16 "(b) Suitability for Adoption.—The decision
- 17 whether a particular military working dog is suitable or
- 18 unsuitable for adoption under this section shall be made
- 19 by the commander of the last unit to which the dog is
- 20 assigned before being declared excess. The unit com-
- 21 mander shall consider the recommendations of the unit's
- 22 veterinarian in making the decision regarding a dog's
- 23 adoptability.
- 24 "(c) AUTHORIZED RECIPIENTS.—Military working
- 25 dogs may be adopted under this section by law enforce-

- 1 ment agencies, former handlers of these dogs, and other
- 2 persons capable of humanely caring for these dogs.
- 3 "(d) Consideration.—The Secretary may authorize
- 4 the transfer a military working dog under this section
- 5 without charge to the recipient.
- 6 "(e) Limitations on Liability for Transferred
- 7 Dogs.—Notwithstanding any other provision of law, the
- 8 United States shall not be subject to any suit, claim, de-
- 9 mand or action, liability, judgment, cost, or other fee aris-
- 10 ing out of any claim for personal injury or property dam-
- 11 age that results from, or is in any manner predicated
- 12 upon, the act or omission of a former military working
- 13 dog transferred under this section, including any training
- 14 provided to the dog while a military working dog.
- 15 "(f) Annual Report.—The Secretary shall submit
- 16 to Congress an annual report specifying the number of
- 17 military working dogs adopted under this section during
- 18 the preceding year, the number of these dogs currently
- 19 awaiting adoption, and the number of these dogs
- 20 euthanized during the preceding year. With respect to
- 21 each euthanized military working dog, the report shall
- 22 contain an explanation of the reasons why the dog was
- 23 euthanized rather than retained for adoption under this
- 24 section.".

- 1 (b) CLERICAL AMENDMENT.—The table of sections
- 2 at the beginning of such chapter is amended by adding
- 3 at the end the following new item:
