A BILL

To require the Secretary of the Treasury to mint coins in commemoration of veterans of the Armed Forces of the United States and to use the proceeds of surcharges imposed on the sale of such coins to fund the transportation of veterans to and from hospitals administered by the Secretary of Veterans Affairs.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Veterans Commemora-
- 5 tion Act of 2000".
- 6 SEC. 2. FINDINGS.
- 7 The Congress finds as follows:
- 8 (1) The United States is indebted to those who
- 9 served this nation in times of war.
- 10 (2) The United States must meet its obligations
- 11 to veterans.

- 1 (3) The Congress has the responsibility to fulfill 2 those obligations to veterans.
 - (4) The Congress recognizes the unique service that the Disabled American Veterans' transportation program provides to veterans.
 - (5) The Congress would like to offer the opportunity for all persons to voluntarily participate in raising funds for the transportation of veterans to and from veterans' hospitals.
 - (6) The Congress understands the importance of Executive Order Numbered 5398, signed by President Herbert Hoover on July 21, 1930, which created the Veterans Administration at a time when there were 54 hospitals, 4,700,000 living veterans, and 31,600 employees.
 - (7) It is appropriate to authorize coins commemorating the service of veterans of the Armed Forces of the United States and provide for the use of the proceeds of surcharges imposed on the sale of the coins to fund the transportation of veterans to and from hospitals administered by the Secretary of Veterans Affairs.
- 23 SEC. 3. COIN SPECIFICATIONS.
- 24 (a) \$1 SILVER COINS.—

1	(1) Designations.—The Secretary of the
2	Treasury (hereafter in this Act referred to as the
3	"Secretary") shall mint and issue not more than
4	500,000 \$1 coins to commemorate veterans of the
5	United States Armed Services.
6	(2) Size, weight, and composition.—Each
7	coin issued under paragraph (1) shall—
8	(A) weigh 26.73 grams;
9	(B) have a diameter of 1.500 inches; and
10	(C) contain 90 percent silver and 10 per-
11	cent copper.
12	(b) Legal Tender.—The coins minted under this
13	Act shall be legal tender, as provided in section 5103 of
14	title 31, United States Code.
15	(c) Numismatic Items.—For purposes of section
16	5136 of title 31, United States Code, all coins minted
17	under this Act shall be considered to be numismatic items.
18	SEC. 4. SOURCES OF BULLION.
19	The Secretary may obtain silver for minting coins
20	under this Act from any available source, including stock-
21	piles established under the Strategic and Critical Mate-
22	rials Stock Piling Act.
23	SEC. 5. DESIGN OF COINS.
24	(a) Design Requirements.—

1	(1) In general.—The design of each coin
2	minted under this Act shall be emblematic of the
3	service of veterans of the Armed Forces of the
4	United States.
5	(2) Designation and Inscriptions.—On
6	each coin minted under this Act there shall be—
7	(A) a designation of the value of the coin
8	(B) an inscription of the year "2005"; and
9	(C) inscriptions of the words "Liberty"
10	"In God We Trust", "United States of Amer-
11	ica", and "E Pluribus Unum".
12	(b) Selection.—The design for the coins minted
13	under this Act shall be—
14	(1) selected by the Secretary after consultation
15	with the Disabled American Veterans and the Com-
16	mission of Fine Arts; and
17	(2) reviewed by the Citizens Commemorative
18	Coin Advisory Committee.
19	SEC. 6. ISSUANCE OF COINS.
20	(a) QUALITY OF COINS.—Coins minted under this
21	Act shall be issued in uncirculated and proof qualities.
22	(b) MINT FACILITY.—Only 1 facility of the United
23	States Mint may be used to strike any particular quality
24	of the coins minted under this Act.

1	(c) Commencement of Issuance.—The Secretary
2	may issue coins minted under this Act beginning January
3	1, 2005.
4	(d) Termination of Minting Authority.—No
5	coins may be minted under this Act after December 31,
6	2005.
7	SEC. 7. SALE OF COINS.
8	(a) Sale Price.—The coins issued under this Act
9	shall be sold by the Secretary at a price equal to the sum
10	of—
11	(1) the face value of the coins;
12	(2) the surcharge provided in section 8(a) with
13	respect to such coins; and
14	(3) the cost of designing and issuing the coins
15	(including labor, materials, dies, use of machinery,
16	overhead expenses, marketing, and shipping).
17	(b) Bulk Sales.—The Secretary shall make bulk
18	sales of the coins issued under this Act at a reasonable
19	discount.
20	(c) Prepaid Orders.—
21	(1) In General.—The Secretary shall accept
22	prepaid orders for the coins minted under this Act
23	before the issuance of such coins.

- 1 (2) DISCOUNT.—Sale prices with respect to pre-
- 2 paid orders under paragraph (1) shall be at a rea-
- 3 sonable discount.
- 4 SEC. 8. SURCHARGES.
- 5 (a) In General.—All sales of coins minted under
- 6 this Act shall include a surcharge of \$10.
- 7 (b) DISTRIBUTION.—All surcharges received by the
- 8 Secretary from the sale of coins issued under this Act shall
- 9 be promptly paid by the Secretary, in accordance with sec-
- 10 tion 5134(f)(1) of title 31, United States Code, to the Dis-
- 11 abled American Veterans for the purpose of funding the
- 12 transportation of veterans to and from hospitals adminis-
- 13 tered by the Secretary of Veterans Affairs.
- 14 (c) Audits.—The Disabled American Veterans shall
- 15 be subject to the audit requirements of section 5134(f)(2)
- 16 of title 31, United States Code.
