A BILL

To amend title 49, United States Code, to extend Federal Aviation Administration programs through September 30, 1999, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. AIRPORT IMPROVEMENT PROGRAM.**

2 (a) AUTHORIZATION OF APPROPRIATIONS.—Section
3 48103 of title 49, United States Code, is amended by
4 striking “\$1,205,000,000” and all that follows through
5 the period at the end and inserting the following:
6 “~~\$2,347,000,000~~ “\$2,410,000,000 for fiscal years ending
7 before October 1, 1999.”.

8 (b) OBLIGATIONAL AUTHORITY.—Section 47104(c)
9 is amended by striking “March 31, 1999” and inserting
10 “September 30, 1999”.

11 **SEC. 2. AIRWAY FACILITIES IMPROVEMENT PROGRAM.**

12 Section 48101(a) of title 49, United States Code, is
13 amended by adding at the end the following:

14 “(3) \$2,131,000,000 for fiscal year 1999.”.

15 **SEC. 3. FAA OPERATIONS.**

16 (a) AUTHORIZATION OF APPROPRIATIONS FROM
17 GENERAL FUND.—Section 106(k) of title 49, United
18 States Code, is amended by striking “\$5,158,000,000”
19 and all that follows through the period at the end and
20 inserting the following: “\$5,632,000,000 for fiscal year
21 1999.”.

22 (b) AUTHORIZATION OF APPROPRIATIONS FROM
23 TRUST FUND.—Section 48104(c) of such title is
24 amended—

1 (1) in the subsection heading by striking “FIS-
2 CAL YEARS 1994–1998” and inserting “FISCAL
3 YEARS 1994–2000”; and

4 (2) in the matter preceding paragraph (1) by
5 striking “through 1998” and inserting “through
6 2000”.

7 (c) LIMITATION ON OBLIGATING OR EXPENDING
8 AMOUNTS.—Section 48108(c) of such title is amended by
9 striking “1998” and inserting “2000”.

10 **SEC. 4. AIP DISCRETIONARY FUND.**

11 Section 47115 of title 49, United States Code, is
12 amended—

13 (1) by striking subsection (g); and

14 (2) by redesignating subsection (h) as sub-
15 section (g).
