# RESOLUTION

Providing for consideration of the bill (H.R. 4680) to amend title XVIII of the Social Security Act to provide for a voluntary program for prescription drug coverage under the Medicare Program, to modernize the Medicare Program, and for other purposes.

- 1       *Resolved*, That upon the adoption of this resolution
- 2 it shall be in order, without intervention of any point of
- 3 order, to consider in the House bill (H.R. 4680) to amend
- 4 title XVIII of the Social Security Act to provide for a vol-
- 5 untary program for prescription drug coverage under the

1 Medicare Program, to modernize the Medicare Program,  
2 and for other purposes. The bill shall be considered as  
3 read for amendment. The amendment recommended by  
4 the Committee on Ways and Means now printed in the  
5 bill, modified by the amendment printed in the report of  
6 the Committee on Rules accompanying this resolution,  
7 shall be considered as adopted. The previous question shall  
8 be considered as ordered on the bill, as amended, to final  
9 passage without intervening motion except: (1) two hours  
10 of debate on the bill, as amended, equally divided among  
11 and controlled by the chairmen and ranking minority  
12 members of the Committee on Ways and Means and the  
13 Committee on Commerce; and (2) one motion to recommit  
14 with or without instructions.

15 SEC. 2. During consideration of H.R. 4680, notwith-  
16 standing the operation of the previous question, the Chair  
17 may postpone further consideration of the bill until a time  
18 designated by the Speaker.

19 SEC. 3. It shall be in order at any time on or before  
20 the legislative day of Friday, June 30, 2000, for the  
21 Speaker to entertain motions to suspend the rules with  
22 respect to the following measures:

23 (1) The bill (H.R. 3240) to amend the Federal  
24 Food, Drug, and Cosmetic Act to clarify certain re-  
25 sponsibilities of the Food and Drug Administration

1 with respect to the importation of drugs into the  
2 United States; and

3 (2) the resolution (H. Res. 535) expressing the  
4 sense of the House of Representatives concerning  
5 use of additional projected surplus funds to supple-  
6 ment Medicare funding, previously reduced under  
7 the Balanced Budget Act of 1997.
