Mr. GOSS, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 4118) to prohibit the rescheduling or forgiveness of any outstanding bilateral debt owed to the United States by the Government of the Russian Federation until the President certifies to the Congress that the Government of the Russian Federation has ceased all its operations at, removed all personnel from, and permanently closed the intelligence facility at Lourdes, Cuba.

1 *Resolved*, That upon the adoption of this resolution
2 it shall be in order to consider in the House the bill (H.R.
3 4118) to prohibit the rescheduling or forgiveness of any
4 outstanding bilateral debt owed to the United States by
5 the Government of the Russian Federation until the Presi-
6 dent certifies to the Congress that the Government of the
7 Russian Federation has ceased all its operations at, re-
8 moved all personnel from, and permanently closed the in-
9 telligence facility at Lourdes, Cuba. The bill shall be con-
10 sidered as read for amendment. The amendment rec-
11 ommended by the Committee on International Relations
12 now printed in the bill shall be considered as adopted. The
13 previous question shall be considered as ordered on the
14 bill, as amended, and on any further amendment thereto
15 to final passage without intervening motion except: (1) one
16 hour of debate on the bill, as amended, equally divided
17 and controlled by the chairman and ranking minority
18 member of the Committee on International Relations; (2)
19 an amendment in the nature of a substitute printed in
20 the Congressional Record pursuant to clause 8 of rule
21 XVIII, if offered by Representative Gejdenson of Con-
22 necticut or his designee, which shall be considered as read
23 and shall be separately debatable for one hour equally di-
24 vided and controlled by the proponent and an opponent;

1 and (3) one motion to recommit with or without instruc-
2 tions.
