## A BILL

To amend chapter 1 of title 9, United States Code, to provide for greater fairness in the arbitration process relating to motor vehicle franchise contracts.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Motor Vehicle Fran-
- 5 chise Contract Arbitration Fairness Act of 1999".
- 6 SEC. 2. ELECTION OF ARBITRATION.
- 7 (a) Sales and Service Contracts.—Chapter 1 of
- 8 title 9, United States Code, is amended by adding at the
- 9 end the following new section:

#### 1 "§ 17. Motor vehicle franchise contracts

- 2 "(a) For purposes of this section, the term—
- 3 "(1) 'motor vehicle' has the meaning given such
- 4 term under section 30102(6) of title 49; and
- 5 "(2) 'motor vehicle franchise contract' means a
- 6 contract under which a motor vehicle manufacturer,
- 7 importer, or distributor sells motor vehicles to any
- 8 other person for resale to an ultimate purchaser and
- 9 authorizes such other person to repair and service
- the manufacturer's motor vehicles.
- 11 "(b) Whenever a motor vehicle franchise contract
- 12 provides for the use of arbitration to resolve a controversy
- 13 arising out of or relating to the contract, each party to
- 14 the contract shall have the option, after the controversy
- 15 arises and before both parties commence an arbitration
- 16 proceeding, to reject arbitration as the means of settling
- 17 the controversy. Any such rejection shall be in writing.
- 18 "(c) Whenever arbitration is elected to settle a dis-
- 19 pute under a motor vehicle franchise contract, the arbi-
- 20 trator shall provide the parties to the contract with a writ-
- 21 ten explanation of the factual and legal basis for the
- 22 award.".
- 23 (b) Technical and Conforming Amendment.—
- 24 The table of sections for chapter 1 of title 9, United States

- 1 Code, is amended by adding at the end the following new
- 2 item:

"17. Motor vehicle franchise contracts.".

### 3 SEC. 3. EFFECTIVE DATE.

- 4 The amendments made by section 2 shall apply to
- 5 contracts entered into, amended, altered, modified, re-
- 6 newed, or extended after the date of enactment of this Act.
