SECTION 1. 60 BAR LAND EXCHANGE.

- 5 of the Interior of the land described in subsection (b) in

- 7 bell County, Wyoming, pursuant to the terms of the Cow
- 8 Creek/60 Bar land exchange, WYW-143315.
- 9 (b) LAND DESCRIPTION.—The land described in this
- 10 subsection comprises the following land in Campbell and
- 11 Johnson Counties, Wyoming:
- 12 (1) Approximately 2,960 acres of land in the
- tract known as the "Bill Barlow Ranch";
- 14 (2) Approximately 2,315 acres of land in the
- tract know as the "T-Chair Ranch";
- 16 (3) Approximately 3,948 acres of land in the
- tract known as the "Bob Christensen Ranch";
- 18 (4) Approximately 11,609 acres of land in the
- tract known as the "John Christensen Ranch".
