A BILL

To amend the Watershed Protection and Flood Prevention Act to authorize the Secretary of Agriculture to provide cost share assistance for the rehabilitation of structural measures constructed as part of water resource projects previously funded by the Secretary under such Act or related laws.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Small Watershed Re-
 5 habilitation Act of 1999”.

6 **SEC. 2. REHABILITATION OF WATER RESOURCE STRUC-**
 7 **TURAL MEASURES CONSTRUCTED UNDER**
 8 **CERTAIN DEPARTMENT OF AGRICULTURE**
 9 **PROGRAMS.**

10 The Watershed Protection and Flood Prevention Act
 11 (16 U.S.C. 1001 et seq.) is amended by adding at the end
 12 the following new section:

13 **“SEC. 14. REHABILITATION OF STRUCTURAL MEASURES**
 14 **NEAR, AT, OR PAST THEIR EVALUATED LIFE**
 15 **EXPECTANCY.**

16 “(a) DEFINITIONS.—For purposes of this section:

17 “(1) REHABILITATION.—The term ‘rehabilita-
 18 tion’, with respect to a structural measure con-
 19 structed as part of a covered water resource project,
 20 means the completion of all work necessary to ex-
 21 tend the service life of the structural measure and
 22 meet applicable safety and performance standards.
 23 This may include (A) protecting the integrity of the
 24 structural measure, or prolonging the useful life of
 25 the structural measure, beyond the original evalu-

1 ated life expectancy, (B) correcting damage to the
2 structural measure from a catastrophic event, (C)
3 correcting the deterioration of structural components
4 that are deteriorating at an abnormal rate, (D) up-
5 grading the structural measure to meet changed
6 land use conditions in the watershed served by the
7 structural measure or changed safety criteria appli-
8 cable to the structural measure, or (E) decommis-
9 sioning the structural measure, including removal or
10 breaching.

11 “(2) COVERED WATER RESOURCE PROJECT.—
12 The term ‘covered water resource project’ means a
13 work of improvement carried out under any of the
14 following:

15 “(A) This Act.

16 “(B) Section 13 of the Act of December
17 22, 1944 (Public Law 78–534; 58 Stat. 905).

18 “(C) The pilot watershed program author-
19 ized under the heading ‘FLOOD PREVENTION’
20 of the Department of Agriculture Appropriation
21 Act, 1954 (Public Law 156; 67 Stat. 214).

22 “(D) Subtitle H of title XV of the Agri-
23 culture and Food Act of 1981 (16 U.S.C. 3451
24 et seq.; commonly known as the Resource Con-
25 servation and Development Program).

1 “(3) ELIGIBLE LOCAL ORGANIZATION.—The
2 term ‘eligible local organization’ means a local orga-
3 nization or appropriate State agency responsible for
4 the operation and maintenance of structural meas-
5 ures constructed as part of a covered water resource
6 project.

7 “(4) STRUCTURAL MEASURE.—The term ‘struc-
8 tural measure’ means a physical improvement that
9 impounds water, commonly known as a dam, which
10 was constructed as part of a covered water resource
11 project.

12 “(b) COST SHARE ASSISTANCE FOR REHABILITA-
13 TION.—

14 “(1) ASSISTANCE AUTHORIZED.—The Secretary
15 may provide financial assistance to an eligible local
16 organization to cover a portion of the total costs in-
17 curred for the rehabilitation of structural measures
18 originally constructed as part of a covered water re-
19 source project. The total costs of rehabilitation in-
20 clude the costs associated with all components of the
21 rehabilitation project, including acquisition of land,
22 easements, and rights-of-ways, rehabilitation project
23 administration, the provision of technical assistance,
24 contracting, and construction costs, except that the
25 local organization shall be responsible for securing

1 all land, easements, or rights-of-ways necessary for
2 the project.

3 “(2) AMOUNT OF ASSISTANCE; LIMITATIONS.—

4 The amount of Federal funds that may be made
5 available under this subsection to an eligible local
6 organization for construction of a particular rehabili-
7 tation project shall be equal to 65 percent of the
8 total rehabilitation costs, but not to exceed 100 per-
9 cent of actual construction costs incurred in the re-
10 habilitation. However, the local organization shall be
11 responsible for the costs of water, mineral, and other
12 resource rights and all Federal, State, and local per-
13 mits.

14 “(3) RELATION TO LAND USE AND DEVELOP-

15 MENT REGULATIONS.—As a condition on entering
16 into an agreement to provide financial assistance
17 under this subsection, the Secretary, working in con-
18 cert with the eligible local organization, may require
19 that proper zoning or other developmental regula-
20 tions are in place in the watershed in which the
21 structural measures to be rehabilitated under the
22 agreement are located so that—

23 “(A) the completed rehabilitation project is
24 not quickly rendered inadequate by additional
25 development; and

1 “(B) society can realize the full benefits of
2 the rehabilitation investment.

3 “(c) TECHNICAL ASSISTANCE FOR WATERSHED
4 PROJECT REHABILITATION.—The Secretary, acting
5 through the Natural Resources Conservation Service, may
6 provide technical assistance in planning, designing, and
7 implementing rehabilitation projects should an eligible
8 local organization request such assistance. Such assistance
9 may consist of specialists in such fields as engineering,
10 geology, soils, agronomy, biology, hydraulics, hydrology,
11 economics, water quality, and contract administration.

12 “(d) PROHIBITED USE.—

13 “(1) PERFORMANCE OF OPERATION AND MAIN-
14 TENANCE.—Rehabilitation assistance provided under
15 this section may not be used to perform operation
16 and maintenance activities specified in the agree-
17 ment for the covered water resource project entered
18 into between the Secretary and the eligible local or-
19 ganization responsible for the works of improvement.
20 Such operation and maintenance activities shall re-
21 main the responsibility of the local organization, as
22 provided in the project work plan.

23 “(2) RENEGOTIATION.—Notwithstanding para-
24 graph (1), as part of the provision of financial as-
25 sistance under subsection (b), the Secretary may re-

1 negotiate the original agreement for the covered
2 water resource project entered into between the Sec-
3 retary and the eligible local organization regarding
4 responsibility for the operation and maintenance of
5 the project when the rehabilitation is finished.

6 “(e) APPLICATION FOR REHABILITATION ASSIST-
7 ANCE.—An eligible local organization may apply to the
8 Secretary for technical and financial assistance under this
9 section if the application has also been submitted to and
10 approved by the State agency having supervisory responsi-
11 bility over the covered water resource project at issue or,
12 if there is no State agency having such responsibility, by
13 the Governor of the State. The Secretary shall request the
14 State dam safety officer (or equivalent State official) to
15 be involved in the application process if State permits or
16 approvals are required. The rehabilitation of structural
17 measures shall meet standards established by the Sec-
18 retary and address other dam safety issues. At the request
19 of the eligible local organization, personnel of the Natural
20 Resources Conservation Service of the Department of Ag-
21 riculture may assist in preparing applications for assist-
22 ance.

23 “(f) JUSTIFICATION FOR REHABILITATION ASSIST-
24 ANCE.—In order to qualify for technical or financial as-
25 sistance under this authority, the Secretary shall require

1 the rehabilitation project to be performed in the most cost-
2 effective manner that accomplishes the rehabilitation ob-
3 jective. Since the requirements for accomplishing the reha-
4 bilitation are generally for public health and safety rea-
5 sons, in many instances being mandated by other State
6 or Federal laws, no benefit-cost analysis will be conducted
7 and no benefit-cost ratio greater than one will be required.
8 The benefits of and the requirements for the rehabilitation
9 project shall be documented to ensure the wise and respon-
10 sible use of Federal funds.

11 “(g) RANKING OF REQUESTS FOR REHABILITATION
12 ASSISTANCE.—The Secretary shall establish such system
13 of approving rehabilitation requests, recognizing that such
14 requests will be received throughout the fiscal year and
15 subject to the availability of funds to carry out this sec-
16 tion, as is necessary for proper administration by the De-
17 partment of Agriculture and equitable for all eligible local
18 organizations. The approval process shall be in writing,
19 and made known to all eligible local organizations and ap-
20 propriate State agencies.

21 “(h) AUTHORIZATION OF APPROPRIATIONS.—There
22 are authorized to be appropriated to the Secretary
23 \$60,000,000 for each of the fiscal years 2000 through
24 2009 to provide financial and technical assistance under
25 this section.

1 “(i) ASSESSMENT OF REHABILITATION NEEDS.—Of
2 the amount appropriated pursuant to subsection (h) for
3 fiscal years 2000 and 2001, \$5,000,000 shall be used by
4 the Secretary, in concert with the responsible State agen-
5 cies, to conduct an assessment of the rehabilitation needs
6 of covered water resource projects in all States in which
7 such projects are located.

8 “(j) RECORDKEEPING AND REPORTS.—

9 “(1) SECRETARY.—The Secretary shall main-
10 tain a data base to track the benefits derived from
11 rehabilitation projects supported under this section
12 and the expenditures made under this section. On
13 the basis of such data and the reports submitted
14 under paragraph (2), the Secretary shall prepare
15 and submit to Congress an annual report providing
16 the status of activities conducted under this section.

17 “(2) GRANT RECIPIENTS.—Not later than 90
18 days after the completion of a specific rehabilitation
19 project for which assistance is provided under this
20 section, the eligible local organization that received
21 the assistance shall make a report to the Secretary
22 giving the status of any rehabilitation effort under-
23 taken using financial assistance provided under this
24 section.”.
