AN ACT

To continue the reporting requirements of section 2519 of title 18, United States Code, beyond December 21, 1999, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Continued Reporting
- 5 of Intercepted Wire, Oral, and Electronic Communications
- 6 Act".

1 SEC. 2. FINDINGS.

- 2 Congress makes the following findings:
- 3 (1) Section 2519(3) of title 18, United States
- 4 Code, requires the Director of the Administrative
- 5 Office of the United States Courts to transmit to
- 6 Congress a full and complete annual report con-
- 7 cerning the number of applications for orders au-
- 8 thorizing or approving the interception of wire, oral,
- 9 or electronic communications. This report is required
- to include information specified in section 2519(3).
- 11 (2) The Federal Reports Elimination and Sun-
- set Act of 1995 provides for the termination of cer-
- tain laws requiring submittal to Congress of annual,
- semiannual, and regular periodic reports as of De-
- cember 21, 1999, 4 years from the effective date of
- that Act.
- 17 (3) Due to the Federal Reports Elimination Act
- and Sunset Act of 1995, the Administrative Office
- of United States Courts is not required to submit
- the annual report described in section 2519(3) of
- 21 title 18, United States Code, as of December 21,
- 22 1999.
- 23 SEC. 3. CONTINUED REPORTING REQUIREMENTS.
- 24 (a) Continued Reporting Requirements.—Sec-
- 25 tion 2519 of title 18, United States Code, is amended by
- 26 adding at the end the following:

- 1 "(4) The reports required to be filed by subsection
- 2 (3) are exempted from the termination provisions of sec-
- 3 tion 3003(a) of the Federal Reports Elimination and Sun-
- 4 set Act of 1995 (Public Law 104-66).".
- 5 (b) Exemption.—Section 3003(d) of the Federal
- 6 Reports Elimination and Sunset Act of 1995 (Public Law
- 7 104–66) is amended—
- 8 (1) in paragraph (31), by striking "or" at the
- 9 end;
- 10 (2) in paragraph (32), by striking the period
- and inserting "; or"; and
- 12 (3) by adding at the end the following:
- "(33) section 2519(3) of title 18, United States
- 14 Code.".

15 SEC. 4. ENCRYPTION REPORTING REQUIREMENTS.

- 16 (a) Section 2519(2)(b) of title 18, United States
- 17 Code, is amended by striking "and (iv)" and inserting
- 18 "(iv) the number of orders in which encryption was en-
- 19 countered and whether such encryption prevented law en-
- 20 forcement from obtaining the plain text of communica-
- 21 tions intercepted pursuant to such order, and (v)".
- 22 (b) The encryption reporting requirement in sub-
- 23 section (a) shall be effective for the report transmitted by
- 24 the Director of the Administrative Office of the Courts
- 25 for calendar year 2000 and in subsequent reports.

SEC. 5. REPORTS CONCERNING PEN REGISTERS AND TRAP 2 AND TRACE DEVICES. 3 Section 3126 of title 18, United States Code, is 4 amended by striking the period and inserting ", which report shall include information concerning— 5 6 "(1) the period of interceptions authorized by 7 the order, and the number and duration of any ex-8 tensions of the order; "(2) the offense specified in the order or appli-9 10 cation, or extension of an order; "(3) the number of investigations involved; 11 "(4) the number and nature of the facilities af-12 13 fected; and "(5) the identity, including district, of the ap-14 15 plying investigative or law enforcement agency mak-16 ing the application and the person authorizing the 17 order.".
