AN ACT

To provide for a land conveyance to the city of Craig, Alaska,
and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. LAND EXCHANGE WITH CITY OF CRAIG,**
 2 **ALASKA.**

3 (a) At such time as Congress appropriates funds suf-
 4 ficient for the Secretary of Agriculture to acquire non-
 5 Federal lands within conservation system units on the
 6 Tongass National Forest, the Secretary shall convey to the
 7 city of Craig, Alaska, all Federal interests in the lands
 8 identified in subsection (b): *Provided*, That the lands con-
 9 veyed to the city of Craig shall be of equal value to the
 10 lands acquired by the Secretary of Agriculture pursuant
 11 to this subsection.

12 (b) The approximately 4,532 acres of Federal lands
 13 to be conveyed to the city of Craig are described as follows:

14 (1) All Federal land in the following described
 15 protracted and partially surveyed townships in the
 16 Copper River Meridian, Alaska:

17 (A) Within T. 71 S., R. 81 E—

18 Section 24, E $\frac{1}{2}$;

19 Section 25, E $\frac{1}{2}$, S $\frac{1}{2}$ SW $\frac{1}{4}$;

20 Section 36.

21 Containing 1,360 acres, more or less.

22 (B) Within T. 71 S., R. 82 E—

23 Section 19, S $\frac{1}{2}$ SW $\frac{1}{4}$;

24 Section 29, W $\frac{1}{4}$ NW $\frac{1}{4}$, N $\frac{1}{2}$ SW $\frac{1}{4}$;

25 Section 30, All;

26 Section 31, All.
