A BILL

To authorize the Secretary of Agriculture to sell or exchange all or part of certain administrative sites and other National Forest System land in the State of Oregon and use the proceeds derived from the sale or exchange for National Forest System purposes.

1 SECTION 1. SHORT TITLE.

- 2 This Act may be eited as the "Bend Pine Nursery

- 22 entitled "Shelter Cove Resort", dated November 3,

- 24 (3) Isolated parcels of National Forest System
- 25 land located in sec. 25, T. 20 S., R. 10 E., and secs.
- 26 16, 17, 20, and 21, T. 20 S., R. 11 E., Willamette

- 1 Meridian, as depicted on the map entitled "Isolated 2 Parcels, Deschutes National Forest", dated 1988.
- 3 (4) Alsea Administrative Site, consisting of approximately 24 acres, as depicted on site plan map entitled "Alsea Administrative Site", dated May 14, 1999.
- 7 (5) Mapleton Administrative Site, consisting of
 8 approximately 8 acres, as depicted on site plan map
 9 entitled "Mapleton Administrative Site", dated May
 10 14, 1999.
- 11 (6) Springdale Administrative Site, consisting
 12 of approximately 3.6 acres, as depicted on site plan

- 19 (b) Consideration.—Consideration for a sale or ex-20 change of land under subsection (a) may include the ac-21 quisition of land, existing improvements, or improvements 22 constructed to the specifications of the Secretary.
- 23 (c) APPLICABLE LAW.—Except as otherwise provided 24 in this Act, any sale or exchange of National Forest Sys-25 tem land under subsection (a) shall be subject to the laws

- 11 (2) Tract B, the Federal Government owned
- 12 structures located at Shelter Cove Resort, Deschutes
- National Forest, buildings only, as depicted on site
- plan map entitled "Shelter Cove Resort, November 3,
- 15 1997".
- 16 (3) Tract C, portions of isolated parcels of Na-
- 17 tional Forest Land located in Township 20 south,
- 18 Range 10 East section 25 and Township 20 South,
- 19 Range 11 East sections 8, 9, 16, 17, 20, and 21 con-
- sisting of approximately 1,260 acres, as depicted on
- 21 map entitled "Deschutes National Forest Isolated
- 22 Parcels, January 1, 2000".
- 23 (4) Tract D, Alsea Administrative Site, con-
- 24 sisting of approximately 24 acres, as depicted on site
- 25 plan map entitled "Alsea Administrative Site, May
- 26 *14, 1999*".

- 1 (5) Tract E, Mapleton Administrative Site, con-2 sisting of approximately 8 acres, as depicted on site 3 plan map entitled "Mapleton Administrative Site, 4 May 14, 1999".
 - (6) Tract F, Springdale Administrative Site, consisting of approximately 3.6 acres, as depicted on site plan map entitled "Site Development Plan, Columbia Gorge Ranger Station, April 22, 1964".
 - (7) Tract G, Dale Administrative Site, consisting of approximately 37 acres, as depicted on site plan map entitled "Dale Compound, February 1999".
- 12 (8) Tract H, Crescent Butte Site, consisting of 13 approximately .8 acres, as depicted on site plan map 14 entitled "Crescent Butte Communication Site, Janu-15 ary 1, 2000".
- 16 (b) CONSIDERATION.—Consideration for a sale or ex-17 change of land under subsection (a) may include the acqui-18 sition of land, existing improvements, or improvements con-19 structed to the specifications of the Secretary.
- 20 (c) APPLICABLE LAW.—Except as otherwise provided 21 in this Act, any sale or exchange of National Forest System 22 land under subsection (a) shall be subject to the laws (in-23 cluding regulations) applicable to the conveyance and ac-24 quisition of land for the National Forest System.

8	U.S.C. 484a) (commonly known as the "Sisk Act").
9	(b) Use of Proceeds.—Funds deposited under sub-
10	section (a) shall be available to the Secretary, without fur-
11	ther Act of appropriation, for—
12	(1) the acquisition, construction, or improvement
13	of administrative and visitor facilities and associated
14	land in connection with the Deschutes National For-

24	March 1, 1911 (16 U.S.C. 480 et seq.) (commonly known

as the "Weeks Act") and other laws (including regulations) pertaining to the National Forest System. SEC. 5. CONSTRUCTION OF NEW ADMINISTRATIVE FACILI-4 TIES.
