**A BILL**

For the relief of Tony Lara.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. PERMANENT RESIDENT STATUS FOR TONY**  
4 **LARA.**

5 (a) IN GENERAL.—Notwithstanding subsections (a)  
6 and (b) of section 201 of the Immigration and Nationality  
7 Act, Tony Lara shall be eligible for issuance of an immi-  
8 grant visa or for adjustment of status to that of an alien

1 lawfully admitted for permanent residence upon filing an  
2 application for issuance of an immigrant visa under sec-  
3 tion 204 of such Act or for adjustment of status to lawful  
4 permanent resident.

5 (b) ADJUSTMENT OF STATUS.—If Tony Lara enters  
6 the United States before the filing deadline specified in  
7 subsection (c), he shall be considered to have entered and  
8 remained lawfully and shall, if otherwise eligible, be eligi-  
9 ble for adjustment of status under section 245 of the Im-  
10 migration and Nationality Act as of the date of enactment  
11 of this Act.

12 (c) DEADLINE FOR APPLICATION AND PAYMENT OF  
13 FEES.—Subsections (a) and (b) shall apply only if the ap-  
14 plication for issuance of an immigrant visa or the applica-  
15 tion for adjustment of status are filed with appropriate  
16 fees within 2 years after the date of enactment of this  
17 Act.

18 (d) REDUCTION OF IMMIGRANT VISA NUMBER.—  
19 Upon the granting of an immigrant visa or permanent res-  
20 idence to ~~Guy Taylor~~ *Tony Lara*, the Secretary of State  
21 shall instruct the proper officer to reduce by one, during  
22 the current or next following fiscal year, the total number  
23 of immigrant visas that are made available to natives of  
24 the country of the alien's birth under section 203(a) of  
25 the Immigration and Nationality Act or, if applicable, the

- 1 total number of immigrant visas that are made available
- 2 to natives of the country of the alien's birth under section
- 3 202(e) of such Act.
