A BILL

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Medicaid DSH Preser-
5 vation Act of 2000”.

1 **SEC. 2. CONTINUATION OF MEDICAID DSH ALLOTMENTS AT**
 2 **FY FISCAL YEAR 2000 LEVELS FOR FISCAL**
 3 **YEAR 2001.**

4 Section 1923(f) of the Social Security Act (42 U.S.C.
 5 1396r-4(f)), as amended by section 601 of the Medicare,
 6 Medicaid, and SCHIP Balanced Budget Refinement Act
 7 of 1999, as enacted into law by section 1000(a)(6) of Pub-
 8 lic Law 106-113 (113 Stat. 1501A-394), is amended—

9 (1) in paragraph (2)—

10 (A) in the heading, by striking “2002” and
 11 inserting “2001”;

12 (B) in the matter preceding the table—

13 (i) by striking “2002” and inserting
 14 “2001”; and

15 (ii) by inserting “(and the DSH allot-
 16 ment for a State for fiscal year 2001 is the
 17 same as the DSH allotment for the State
 18 for fiscal year 2000 as determined under
 19 the following table)” before the semicolon;
 20 and

21 (C) in the table in such paragraph, by
 22 striking the columns labeled “FY 01” and “FY
 23 02” relating to fiscal years 2001 and 2002; and
 24 (2) in paragraph (3)—

25 (A) in the heading, by striking “2003” and
 26 inserting “2002”; and

- 1 (B) in subparagraph (A), by striking
- 2 “2003” and inserting “2002”.
