A BILL

To authorize the Forest Service to convey certain lands in the Lake Tahoe Basin to the Washoe County School District for use as an elementary school site.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. CONVEYANCE OF CERTAIN FOREST SERVICE
- 4 LAND IN THE LAKE TAHOE BASIN.
- 5 (a) Conveyance.—Upon application, the Secretary
- 6 of Agriculture, acting through the Chief of the Forest
- 7 Service, may convey to the Washoe County School District
- 8 all right, title, and interest of the United States in the
- 9 property described as a portion of the Northwest quarter

- 1 of Section 15, Township 16 North, Range 18 East,
- 2 M.D.B. & M., more particularly described as Parcel 1 of
- 3 Parcel Map No. 426 for Boise Cascade, filed in the office
- 4 of the Washoe County Recorder, State of Nevada, on May
- 5 19, 1977, as file No. 465601, Official Records.
- 6 (b) REVIEW OF APPLICATION.—When the Secretary
- 7 receives an application to convey the property under sub-
- 8 section (a), the Secretary shall make a final determination
- 9 whether or not to convey such property before the end of
- 10 the 180-day period beginning on the date of the receipt
- 11 of the application.
- 12 (c) USE; REVERSION.—The conveyance of the prop-
- 13 erty under subsection (a) shall be for the sole purpose of
- 14 the construction of an elementary school on the property.
- 15 The property conveyed shall revert to the United States
- 16 if the property is used for a purpose other than as an
- 17 elementary school site.
- 18 (d) Consideration Based on Requirement To
- 19 Use For Limited Public Purposes.—The Secretary
- 20 shall determine the amount of any consideration required
- 21 for the conveyance of property under this section based
- 22 on the fair market value of the property when it is subject
- 23 to the restriction on use under subsection (c).
- 24 (e) Proceeds.—The proceeds from the conveyance
- 25 of the property under subsection (a) shall be available to

- 1 the Secretary without further appropriation and shall re-
- 2 main available until expended for the purpose of acquiring
- 3 environmentally sensitive land in the Lake Tahoe Basin
- 4 pursuant to section 3 of the Act entitled "An Act to pro-
- 5 vide for the orderly disposal of certain Federal lands in
- 6 Nevada and for the acquisition of certain other lands in
- 7 the Lake Tahoe Basin, and for other purposes", approved
- 8 December 23, 1980 (94 Stat. 3381; commonly known as
- 9 the "Santini-Burton Act").
- 10 (f) Applicable Law.—Except as otherwise provided
- 11 in this section, any sale of National Forest System land
- 12 under this section shall be subject to the laws (including
- 13 regulations) applicable to the conveyance of National For-
- 14 est System lands.
