A BILL

1 **SECTION 1. DESIGNATION OF THOMAS S. FOLEY FEDERAL**
2 **BUILDING AND UNITED STATES COURT-**
3 **HOUSE.**

4 (a) IN GENERAL.—The Federal building and United
5 States courthouse located at West 920 Riverside Avenue
6 in Spokane, Washington, shall be known and designated
7 as the “Thomas S. Foley Federal Building and United
8 States Courthouse”.

9 (b) REFERENCES.—Any reference in a law, map, reg-
10 ulation, document, paper, or other record of the United
11 States to the Federal building and United States court-
12 house referred to in subsection (a) shall be deemed to be
13 a reference to the “Thomas S. Foley Federal Building and
14 United States Courthouse”.

15 **SEC. 2. DESIGNATION OF WALTER F. HORAN PLAZA.**

16 (a) IN GENERAL.—The plaza located at the south en-
17 trance of the Federal building and United States court-
18 house referred to in section 1(a) shall be known and des-
19 igned as the “Walter F. Horan Plaza”.

20 (b) REFERENCES.—Any reference in a law, map, reg-
21 ulation, document, paper, or other record of the United
22 States to the plaza referred to in subsection (a) shall be
23 deemed to be a reference to the “Walter F. Horan Plaza”.

24 **SEC. 3. EFFECTIVE DATE.**

25 This Act takes effect on March 6, 1999.
