Designating certain land in the San Isabel National Forest in the State of Colorado as the "Spanish Peaks Wilderness".

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Spanish Peaks Wilder-
- 5 ness Act of 1999".

1	SEC. 2. DESIGNATION OF SPANISH PEAKS WILDERNESS.				
2	(a) Colorado Wilderness Act.—Section 2(a) of				
3	the Colorado Wilderness Act of 1993 (Public Law 103–				
4	77; 107 Stat. 756; 16 U.S.C. 1132 note) is amended by				
5	adding at the end the following:				
6	"(20) Spanish peaks wilderness.—Certain				
7	land in the San Isabel National Forest that—				
8	"(A) comprises approximately 18,00				
9	acres, as generally depicted on a map entitle				
10	'Proposed Spanish Peaks Wilderness', dated				
11	February 10, 1999; and				
12	"(B) shall be known as the 'Spanish Peak				
13	Wilderness'.".				
14	(b) Map; Boundary Description.—				
15	(1) FILING.—As soon as practicable after the				
16	date of enactment of this Act, the Secretary of Agri-				
17	culture (referred to in this Act as the "Secretary")				
18	shall file a map and boundary description of the				
19	area designated under subsection (a) with—				
20	(A) the Committee on Resources of the				
21	House of Representatives; and				
22	(B) the Committee on Energy and Natura				
23	Resources of the Senate.				
24	(2) FORCE AND EFFECT.—The map and bound-				
25	ary description under paragraph (1) shall have the				

same force and effect as if included in the Colorado

- 5 (3) AVAILABILITY.—The map and boundary de-

- 9 SEC. 3. ACCESS.
- 10 Within the Spanish Peaks Wilderness designated
- 11 under section 2—
- 12 (1) the Secretary shall allow the continuation of
- 13 historic uses of the Bulls Eye Mine Road established
- prior to the date of enactment of this Act, subject
- to such terms and conditions as the Secretary may
