AN ACT

- To require the Secretary of Veterans Affairs to establish a national cemetery for veterans in various locations in the United States, and for other purposes.

3 (c) REPORT.—As soon as practicable after the date 4 of the enactment of this Act, the Secretary shall submit 5 to Congress a report on the establishment of the national 6 cemeteries under subsection (a). The report shall set forth 7 a schedule for the establishment of each such cemetery 8 and an estimate of the costs associated with the establish-9 ment of each such cemetery.

10 SEC. 2. USE OF FLAT GRAVE MARKERS.

11 (a) Authority To Use Flat Grave Markers at 12 SANTA FE NATIONAL CEMETERY.—Notwithstanding section 2404(c)(2) of title 38, United States Code, the Sec-13 retary of Veterans Affairs may provide for flat grave 14 15 markers at the Santa Fe National Cemetery, New Mexico. 16 (b) Report Comparing Use of Flat Grave MARKERS AND UPRIGHT GRAVE MARKERS.—(1) Not 17 later than 90 days after the date of the enactment of this 18 Act, the Secretary of Veterans Affairs shall submit to the 19 20 Committees on Veterans' Affairs of the Senate and the 21 House of Representatives a report assessing the advan-22 tages and disadvantages of the use by the National Ceme-23 tery Administration of flat grave markers and upright 24 grave markers.

(2) The report under paragraph (1) shall set forth
the advantages and disadvantages of the use of each type
of grave marker referred to in that paragraph, and shall
include criteria to be utilizing in determining whether to
prefer the use of one such type of grave marker over the
other.
