A BILL

To amend title 10, United States Code, to authorize payment of special compensation to certain severely disabled uniformed services retirees.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SPECIAL COMPENSATION FOR SEVERELY DIS-
- 4 ABLED UNIFORMED SERVICES RETIREES.
- 5 (a) AUTHORITY.—(1) Chapter 71 of title 10, United
- 6 States Code, is amended by adding at the end the fol-
- 7 lowing new section:

1	"§ 1413. Special compensation for certain severely
2	disabled uniformed services retirees
3	"(a) AUTHORITY.—The Secretary concerned shall
4	subject to the availability of appropriations for such pur-
5	pose, pay to each eligible disabled uniformed services re-
6	tiree a monthly amount determined under subsection (b)
7	"(b) Amount.—The amount to be paid to an eligible
8	disabled uniformed services retiree in accordance with sub-
9	section (a) is the following:
10	"(1) For any month for which the retiree has
11	a qualifying service-connected disability rated as
12	total, \$300.
13	"(2) For any month for which the retiree has
14	a qualifying service-connected disability rated as 90
15	percent, \$200.
16	"(3) For any month for which the retiree has
17	a qualifying service-connected disability rated as 80
18	percent or 70 percent, \$100.
19	"(c) Eligible Members.—An eligible disabled uni-
20	formed services retiree referred to in subsection (a) is a
21	member of the uniformed services in a retired status
22	(other than a member who is retired under chapter 61
23	of this title) who—
24	"(1) completed at least 20 years of service in
25	the uniformed services that are creditable for our

1	poses of computing the amount of retired pay to
2	which the member is entitled; and
3	"(2) has a qualifying service-connected dis-
4	ability.
5	"(d) Qualifying Service-Connected Disability
6	DEFINED.—In this section, the term 'qualifying service-
7	connected disability means a service-connected disability
8	that—
9	"(1) was incurred or aggravated in the per-
10	formance of duty as a member of a uniformed serv-
11	ice, as determined by the Secretary concerned; and
12	"(2) is rated as not less than 70 percent
13	disabling—
14	"(A) by the Secretary concerned as of the
15	date on which the member is retired from the
16	uniformed services; or
17	"(B) by the Secretary of Veterans Affairs
18	within four years following the date on which
19	the member is retired from the uniformed serv-
20	ices.
21	"(e) Status of Payments.—Payments under this
22	section are not retired pay.
23	"(f) Source of Funds.—Payments under this sec-
24	tion for any fiscal year shall be paid out of funds appro-

- priated for pay and allowances payable by the Secretary 2 concerned for that fiscal year. 3 "(g) OTHER DEFINITIONS.—In this section: "(1) The term 'service-connected' has the 4 5 meaning give that term in section 101 of title 38. 6 The term 'disability rated as total' 7 means— "(A) a disability that is rated as total 8 9 under the standard schedule of rating disabilities in use by the Department of Veterans Af-10 11 fairs; or 12 "(B) a disability for which the scheduled 13 rating is less than total but for which a rating 14 of total is assigned by reason of inability of the 15 disabled person concerned to secure or follow a 16 substantially gainful occupation as a result of 17 service-connected disabilities. 18 "(3) The term 'retired pay' includes retainer 19 pay, emergency officers' retirement pay, and naval 20 pension.". 21 (2) The table of sections at the beginning of such chapter is amended by adding at the end the following 23 new item:
 - "1413. Special compensation for certain severely disabled uniformed services retirees.".

- 1 (b) Effective Date.—Section 1413 of title 10,
- 2 United States Code, as added by subsection (a), shall take
- 3 effect on October 1, 1999, and shall apply to months that
- 4 begin on or after that date. No benefit may be paid to
- 5 any person by reason of that section for any period before

6 that date.
