1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Biennial Budgeting
 5 and Appropriations Act”.

6 **SEC. 2. REVISION OF TIMETABLE.**

7 Section 300 of the Congressional Budget Act of 1974
 8 (2 U.S.C. 631) is amended to read as follows:

1 **SEC. 3. AMENDMENTS TO THE CONGRESSIONAL BUDGET**
 2 **AND IMPOUNDMENT CONTROL ACT OF 1974.**

3 (a) **DECLARATION OF PURPOSE.**—Section 2(2) of the
 4 Congressional Budget and Impoundment Control Act of
 5 1974 (2 U.S.C. 621(2)) is amended by striking “each
 6 year” and inserting “biennially”.

7 (b) **DEFINITIONS.**—

8 (1) **BUDGET RESOLUTION.**—Section 3(4) of
 9 such Act (2 U.S.C. 622(4)) is amended by striking
 10 “fiscal year” each place it appears and inserting “bi-
 11 ennium”.

12 (2) **BIENNIUM.**—Section 3 of such Act (2
 13 U.S.C. 622) is further amended by adding at the
 14 end the following new paragraph:

15 “(11) The term ‘biennium’ means the period of
 16 2 consecutive fiscal years beginning on October 1 of
 17 any odd-numbered year.”.

3 it appears and inserting “the biennium be-
4 ginning on October 1 of such year”; and

5 (iii) striking “the fiscal year beginning
6 on October 1 of such year” the second
7 place it appears and inserting “each fiscal
8 year in such period”;

9 (B) in paragraph (6), by striking “for the
10 fiscal year” and inserting “for each fiscal year
11 in the biennium”; and

12 (C) in paragraph (7), by striking “for the
13 first fiscal year” and inserting “for each fiscal
14 year in the biennium”.

15 (2) *ADDITIONAL MATTERS.*—Section 301(b)(3)
16 of such Act (2 U.S.C. 632(b)) is amended by strik-
17 ing “for such fiscal year” and inserting “for either
18 fiscal year in such biennium”.

19 (3) *VIEWS OF OTHER COMMITTEES.*—Section

22 RESOLUTIONS.—Section 305(a)(3) of such Act (2 U.S.C.
23 636(b)(3)) is amended by striking “fiscal year” and in-
24 serting “biennium”.

21 Subparagraphs (A), (B), and (C) of section 202(b)(2)
22 of House Concurrent Resolution 67 (104th Congress) are

2 by the most recently adopted concurrent resolu-
3 tion on the budget.

9 most recently adopted concurrent resolution on
10 the budget.”.

22 graph (1) in section 1105(a) of title 31, United
23 States Code, is amended to read as follows:

24 “(a) On or before the first Monday in February of
25 each odd-numbered year (or, if applicable, as provided by

1 section 300(b) of the Congressional Budget Act of 1974),
2 beginning with the One Hundred Seventh Congress, the
3 President shall transmit to the Congress, the budget for
4 the biennium beginning on October 1 of such calendar
5 year. The budget transmitted under this subsection shall
6 include a budget message and summary and supporting
7 information. The President shall include in each budget
8 the following:”.

9 (2) EXPENDITURES.—Section 1105(a)(5) of
10 title 31, United States Code, is amended by striking
11 “the fiscal year for which the budget is submitted
12 and the 4 fiscal years after that year” and inserting
13 “each fiscal year in the biennium for which the

16 United States Code, is amended by striking “the fis-
17 cal year for which the budget is submitted and the
18 4 fiscal years after that year” and inserting “each
19 fiscal year in the biennium for which the budget is
20 submitted and in the succeeding 4 years”.

21 (4) BALANCE STATEMENTS.—Section
22 1105(a)(9)(C) of title 31, United States Code, is
23 amended by striking “the fiscal year” and inserting
24 “each fiscal year in the biennium”.

1 (5) FUNCTIONS AND ACTIVITIES.—Section
2 1105(a)(12) of title 31, United States Code, is
3 amended in subparagraph (A), by striking “the fis-
4 cal year” and inserting “each fiscal year in the bien-
5 nium”.

6 (6) ALLOWANCES.—Section 1105(a)(13) of title
7 31, United States Code, is amended by striking “the
8 fiscal year” and inserting “each fiscal year in the bi-
9 ennium”.

10 (7) ALLOWANCES FOR UNCONTROLLED EX-
11 PENDITURES.—Section 1105(a)(14) of title 31,

8 inserting “each of the 2 most recently com-
9 pleted fiscal years”;

11 ing “with respect to those fiscal years”; and

12 (C) by striking “in that year” and insert-
13 ing “in those fiscal years”.

14 (11) PRIOR YEAR RECEIPTS.—Section
15 1105(a)(19) of title 31, United States Code, is
16 amended—

17 (A) by striking “the prior fiscal year” and
18 inserting “each of the 2 most recently com-
19 pleted fiscal years”;

20 (B) by striking “for that year” and insert-
21 ing “with respect to those fiscal years”; and

22 (C) by striking “in that year” each place
23 it appears and inserting “in those fiscal years”.

24 (c) ESTIMATED EXPENDITURES OF LEGISLATIVE
25 AND JUDICIAL BRANCHES.—Section 1105(b) of title 31,

1 United States Code, is amended by striking “each year”
2 and inserting “each even-numbered year”.

3 (d) ~~RECOMMENDATIONS TO MEET ESTIMATED DE-~~
4 ~~FICIENCIES.~~—Section 1105(e) of title 31, United States
5 Code, is amended—

6 (1) by striking “the fiscal year for” the first
7 place it appears and inserting “each fiscal year in
8 the biennium for”;

10 place it appears and inserting “each fiscal year of
11 the biennium, as the case may be,”; and

12 (3) by striking “that year” and inserting “for
13 each year of the biennium”.

5 ing “biennium”;

11 fiscal years following the biennium”; and

14 sion for each odd-numbered year (or, if applicable,
15 as provided by section 300(b) of the Congressional

17 (h) YEAR-AHEAD REQUESTS FOR AUTHORIZING

1 **SEC. 6. TWO-YEAR APPROPRIATIONS; TITLE AND STYLE OF**
 2 **APPROPRIATIONS ACTS.**

3 Section 105 of title 1, United States Code, is amend-
 4 ed to read as follows:

5 **“§ 105. Title and style of appropriations Acts**

6 “(a) The style and title of all Acts making appropria-
 7 tions for the support of the Government shall be as fol-
 8 lows: ‘An Act making appropriations (here insert the ob-
 9 ject) for each fiscal year in the biennium of fiscal years
 10 (here insert the fiscal years of the biennium).’.

11 “(b) All Acts making regular appropriations for the
 12 support of the Government shall be enacted for a biennium
 13 and shall specify the amount of appropriations provided
 14 for each fiscal year in such period.

15 “(c) For purposes of this section, the term ‘biennium’
 16 has the same meaning as in section 3(11) of the Congres-
 17 sional Budget and Impoundment Control Act of 1974 (2
 18 U.S.C. 622(11)).”.

19 **SEC. 7. MULTIYEAR AUTHORIZATIONS.**

20 (a) **IN GENERAL.**—Title III of the Congressional
 21 Budget Act of 1974 is amended by adding at the end the
 22 following new section:

23 “**AUTHORIZATIONS OF APPROPRIATIONS**

24 “**SEC. 316. (a) POINT OF ORDER.**—It shall not be
 25 in order in the House of Representatives or the Senate
 26 to consider—

1 “(1) any bill, joint resolution, amendment, mo-
 2 tion, or conference report that authorizes appropria-
 3 tions for a period of less than 2 fiscal years, unless
 4 the program, project, or activity for which the ap-
 5 propriations are authorized will require no further
 6 appropriations and will be completed or terminated
 7 after the appropriations have been expended; and

8 “(2) in any odd-numbered year, any authoriza-
 9 tion or revenue bill or joint resolution until Congress
 10 completes action on the biennial budget resolution;
 11 all regular biennial appropriations bills, and all rec-
 12 onciliation bills.

13 “(b) APPLICABILITY.—In the Senate, subsection (a)
 14 shall not apply to—

15 “(1) any measure that is privileged for consid-
 16 eration pursuant to a rule or statute;

17 “(2) any matter considered in Executive Ses-
 18 sion; or

19 “(3) an appropriations measure or reconcili-
 20 ation bill.”.

21 (b) AMENDMENT TO TABLE OF CONTENTS.—The
 22 table of contents set forth in section 1(b) of the Congres-
 23 sional Budget and Impoundment Control Act of 1974 is
 24 amended by adding after the item relating to section 313
 25 the following new item:

“Sec. 316. Authorizations of appropriations.”.

1 **SEC. 8. GOVERNMENT PLANS ON A BIENNIAL BASIS.**

2 (a) STRATEGIC PLANS.—Section 306 of title 5,
3 United States Code, is amended—

4 (1) in subsection (a), by striking “September
5 30, 1997” and inserting “September 30, 2000”;
