## CONCURRENT RESOLUTION

To make technical corrections in the enrollment of the bill  
H.R. 434.

1       *Resolved by the Senate (the House of Representatives*  
2   *concurring)*, That, in the enrollment of the bill (H.R. 434)  
3 to authorize a new trade and investment policy for sub-  
4 Sahara Africa, the Clerk of the House of Representatives  
5 shall make the following corrections:

6       (1) In section 112(b)(1), insert “(including fabrics  
7 not formed from yarns, if such fabrics are classifiable  
8 under heading 5602 or 5603 of the Harmonized Tariff  
9 Schedule of the United States and are wholly formed and  
10 cut in the United States)” after “yarns wholly formed in  
11 the United States,”.

1       (2) In section 112(b)(2), insert “(including fabrics  
2 not formed from yarns, if such fabrics are classifiable  
3 under heading 5602 or 5603 of the Harmonized Tariff  
4 Schedule of the United States and are wholly formed in  
5 the United States)” after “yarns wholly formed in the  
6 United States”.

7       (3) In section 112(b)(3), strike “countries, subject”  
8 and insert “countries (including fabrics not formed from  
9 yarns, if such fabrics are classifiable under heading 5602  
10 or 5603 of the Harmonized Tariff Schedule of the United  
11 States and are wholly formed and cut in 1 or more bene-  
12 ficiary sub-Saharan African countries), subject”.

13       (4) In section 112(b)(5)(A), insert “apparel articles  
14 of” after “to the extent that”.

15       (5) In section 213(b)(2)(A) of the Caribbean Basin  
16 Economic Recovery Act, as contained in section 211(a) of  
17 the bill—

18               (A) in clause (i), strike “in a CBTPA bene-  
19 ficiary country” and insert “in 1 or more CBTPA  
20 beneficiary countries”; and

21               (B) in clause (ii)—

22                       (i) strike “cut in a CBTPA beneficiary  
23 country” and insert “cut in 1 or more CBTPA  
24 beneficiary countries”; and

1 (ii) strike “assembled in such country” and  
2 insert “assembled in 1 or more such countries”.

3 (6) In section 213(b)(2)(A)(i) of the Caribbean Basin  
4 Economic Recovery Act, as contained in section 211(a) of  
5 the bill, insert “(including fabrics not formed from yarns,  
6 if such fabrics are classifiable under heading 5602 or 5603  
7 of the HTS and are wholly formed and cut in the United  
8 States)” after “yarns wholly formed in the United  
9 States,”.

10 (7) In section 213(b)(2)(A)(ii) of the Caribbean  
11 Basin Economic Recovery Act, as contained in section  
12 211(a) of the bill, insert “(including fabrics not formed  
13 from yarns, if such fabrics are classifiable under heading  
14 5602 or 5603 of the HTS and are wholly formed in the  
15 United States)” after “yarns wholly formed in the United  
16 States”.

17 (8) In section 213(b)(2)(A)(iii)(I) of the Caribbean  
18 Basin Economic Recovery Act, as contained in section  
19 211(a) of the bill, strike “United States, in an amount”  
20 and insert “United States (including fabrics not formed  
21 from yarns, if such fabrics are classifiable under heading  
22 5602 or 5603 of the HTS and are formed in 1 or more  
23 CBTPA beneficiary countries), in an amount”.

1       (9) In clause (v) of section 213(b)(2)(A) of the Carib-  
 2 bean Basin Economic Recovery Act, as contained in sec-  
 3 tion 211(a) of the bill—

4           (A) strike “fibers, fabric, or yarn” each place it  
 5 appears in the heading and the text and insert “fab-  
 6 rics or yarn”;

7           (B) strike “fibers, fabric, and yarn” and insert  
 8 “fabrics and yarn”; and

9           (C) insert “apparel articles of” after “to the ex-  
 10 tent that”.

11       (10) In section 213(b)(2)(A)(vii)(IV) of the Carib-  
 12 bean Basin Economic Recovery Act, as contained in sec-  
 13 tion 211(a) of the bill, strike “entered” and insert “classi-  
 14 fiable”.

15       (11) In section 213(b)(2)(A) of the Caribbean Basin  
 16 Economic Recovery Act, as contained in section 211(a) of  
 17 the bill, strike “(vii) TEXTILE LUGGAGE.—” and insert  
 18 “(viii) TEXTILE LUGGAGE.—”.

19       (12) Strike section 412(a)(2) and insert the fol-  
 20 lowing:

21           (2) in the flush paragraph at the end, by strik-  
 22 ing “and (G)” and inserting “(G), and (H) (to the  
 23 extent described in section 507(6)(D))”.

24       (13) In the article description for subheading  
 25 9902.51.13 of the Harmonized Tariff Schedule of the

1 United States, as added by section 502(a) of the bill,  
2 strike “of 64’s and linen worsted wool count wool yarn”.

3 (14) In section 505(d), insert “to the United States  
4 Customs Service” after “appropriate claim”.
