## CONCURRENT RESOLUTION

1       *Resolved by the Senate (the House of Representatives*  
2       *concurring),*

3       **SECTION 1. DEFINITIONS.**

4       In this Resolution:

5               (1) **EVENT.**—The term “event” means the dedi-  
6       cation of the National Japanese-American Memorial  
7       to Patriotism .

8               (2) **SPONSOR.**—The term “sponsor” means the  
9       National Japanese-American Memorial Foundation.

10       **SEC. 2. AUTHORIZATION OF EVENT TO CELEBRATE THE**  
11                       **DEDICATION OF THE NATIONAL JAPANESE-**  
12                       **AMERICAN MEMORIAL.**

13       The National Japanese-American Memorial Founda-  
14       tion may sponsor the dedication of the National Japanese-

1 American Memorial to Patriotism on the Capitol grounds  
2 on November 9, 2000, or on such other date as the Speak-  
3 er of the House of Representatives and the Committee on  
4 Rules and Administration of the Senate may jointly des-  
5 ignate.

6 **SEC. 3. TERMS AND CONDITIONS.**

7 (a) IN GENERAL.—The event shall be open to the  
8 public, free of admission charge, and arranged so as not  
9 to interfere with the needs of Congress, under conditions  
10 to be prescribed by the Architect of the Capitol and the  
11 Capitol Police Board.

12 (b) EXPENSES AND LIABILITIES.—The sponsor shall  
13 assume full responsibility for all expenses and liabilities  
14 incident to all activities associated with the event.

15 **SEC. 4. STRUCTURES AND EQUIPMENT.**

16 (a) STRUCTURES AND EQUIPMENT.—

17 (1) IN GENERAL.—Subject to the approval of  
18 the Architect of the Capitol, beginning on November  
19 8, 2000, the sponsor may erect or place and keep on  
20 the Capitol grounds, until not later than 8:00 p.m.  
21 on Saturday, November 11, 2000, such stage, sound  
22 amplification devices, and other related structures  
23 and equipment as are required for the event.

24 (b) ADDITIONAL ARRANGEMENTS.—The Architect of  
25 the Capitol and the Capitol Police Board may make any

1 such additional arrangements as are appropriate to carry  
2 out the event.

3 **SEC. 5. ENFORCEMENT OF RESTRICTIONS.**

4       The Capitol Police Board shall provide for enforce-  
5 ment of the restrictions contained in section 4 of the Act  
6 of July 31, 1946 (40 U.S.C. 193d; 60 Stat. 718), con-  
7 cerning sales, advertisements, displays, and solicitations  
8 on the Capitol grounds, as well as other restrictions appli-  
9 cable to the Capitol grounds, with respect to the event.
