## RESOLUTION

Designating December 10, 2000, as “National Children’s Memorial Day”.

Whereas approximately 80,000 infants, children, teenagers, and young adults of families living throughout the United States die each year from myriad causes;

Whereas the death of an infant, child, teenager, or young adult of a family is considered to be 1 of the greatest

tragedies that a parent or family will ever endure during a lifetime; and

Whereas a supportive environment and empathy and understanding are considered critical factors in the healing process of a family that is coping with and recovering from the loss of a loved one: Now, therefore, be it

2       **SECTION 1. DESIGNATION OF NATIONAL CHILDREN’S ME-**  
 3                                   **MORIAL DAY.**

4       The Senate—

5               (1) designates December 10, 2000, as “Na-  
 6       tional Children’s Memorial Day”; and

7               (2) requests that the President issue a procla-  
 8       mation calling upon the people of the United States  
 9       to observe the day with appropriate ceremonies and  
 10      activities in remembrance of the many infants, chil-  
 11      dren, teenagers, and young adults of families in the  
 12      United States who have died.
