CONCURRENT RESOLUTION

Authorizing printing of the book entitled “Asian and Pacific Islander Americans in Congress”.

1 *Resolved by the House of Representatives (the Senate*
2 *concurring),*

3 **SECTION 1. ASIAN AND PACIFIC ISLANDER AMERICANS IN**
4 **CONGRESS.**

5 (a) IN GENERAL.—The book entitled “Asian and Pa-
6 cific Islander Americans in Congress”, prepared by the Li-
7 brary of Congress under the direction of the Joint Com-
8 mittee on Printing, shall be printed as a House document.

1 (b) SPECIFICATIONS.—The House document de-
2 scribed in subsection (a) shall include illustrations and
3 shall be in the style, form, manner, and binding as di-
4 rected by the Joint Committee on Printing.

5 (c) NUMBER OF COPIES.—In addition to the usual
6 number of copies, there shall be printed the lesser of—

7 (1) 30,700 copies of the document described in
8 subsection (a), of which—

9 (A) 25,000 shall be for the use of the
10 Committee on House Administration of the
11 House of Representatives; and

12 (B) 5,700 shall be for the use of the Com-
13 mittee on Rules and Administration of the Sen-
14 ate; or

15 (2) such number of copies of the document de-
16 scribed in subsection (a) as does not exceed a total
17 production and printing cost of \$220,000, which
18 copies shall be for the use of the Committee on
19 House Administration of the House of Representa-
20 tives and the Committee on Rules and Administra-
21 tion of the Senate in the same proportions as de-
22 scribed in paragraph (1).
