CONCURRENT RESOLUTION

Directing the Architect of the Capitol to enter into a contract for the design and construction of a monument to commemorate the contributions of minority women to women's suffrage and to the participation of women in public life, and for other purposes.

1 *Resolved by the House of Representatives (the Senate*
2 *concurring),*

3 **SECTION 1. CONSTRUCTION OF MONUMENT COMMEMO-**
4 **RATING CONTRIBUTIONS OF MINORITY**
5 **WOMEN TO WOMEN'S SUFFRAGE.**

6 (a) IN GENERAL.—Not later than 1 year after the
7 date of the adoption of this concurrent resolution, the Ar-
8 chitect of the Capitol shall enter into a contract for the
9 design and construction of a monument to commemorate
10 the contributions of minority women to women's suffrage
11 and to the participation of women in public life in the
12 United States.

13 (b) WOMEN DEPICTED ON MONUMENT.—The monu-
14 ment constructed pursuant to the contract entered into
15 under subsection (a) shall include depictions of an appro-
16 priate representative of each of the following, as deter-
17 mined by the recommendations provided by the advisory
18 committee under section 2:

19 (1) African American women.

20 (2) Hispanic American women.

1 (3) Asian Pacific American women.

2 (4) Jewish American women.

3 (5) Native American women.

4 (c) DEADLINE FOR COMPLETION.—The contract en-
5 tered into under subsection (a) shall include a requirement
6 that the monument designed and constructed under the
7 contract be completed and delivered to the Architect of
8 the Capitol not later than 18 months after the date on
9 which the Architect enters into the contract.

10 (d) PLACEMENT IN ROTUNDA OF THE CAPITOL.—
11 Upon delivery of the monument constructed pursuant to
12 the contract entered into under subsection (a), the Archi-
13 tect of the Capitol shall arrange for the monument to be
14 placed in permanent display in the rotunda of the Capitol.

15 **SEC. 2. USE OF ADVISORY COMMITTEE FOR MAKING REC-**
16 **COMMENDATIONS ON WOMEN TO BE DE-**
17 **PICTED ON MONUMENT.**

18 (a) IN GENERAL.—The individuals to be depicted on
19 the monument designed and constructed under this con-
20 current resolution shall be those individuals recommended
21 by an advisory committee consisting of—

22 (1) 1 member appointed by the Speaker of the
23 House of Representatives;

24 (2) 1 member appointed by the minority leader
25 of the House of Representatives; and

1 (3) 1 member appointed by the President Pro
2 Tempore of the Senate.

3 (b) DEADLINE FOR APPOINTMENT.—Members of the
4 advisory committee shall be appointed not later than 30
5 days after the adoption of this concurrent resolution.

6 (c) NO COMPENSATION FOR SERVICE.—Members of
7 the advisory committee shall serve without pay.

8 (d) SOLICITATION OF NOMINEES FROM PUBLIC.—
9 The members of the advisory committee shall solicit from
10 the general public nominees for depiction on the monu-
11 ment designed and constructed under this concurrent res-
12 olution.

13 (e) DEADLINE FOR SUBMISSION OF RECOMMENDA-
14 TIONS.—Not later than 90 days after the date of the adop-
15 tion of this concurrent resolution, the advisory committee
16 shall submit to the Architect of the Capitol the names of
17 the individuals to be depicted on the monument designed
18 and constructed under this concurrent resolution.

19 **SEC. 3. AUTHORIZATION OF APPROPRIATIONS.**

20 There are authorized to be appropriated such sums
21 as may be necessary to carry out this concurrent resolu-
22 tion (including sums necessary for the advisory committee
23 to carry out its duties under section 2), to remain available
24 until expended.
