 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,

1 SECTION 1. SHORT TITLE.

- This Act may be cited as the "Maritime Policy Im-
- 3 provement Act of 2001".

6 SEC. 3. VESSEL COASTAL VENTURE.

- 7 Section 1120(g) of the Coast Guard Authorization
- 8 Act of 1996 (Public Law 104–324; 110 Stat. 3978) is
- 9 amended by inserting "COASTAL VENTURE (United
- 10 States official number 971086)," after "vessels".

11 SEC. 4. EXPANSION OF AMERICAN MERCHANT MARINE ME-

- 12 MORIAL WALL OF HONOR.
- 13 (a) FINDINGS.—The Congress finds that—
- 14 (1) the United States Merchant Marine has
- served the people of the United States in all wars
- 16 since 1775;
- 17 (2) the United States Merchant Marine served
- as the Nation's first navy and defeated the British
- 19 Navy to help gain the Nation's independence;

- 1 (3) the United States Merchant Marine kept 2 the lifeline of freedom open to the allies of the 3 United States during the Second World War, mak-4 ing one of the most significant contributions made 5 by any nation to the victory of the allies in that war;
 - (4) President Franklin D. Roosevelt and many military leaders praised the role of the United States Merchant Marine as the "Fourth Arm of Defense" during the Second World War;
 - (5) more than 250,000 men and women served in the United States Merchant Marine during the Second World War;
 - (6) during the Second World War, members of the United States Merchant Marine faced dangers from the elements and from submarines, mines, armed raiders, destroyers, aircraft, and "kamikaze" pilots;
 - (7) during the Second World War, at least 6,830 members of the United States Merchant Marine were killed at sea;
 - (8) during the Second World War, 11,000 members of the United States Merchant Marine were wounded, at least 1,100 of whom later died from their wounds;

1	(9) during the Second World War, 604 mem-
2	bers of the United States Merchant Marine were
3	taken prisoner;
4	(10) 1 in 32 members of the United States
5	Merchant Marine serving in the Second World War
6	died in the line of duty, suffering a higher percent-
7	age of war-related deaths than any of the other
8	armed services of the United States; and
9	(11) the United States Merchant Marine con-
10	tinues to serve the United States, promoting free-
11	dom and meeting the high ideals of its former mem-
12	bers.
13	(b) Grants To Construct Addition to Amer-
14	ICAN MERCHANT MARINE MEMORIAL WALL OF
15	Honor.—
16	(1) In General.—The Secretary of Transpor-
17	tation may make grants to the American Merchant
18	Marine Veterans Memorial Committee, Inc., to con-
19	struct an addition to the American Merchant Marine
20	Memorial Wall of Honor located at the Los Angeles
21	Maritime Museum in San Pedro, California.
22	(2) FEDERAL SHARE.—The Federal share of
23	the cost of activities carried out with a grant made

under this section shall be 50 percent.

1	(3) Authorization of appropriations.—
2	There is authorized to be appropriated to carry out
3	this section \$500,000 for fiscal year 2002.
4	SEC. 5. DISCHARGE OF AGRICULTURAL CARGO RESIDUE.
5	Notwithstanding any other provision of law, the dis-
6	charge from a vessel of any agricultural cargo residue ma-
7	terial in the form of hold washings shall be governed exclu-
8	sively by the provisions of the Act to Prevent Pollution
9	from Ships (33 U.S.C. 1901 et seq.) that implement
10	Annex V to the International Convention for the Preven-
11	tion of Pollution from Ships.
12	SEC. 6. RECORDING AND DISCHARGING MARITIME LIENS.
13	(a) Liens on Any Documented Vessel.—
14	(1) In general.—Section 31343 of title 46,
15	United States Code, is amended as follows:
16	(A) By amending the section heading to
17	read as follows:
18	"§ 31343. Recording and discharging liens".
19	(B) In subsection (a) by striking "covered
20	by a preferred mortgage filed or recorded under
21	this chapter" and inserting "documented, or for
22	which an application for documentation has
23	been filed, under chapter 121".
24	(C) By amending subsection (b) to read as
25	follows

1	"(b)(1) The Secretary shall record a notice complying
2	with subsection (a) of this section if, when the notice is
3	presented to the Secretary for recording, the person hav-
4	ing the claim files with the notice a declaration stating
5	the following:
6	"(A) The information in the notice is true and
7	correct to the best of the knowledge, information,
8	and belief of the individual who signed it.
9	"(B) A copy of the notice, as presented for rec-
10	ordation, has been sent to each of the following:
11	"(i) The owner of the vessel.
12	"(ii) Each person that recorded under sec-
13	tion 31343(a) of this title an unexpired notice
14	of a claim of an undischarged lien on the vessel.
15	"(iii) The mortgagee of each mortgage
16	filed or recorded under section 31321 of this
17	title that is an undischarged mortgage on the
18	vessel.
19	"(2) A declaration under this subsection filed by a
20	person that is not an individual must be signed by the
21	president, member, partner, trustee, or other official au-
22	thorized to execute the declaration on behalf of the per-
23	son.".
24	(D) By amending subsection (c) to read as
25	follows:

- 1 "(c)(1) On full and final discharge of the indebted-
- 2 ness that is the basis for a notice of claim of lien recorded
- 3 under subsection (b) of this section, the person having the
- 4 claim shall provide the Secretary with an acknowledged
- 5 certificate of discharge of the indebtedness. The Secretary
- 6 shall record the certificate.
- 7 "(2) The district courts of the United States shall
- 8 have jurisdiction over a civil action to declare that a vessel
- 9 is not subject to a lien claimed under subsection (b) of
- 10 this section, or that the vessel is not subject to the notice
- 11 of claim of lien, or both, regardless of the amount in con-
- 12 troversy or the citizenship of the parties. Venue in such
- 13 an action shall be in the district where the vessel is found,
- 14 or where the claimant resides, or where the notice of claim
- 15 of lien is recorded. The court may award costs and attor-
- 16 neys fees to the prevailing party, unless the court finds
- 17 that the position of the other party was substantially justi-
- 18 fied or other circumstances make an award of costs and
- 19 attorneys fees unjust.".
- 20 (E) By adding at the end the following:
- 21 "(e) A notice of claim of lien recorded under sub-
- 22 section (b) of this section shall expire 3 years after the
- 23 date specified in the notice under subsection (b) of this
- 24 section.

- 1 "(f) This section does not alter in any respect the
- 2 law pertaining to the establishment of a maritime lien, the
- 3 remedy provided by such a lien, or the defenses thereto,
- 4 including any defense under the doctrine of laches.".
- 5 (2) CLERICAL AMENDMENT.—The table of sec-
- 6 tions at the beginning of chapter 313 of title 46,
- 7 United States Code, is amended by striking the item
- 8 relating to section 31343 and inserting the fol-
- 9 lowing:

"31343. Recording and discharging liens.".

- 10 (b) Notice Requirements.—Section 31325 of title
- 11 46, United States Code, is amended as follows:
- 12 (1) In subsection (d)(1)(B) by striking "a no-
- tice of a claim" and inserting "an unexpired notice
- of a claim".
- 15 (2) In subsection (f)(1) by striking "a notice of
- a claim" and inserting "an unexpired notice of a
- 17 claim".
- 18 (c) Approval of Surrender of Documenta-
- 19 TION.—Section 12111 of title 46, United States Code, is
- 20 amended by adding at the end the following:
- 21 "(d)(1) The Secretary shall not refuse to approve the
- 22 surrender of the certificate of documentation for a vessel
- 23 solely on the basis that a notice of a claim of a lien on
- 24 the vessel has been recorded under section 31343(a) of
- 25 this title.

- 1 "(2) The Secretary may condition approval of the
- 2 surrender of the certificate of documentation for a vessel
- 3 over 1,000 gross tons.".
- 4 (d) TECHNICAL CORRECTION.—Section 9(c) of the
- 5 Shipping Act, 1916 (46 U.S.C. App. 808(c)) is amended
- 6 in the matter preceding paragraph (1) by striking "Ex-
- 7 cept" and all that follows "12106(e) of title 46," and in-
- 8 serting "Except as provided in section 611 of the Mer-
- 9 chant Marine Act, 1936 (46 App. U.S.C. 1181) and in
- 10 sections 12106(e) and 31322(a)(1)(D) of title 46,".
- 11 (e) Effective Date.—This section shall take effect
- 12 July 1, 2002.
- 13 SEC. 7. TONNAGE OF R/V DAVIDSON.
- 14 (a) In General.—The Secretary of Transportation
- 15 shall prescribe a tonnage measurement as a small pas-
- 16 senger vessel as defined in section 2101 of title 46, United
- 17 States Code, for the vessel R/V DAVIDSON (United
- 18 States official number D1066485) for purposes of apply-
- 19 ing the optional regulatory measurement under section
- 20 14305 of that title.
- 21 (b) APPLICATION.—Subsection (a) shall apply only
- 22 when the vessel is operating in compliance with the re-
- 23 quirements of section 3301(8) of title 46, United States
- 24 Code.

EXEMPTION FOR VICTORY SHIPS. 4 Section 3302(l)(1) of title 46, United States Code, 5 is amended by adding at the end the following: 6 "(D) The steamship SS Red Oak Victory 7 (United States official number 249410), owned by the Richmond Museum Association, located in Rich-8 9 mond, California. 10 "(E) The SS American Victory (United States official number 248005), owned by Victory Ship, 11 12 Inc., of Tampa, Florida.". 13 SEC. 10. CERTIFICATE OF DOCUMENTATION FOR 3 BARGES. 14 (a) DOCUMENTATION CERTIFICATE.—Notwith-15 standing section 12106 of title 46, United States Code, and section 27 of the Merchant Marine Act, 1920 (46 16 17 App. U.S.C. 883), and subject to subsection (c) of this section, the Secretary of Transportation may issue a cer-18 19 tificate of documentation with an appropriate endorsement 20 for employment in the coastwise trade for each of the ves-21 sels listed in subsection (b). 22 (b) Vessels Described.—The vessels referred to in 23 subsection (a) are the following: 24 (1) The former Navy deck barge JIM, having

a length of 110 feet and a width of 34 feet.

1	(2) The former railroad car barge HUGH, hav-
2	ing a length of 185 feet and a width of 34 feet.
3	(3) The former railroad car barge TOMMY,
4	having a length of 185 feet and a width of 34 feet.
5	(c) Limitation on Operation.—A vessel issued a
6	certificate of documentation under this section may be
7	used only as a floating platform for launching fireworks,
8	including transportation of materials associated with that
9	use.
10	SEC. 11. CERTIFICATE OF DOCUMENTATION FOR THE
11	EAGLE.
12	Notwithstanding section 27 of the Merchant Marine
13	Act, 1920 (46 U.S.C. App. 883), chapter 121 of title 46,
14	United States Code, and section 1 of the Act of May 28,
15	1906 (46 U.S.C. App. 292), the Secretary of Transpor-
16	tation shall issue a certificate of documentation with ap-
17	propriate endorsement for employment in the coastwise
18	trade for the vessel EAGLE (hull number BK—1754,
19	United States official number 1091389) if the vessel is—
20	(1) owned by a State, a political subdivision of
21	a State, or a public authority chartered by a State;
22	(2) if chartered, chartered to a State, a political
23	subdivision of a State, or a public authority char-
24	tered by a State;
25	(3) operated only in conjunction with—

1	(A) scour jet operations; or
2	(B) dredging services adjacent to facilities
3	owned by the State, political subdivision, or
4	public authority; and
5	(4) externally identified clearly as a vessel of
6	that State, subdivision or authority.
7	SEC. 12. WAIVER FOR VESSELS IN NEW WORLD CHALLENGE
8	RACE.
9	Notwithstanding section 8 of the Act of June 19,
10	1886 (46 App. U.S.C. 289), beginning on April 1, 2002,
11	the 10 sailboats participating in the New World Challenge
12	Race may transport guests, who have not contributed con-
13	sideration for their passage, from and around the ports
14	of San Francisco and San Diego, California, before and
15	during stops of that race. This section shall have no force
16	or effect beginning on the earlier of—
17	(1) 60 days after the last competing sailboat
18	reaches the end of that race in San Francisco, Cali-
19	fornia; or
20	(2) December 31, 2003.
21	SEC. 13. VESSEL ASPHALT COMMANDER.
22	Notwithstanding any other law or agreement with the
23	United States Government, the vessel ASPHALT COM-
24	MANDER (United States official number 663105) may
25	be transferred to or placed under a foreign registry or sold

- 1 to a person that is not a citizen of the United States and
- 2 transferred to or placed under a foreign registry.
