## A BILL

To amend the Endangered Species Act of 1973 to improve the ability of individuals and local, State, and Federal agencies to prevent natural flood disaster.

1       *Be it enacted by the Senate and House of Representa-  
2       tives of the United States of America in Congress assembled,*

**3 SECTION 1. PURPOSE.**

4       The purpose of this Act is to assist individuals and  
5       local, State, and Federal agencies in complying with the  
6       Endangered Species Act of 1973 in reconstructing or re-  
7       pairing of flood control levee structures to address immi-

1 nent threats to public health or safety or catastrophic nat-  
2 ural events and in maintaining the structural integrity of  
3 those structures.

4 SEC. 2. AMENDMENTS TO ENDANGERED SPECIES ACT OF  
5 1973.

6 (a) ACTIONS EXEMPT FROM CONSULTATION AND  
7 CONFERENCING.—Section 7(a) of the Endangered Species  
8 Act of 1973 (16 U.S.C. 1536(a)) is amended by adding  
9 at the end the following:

10       “(5) Consultation and conferencing under paragraphs  
11 (2) and (4) is not required for any agency action that—

12        "(A) consists of reconstruction or repair of a  
13        Federal or non-Federal levee structure—

18               “(B) consists of maintaining the structural in-  
19               tegrity of a Federal or non-Federal levee structure.”.

(b) EXCLUSION FROM TAKINGS PROHIBITION.—Section 9(a) of such Act (16 U.S.C. 1538(a)) is amended by adding at the end the following:

23       “(3) For purposes of this subsection, an activity of  
24 a Federal or non-Federal person is not a taking of a spe-  
25 cies if the activity—

1           “(A) consists of reconstruction or repair of a  
2        Federal or non-Federal levee structure—  
3           “(i) to address a critical, imminent threat  
4        to public health or safety; or  
5           “(ii) to address a catastrophic natural  
6        event; or  
7           “(B) consists of maintaining the structural in-  
8        tegrity of a Federal or non-Federal levee structure.”.
